**TITLE: OFFICIAL DEPOSITORIES FOR THE BOROUGH OF PROSPECT PARK**

**WHEREAS**, NJSA 40A:5-14 provides that moneys held in any separate fund shall be treated as moneys held in trust and shall not be diverted to any other purpose; and

**WHEREAS**, NJSA 40A:5-14 mandates that the governing body of a municipal corporation shall, by resolution, passed by a majority vote of the full membership thereof, designate as a depository for its moneys a bank or trust company having its place of business in the State and organized under the laws of the United States or this State;

**NOW THEREFORE, BE IT RESOLVED**, by the Mayor and Council of the Borough of Prospect Park that Valley National Bank shall be authorized as the depository for all payroll funds of the Borough of Prospect Park and the custodian shall be the Borough Chief Financial Officer and all disbursements made by checks signed by the Mayor or Borough Chief Financial Officer/Treasurer in his absence;

**BE IT FURTHER RESOLVED**, that Valley Bank shall be depository for all the following funds of the Borough of Prospect Park and the custodian shall be the Borough Chief Financial Officer/Treasurer:

OTHER TRUST	UNEMPLOYMENT INSURANCE FUND
CAPITAL	CDBG TRUST
PUBLIC ASSISTANCE I	GRANT TRUST
CURRENT MERCHANT SERVICES	GREEN ACRES

**BE IT FURTHER RESOLVED**, that all disbursements from the above mentioned accounts be made by check signed by the following officials:

**BE IT FURTHER RESOLVED**, that in the absence of any one of the above-mentioned individuals, the signature of the current Council President, shall be authorized; and


