RESOLUTION NO. 2022-112

TITLE: RESOLUTION AWARDING THE INFORMATION TECHNOLOGY (IT) SUPPORT AND CONSULTING SERVICES CONTRACT TO QUIKTEKS IN THE AMOUNT NOT TO EXCEED \$18,000

WHEREAS, by way of Resolution 2022-89 the Borough authorized the solicitation of proposals for the provision of Information Technology Support and Consulting Services for the Borough of Prospect Park through the use of competitive contracting pursuant to *N.J.S.A. 40A:11-4.1(a), (b)(3) and (m)*;

WHEREAS, the Borough prepared and publicly advertised the issuance of a Request for Proposals for the Information Technology Support and Consulting Services Contract (“RFP”) for the Borough; and

WHEREAS, on June 23, 2022, pursuant to the RFP, the Borough received and opened five (5) proposals for the Information Technology Support and Consulting Services for the Borough of Prospect Park; and

WHEREAS, the Borough has reviewed, evaluated and scored the Proposals received and the Borough determined that the proposal submitted by Quikteks Business Technology Solutions scored the highest based upon relative experience, qualifications, and who will provide the highest quality of service at fair and competitive prices in accordance with the selection criteria set forth in the RFP, and it is recommended that the contract for Information Technology Support and Consulting Services be awarded to Quikteks Business Technology Solutions.

NOW, THEREFORE, BE IT RESOLVED by the Borough Council of the Borough of Prospect Park, County of Passaic, State of New Jersey that it hereby awards the contract for Information Technology Support and Consulting Services to Quikteks Business Technology Solutions and 373E Route 46 West, Fairfield, NJ 07004 in a total annual amount not to exceed eighteen thousand dollars (\$18,000.00) for a term of one year, with four (4) additional optional renewal terms of one (1) year each not to exceed a total of five (5) years at the Borough’s discretion and further Resolution of the Borough Council; and

BE IT FURTHER RESOLVED that the Borough Clerk shall publish a Notice in the official newspaper summarizing the within award of contract; and

BE IT FURTHER RESOLVED that the Mayor and the Borough Clerk are hereby authorized and directed to execute the contract for the same.


