**RESOLUTION NO. 2022-113**

**TITLE: RESOLUTION AUTHORIZING A SHARED SERVICES AGREEMENT FOR THE PROVISION OF HEALTH SERVICES FOR THE BOROUGH OF PROSPECT PARK WITH THE COUNTY OF PASSAIC IN THE AMOUNT NOT TO EXCEED \$5,696.50 FOR THE PERIOD OF SIX (6) MONTHS FROM JULY 1, 2022 THROUGH DECEMBER 31, 2022**

**WHEREAS**, the Borough of Prospect Park has previously contracted with the City of Paterson for the provision of certain health services of a technical and professional nature pursuant to N.J.S.A. 26:3A2-1, et seq. and N.J.S.A. 40A:65-1, et seq.; and

**WHEREAS**, the existing Shared Services Agreement between the Borough of Prospect Park and City of Paterson for the provision of health services expires on June 30, 2022; and

**WHEREAS**, the County of Passaic has submitted a proposal to the Borough of Prospect Park to provide the Borough with at the very least, the same health services as was provided by the City of Paterson for a period of six (6) months from July 1, 2022 to December 30, 2022; and

**WHEREAS**, the Borough has determined that it is interest of the residents of the Borough not to continue with the provisions of Health Services from the City of Paterson and to enter into a Shared Services Agreement with the County of Passaic for the provision of Health Services for the residents of Prospect Park for a term of six (6) months at a cost of \$5,696.50; and

**NOW THEREFORE BE IT RESOLVED** by the Council of the Borough of Prospect Park that it hereby authorizes the entry into a shared services agreement with the County of Passaic for the provision of health services commencing July 1, 2022 through December 31, 2022 for the total amount of \$5,696.50 consistent with the proposal submitted and as set forth in the Shared Services Agreement; and

**BE IT FURTHER RESOLVED** that the Mayor, Borough Administrator, and any other employee and/or official are authorized and directed to take any further action necessary to effectuate this Resolution, including but not limited to the final negotiations of the specific terms and conditions of the final form of the Shared Services Agreement; and


**BE IT FURTHER RESOLVED** by the Council that the Mayor is authorized to execute the final negotiated Shared Service Agreement by and between the Borough of Prospect Park and the County of Passaic for the provision of health services, consistent with the terms of the within Resolution and, acceptable in form by the Mayor, Borough Administrator, and legal counsel; and


**BE IT FURTHER RESOLVED** that the Borough Administrator and Deputy Administrator and any other employee and/or official are authorized and directed to forward the within Resolution to both the City of Paterson and the New Jersey Commission of Health advising same of the Borough's intention it no longer wishes to continue its shared services relation for the

provision of health services with the City of Paterson and its intention to enter into a Shared Services Agreement with the County of Passaic for said Health Services.
