WHEREAS, Resolution No. 2022-41 was adopted for the approval and authorization the participation with the State of New Jersey is a safe and secure communities program; and

WHEREAS and the Mayor and Council deem it in the best interest of the Borough of Prospect Park to add clarifying language regarding the participation of the same; and

NOW THEREFORE, BE IT RESOLVED that the Resolution No. 2022-41 be amended to read as follows:

WHEREAS, the Borough of Prospect Park wishes to apply for and accept project, and

WHEREAS, project under the Safe and Secure Communities Grant Program, and

WHEREAS, project under the Subaward number: 22-1610, and

WHEREAS, project duration November 1, 2021 thru October 31, 2022, and

WHEREAS, funding of \$15,228.00, with a match of \$55,179.61 for an approximate project total cost of \$70,407.61

WHEREAS, the Mayor and Council of Prospect Park has reviewed the application and has approved said request; and

WHEREAS, the project is a joint effort between the Department of Law and Public Safety and the Borough of Prospect Park, for the purpose described in the application.

NOW THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Borough of Prospect Park that:


1. As a matter of public policy, the Borough of Prospect Park wishes to participate to the fullest extent possible with the Department of Law and Public Safety.
2. The Attorney General of New Jersey will receive funds on behalf of the Applicant.

3. The Department of Law and Public Safety shall be responsible for the receipt of the applications for said funds.
4. The Department of Law and Public Safety shall initiate allocation to the applicant as authorized by law.


BE IT FURTHER RESOLVED that Resolution 2022-41 be and is hereby rescinded.
