**RESOLUTION #2022-59**

**TITLE:        RESOLUTION AUTHORIZING THE EXECUTION OF THE HOFSTRA  
PARK TURF SOCCER FIELD USE AGREEMENT FOR A TERM NOT TO  
EXCEED ONE YEAR WITH ISDS SPORTS**

**WHEREAS**, the Borough has completed the construction of the Hofstra Park Turf Soccer Field and wishes to provide for the use for soccer programs; and

**WHEREAS**, ISDS Sports, a youth soccer organization (“ISDS”), has requested that the Borough provide ISDS with an “Annual Permit” for various use and access to the Hofstra Park Soccer Field located in the Borough of Prospect Park; and

**WHEREAS**, the Soccer Field will require ongoing maintenance costs to be incurred by the Borough of Prospect Park; and

**WHEREAS**, the Borough believes that it would benefit the public to promote the use of the Hofstra Park Soccer Field; and


**WHEREAS**, due to the fact that ISDS seeks a bulk permit time for the use of the Hofstra Park Soccer Field, the Borough has determined to provide ISDS, a Pilot Agreement (Hofstra Park Turf Field Use Agreement), for a term not to exceed one year, with a discounted bulk rate for the Permit Fees contained in the Borough Ordinances, due to the reduction of administration related expenses the Borough will accrue in the review and issuance of permits.


**NOW, THEREFORE, BE IT RESOLVED** by the Mayor and Council of the Borough of Prospect Park, in the County of Passaic, as follows:

1. The Borough Council hereby approves and authorizes the execution of the Hofstra Park Turf Field Use Agreement with an anticipated term from March 14, 2022 to November 30, 2022, but not to exceed one year with ISDS Sports in the general form attached hereto.
2. The Mayor and Borough Clerk are hereby authorized and directed to execute the Hofstra Park Turf Field Use Agreement with ISDS Sports in the general form attached hereto and in the final form acceptable to the Borough Administrator and Mayor.
3. A copy of this Resolution and the attachment hereto shall be filed with the Clerk of the Borough of Prospect Park.
