**TITLE: RESOLUTION AUTHORIZING AND ACCEPTING PROPOSAL FROM THE BOROUGH ENGINEER AS WELL AS AUTHORIZING THE PREPARATION OF BID SPECIFICATIONS AND ADVERTISEMENT FOR THE SOLICITATION OF BIDS FOR THE FOLLOWING PROJECT: IMPROVEMENTS TO PLANTEN AVENUE FROM NORTH 6<sup>TH</sup> STREET TO NORTH 8<sup>TH</sup> STREET**

**WHEREAS**, the Borough of Prospect Park is in need of Engineering Services, in particular for the preparation of construction plans and specifications and for providing construction inspection for the above referenced project; and

**WHEREAS**, the Borough Engineer by letter dated February 16, 2022 submitted its proposal regarding same as evidenced by attachment herein made a part of the within resolution; and

**WHEREAS**, there is a Community Development Block Grant in the amount of \$85,000.00 available for this project; and

**WHEREAS**, the Mayor and Borough Council also deem it in the best interest of the Borough to authorize solicitation of bids for the contracting services to perform the improvement work, pursuant to N.J.S.A. 40A:11-4.

**NOW THEREFORE, BE IT RESOLVED**, by the Borough Council of the Borough of Prospect Park as follows:

- The Proposal of Fastech Consulting Engineers dated February 16, 2022 for engineering services in connection with the above is hereby accepted and approved.
- The compensation for said services shall not exceed \$25,000.00.
- Authorizes the solicitation of sealed bids for Improvements to Planten Avenue from North 6<sup>th</sup> Street to North 8<sup>th</sup> Street.



