RESOLUTION NO.2022-66

**TITLE: RESOLUTION APPROVING AND AUTHORIZING HANDICAP
PARKING SPACE ADDITIONS**

WHEREAS, *N.J.S.A. 39:4-197* confers upon the Borough a right to establish resident handicapped on-street parking in order to preserve and safeguard the public health, safety and welfare; and

WHEREAS, pursuant to *N.J.S.A. 39:4-197.5*, any municipality may, by ordinance, resolution or regulation, establish restricted parking spaces in front of residences, schools, hospitals and other public buildings and in shopping and business districts for use by persons who have been issued special vehicle identification cards by the Division of Motor Vehicles, provided the permitting does not interfere with the normal flow of traffic; and

WHEREAS, the Mayor and Borough Council of the Borough of Prospect Park adopted Chapter 84 of the Code of Prospect Park, Section 84-42 entitled "Restriction of Spaces" which designates restricted parking spaces for use by persons who have been issued special vehicle identification cards by the Division of Motor Vehicles; and

WHEREAS, by way of Ordinance No. 2019-2, the Mayor and Council adopted an ordinance establishing procedures for the application, review and approval of on-street handicapped parking and time limit parking in the Borough of Prospect Park which permits the issuance of handicapped parking spaces upon recommendation of a Parking Review Committee made up of the Borough Administrator, the Chief of Police, or his designee and the Director of Public Works and passage of a Resolution of the Borough Council of the Borough of Prospect Park; and

WHEREAS, the Borough received a request for a designated handicapped space to be located at 336 N-7th Street (Specific), 369 N-8th Street (Specific), and 91 N-17th Street (Specific) and

WHEREAS, the Parking Review Committee has reviewed the request for a handicapped parking space to be located at 336 N-7th Street (Specific), 369 N-8th Street (Specific), and 91 N-17th Street (Specific) and

and has reported that it recommends that it be granted; and

WHEREAS, the Mayor and Borough Council of the Borough of Prospect Park deem it in the best interest of the Borough designate a restricted parking space for use by persons who have been issued special vehicle identification cards by the Division of Motor Vehicles to be located at 336 N-7th Street (Specific), 369 N-8th Street (Specific), and 91 N-17th Street (Specific) and

NOW, THEREFORE, BE IT RESOLVED that the Mayor and Borough Council of the Borough of Prospect Park in the County of Passaic in the State of New Jersey, hereby approves

the following location to be designated as a handicap parking space for the use of persons who have been issued a windshield placard or wheelchair symbol license plate by the Division of Motor Vehicles. No other persons shall be permitted to park in the following location:



Irma Santana 91 N-17th Street	N-17 th Street beginning at a point on Northern side of N-17 th Street, 263 feet East of the corner of Brown Ave. and extending 20 East.
