TITLE: RESOLUTION AUTHORIZING THE AWARD AND EXECUTION OF A RENEWAL CONTRACT TO ONSOLVE, LLC FOR THE PROVISION OF ON-DEMAND ALERTING AND NOTIFICATION TECHNOLOGY SOFTWARE AND SUPPORT SERVICES TO THE BOROUGH OF PROSPECT PARK

WHEREAS, the Borough of Prospect Park has reviewed its technology needs as well as its current resources and personnel and has determined that they would like to continue with and renew their on-demand alerting and response software for the notification of its residents; and

WHEREAS, the Borough Administrator has solicited and reviewed the proposal from its current provider, ONSOLVE, LLC, 780 W. Granada Boulevard, Ormond Beach, FL 32174 at a cost not to exceed, \$3,510.00 per year; and

WHEREAS, the Borough of Prospect Park deems it in the best interest of the residents of the Borough of Prospect Park to re-enter into an Agreement with ONSOLVE, LLC, for the provision of on-demand alerting and notification technology software and support services for the Borough of Prospect Park;

NOW, THEREFORE, BE IT RESOLVED by the Council of the Borough of Prospect Park that it hereby awards a contract and authorizes re-entry into and an Agreement by and between ONSOLVE, LLC, 780 W. Granada Boulevard, Ormond Beach, FL 32174 and the Borough of Prospect Park for the provision of on-demand alerting and notification technology software and support services in general conformity with the terms and conditions set out in their proposal submitted to the Borough at a cost not to exceed, \$3,510.00 per year; and


