RESOLUTION NO. 2022-97

TITLE: RESOLUTION APPROVING DMR ARCHITECTS AS QUALIFIED ARCHITECT/S TO PROVIDE PROFESSIONAL ARCHITECTURAL SERVICES TO THE BOROUGH OF PROSPECT PARK

WHEREAS, the Borough of Prospect Park determined that it may be necessary for the Borough to contract for professional architectural services to assist the Borough Planner with the operations and construction projects within the Borough of Prospect Park; and

WHEREAS, said services are of the nature of a professional service pursuant to N.J.S.A.40A;11-5(1)(a)(i), and therefore, a contract for the services may be negotiated and awarded by the Borough without public advertising for bids and bidding therefore, and

WHEREAS, said services are of the type contemplated by the New Jersey Local Unit Pay-To-Play Law (N.J.S.A. 19:44A-20.4, et. Seq.), and therefore, a contract for the services may be awarded pursuant to a “fair and open” or “non-fair and open” process, both of which are defined in the law; and

WHEREAS, the Borough of Prospect Park advertised a Request for Proposals/Qualifications for professional architectural services for outside professional service firms who desire to perform work for the Borough through a “Fair and Open Process”; and

WHEREAS, pursuant to the RFP/RFQ, on May 23, 2022, the Borough opened the responses received from the professional services firms seeking to provide professional architectural services to the Borough; and

WHEREAS, the Borough has reviewed and evaluated the responses and proposals received based upon the criterial set forth in the RFP/RFQ; and

WHEREAS, the Mayor and Council deem it in the best interest of the Borough to approve DMR Architects, 777 Terrace Avenue, Suite 607, Hasbrouck Heights, New Jersey 07604 as a qualified Architectural Consulting Services Firm to render architectural services to the Borough on an “as needed” basis.


NOW THEREFORE BE IT RESOLVED by the Mayor and Council of the Borough of Prospect Park that it hereby approves DMR Architects, 777 Terrace Avenue, Suite 607,

Hasbrouck Heights, New Jersey 07604 as a qualified firm to render architectural services to the Borough of Prospect Park on an “as needed” project basis; and


BE IT FURTHER RESOLVED that the within Resolution shall not be construed as an authorization to commence or render professional architectural services on behalf of the Borough and the provision of professional services is on an “as-needed” project basis and shall be authorized and approved by further Resolution of the Mayor and Council of the Borough of Prospect Park.
