RESOLUTION NO. 2022-98

TITLE: RESOLUTION AWARDING CONTRACT TO ORLANDSCAPING LLC FOR THE HOFSTRA PARK LAWN MAINTENANCE SERVICES IN THE AMOUNT OF \$21,900.00

WHEREAS, the Borough publicly advertised for the solicitation of bids for the Hofstra Park Lawn Maintenance Services for the Borough of Prospect Park; and

WHEREAS, the Borough received, publicly opened and reviewed one bid for the Hofstra Park Lawn Maintenance Services for the Borough of Prospect Park on May 20, 2022; and

WHEREAS, the bid was submitted by Orlandscaping, 248 N. 13th Place, Prospect Park, New Jersey 07508 in the total amount of Twenty-One Thousand Nine Hundred Dollars (\$21,900.00); and

WHEREAS, the Borough has determined that Orlandscaping to be the lowest responsive and responsible bidder; and

WHEREAS, the appropriate Borough Officials have certified the sufficiency of funds for the award of contract for the Hofstra Park Lawn Maintenance Services Contract.

NOW, THEREFORE BE IT RESOLVED by the Mayor and Council of the Borough of Prospect Park, in the County of Passaic, in accordance with the provisions of the Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq.), that Orlandscaping located at 248 N. 13th Place, Prospect Park, NJ 07508 has been determined to be the lowest responsive and responsible bidder; and

BE IT FURTHER RESOLVED by the Mayor and Council that the Borough hereby awards the contract for the Hofstra Parke Lawn Maintenance Services to Orlandscaping LLC located at 248 N. 13th Place, Prospect Park, NJ 07508 in a total amount not to exceed Twenty-One Thousand Nine Hundred Dollars (\$21,900.00) without further authorization and approval by the Mayor and Council by formal resolution; and

BE IT FURTHER RESOLVED by the Council that the Mayor and Borough Clerk are hereby authorized to execute an agreement with Orlandscaping located at 248 N. 13th Place, Prospect Park, NJ 07508 in a total amount not to exceed Twenty-One Thousand Nine Hundred Dollars (\$21,900.00), in a form consistent with the bid specifications and acceptable in form to the Borough Administrator and Mayor; and

BE IT FURTHER RESOLVED by the Mayor and Council that it hereby authorizes all Borough Officials and employees, including but not limited to the Borough Administrator and the Superintendent of the Department of Public Works, to take all necessary action to implement the within Resolution and the contract awarded herein consistent with the terms of this Resolution and executed contract.
