**TITLE: RESOLUTION OF THE BOROUGH OF PROSPECT PARK AWARDED
BID & AUTHORIZING EXECUTION OF CONTRACT FOR NORTH
12TH PLACE (Planten Ave. to Struyk Ave.)**

WHEREAS, on June 30, 2021, the Borough of Prospect Park (“Borough”) held a public bid opening in connection with the North 12th Place Improvement Project; and

WHEREAS, there were nine bids submitted by 4 Clean-Up Inc., AJM, Cifelli & Son, D&L Paving Contractors, LLC., D.S. Meyer Enterprises, LLC, DLS Contracting Inc., Marini Bros. Construction Co.; Frank Macchione Paving Plus, and Zuccaro Inc.; and

WHEREAS, the Borough Engineer has analyzed the submissions of the bidders in connection with the contract for the Project and the Borough Engineer has submitted a recommendation to the Governing Body to award the Project to Marini Bros. Construction Co., Inc. in the amount of \$103,381.50; and

NOW, THEREFORE BE IT RESOLVED THAT in accordance with the provisions of the Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq.), Marini Bros. Construction Co, Inc. has been determined to be the lowest responsible and responsive bidder with a total bid of \$103,381.50; and

BE IT FURTHER RESOLVED that the Borough of Prospect Park hereby makes the following award of contract:

Marini Bros. Construction Co, Inc. is hereby awarded the contract for the Project and the Mayor and Borough Administrator are authorized and directed to enter into a contract for the Project for the North 12th Place Improvement Project with Marini Bros. Construction Co, Inc. for the total contract sum of \$103,381.50; and

BE IT FURTHER RESOLVED, that the Mayor and Borough Administrator are authorized and directed to obtain from Marini Bros. Construction Co, Inc. the proper Performance and Payment Bond and evidence of adequate insurance prior to the execution of such contract by the Borough; and

BE IT FURTHER RESOLVED that the Municipal Clerk is authorized to return the bid bonds for all unsuccessful bidders with a note of thanks for their participation; and

BE FURTHER RESOLVED that the Borough’s Legal Counsel is further authorized to prepare and transmit for signature all Owner/Contractor Agreements as applicable to this award; and


BE IT FURTHER RESOLVED that the Administrator, Municipal Clerk and any other

Borough official or employee shall take all necessary action in order to effectuate the within Resolution; and


BE IT FURTHER RESOLVED, that a copy of this Resolution shall be filed with the Clerk of the Borough of Prospect Park.
