**TITLE: RESOLUTION OF THE BOROUGH OF PROSPECT PARK AWARDING
BID & AUTHORIZING EXECUTION OF CONTRACT FOR NORTH
12TH STREET (Haledon Ave. to Dead End)**

WHEREAS, on June 30, 2021, the Borough of Prospect Park (“Borough”) held a public bid opening in connection with the North 12th Street Improvement Project; and

WHEREAS, there were eight bids submitted by 4 Clean-Up Inc., AJM, Cifelli & Son, D&L Paving Contractors, LLC., D.S. Meyer Enterprises, LLC, DLS Contracting Inc., Marini Bros. Construction Co., and Frank Macchione Paving Plus; and

WHEREAS, the Borough Engineer has analyzed the submissions of the bidders in connection with the contract for the Project and the Borough Engineer has submitted a recommendation to the Governing Body to award the Project to DLS Contracting Inc. in the amount of \$181,655.00; and

NOW, THEREFORE, BE IT RESOLVED THAT in accordance with the provisions of the Local Public Contracts Law (N.J.S.A. 40A:11-1 et seq.), DLS Contracting Inc. has been determined to be the lowest responsible and responsive bidder with a total bid of \$181,655.00.

BE IT FURTHER RESOLVED the Borough of Prospect Park hereby makes the following award of contract:

DLS Contracting Inc. is hereby awarded the contract for the Project and the Mayor and Borough Administrator are authorized and directed to enter into a contract for the Project for the North 12th Street Improvement Project with DLS Contracting Inc. for the total contract sum of \$181,655.00; and

BE IT FURTHER RESOLVED, that the Mayor and Borough Administrator are authorized and directed to obtain from DLS Contracting Inc. the proper Performance and Payment Bond and evidence of adequate insurance prior to the execution of such contract by the Borough; and

BE IT FURTHER RESOLVED that the Municipal Clerk is authorized to return the bid bonds for all unsuccessful bidders with a note of thanks for their participation; and

BE FURTHER RESOLVED that the Borough’s Legal Counsel is further authorized to prepare and transmit for signature all Owner/Contractor Agreements as applicable to this award.


BE IT FURTHER RESOLVED that the Administrator, Municipal Clerk and any other Borough official or employee shall take all necessary action in order to effectuate the within


Resolution.
