**RESOLUTION NO. 2021-125**

**TITLE: RESOLUTION APPROVING THE EXECUTION OF A SHARED SERVICES AGREEMENT BETWEEN THE BOROUGH OF PROSPECT PARK AND THE BOROUGH OF ELMWOOD PARK FOR THE PROVISION OF AND USE OF THE SNOGO SYSTEM**

**WHEREAS**, the Borough of Prospect Park is the owner of a SNOGO Snow Plow Removal System (“SNOGO”) and has operators that are experienced in its use and maintenance thereof; and

**WHEREAS**, the Borough of Elmwood Park has expressed a desire to enter into an agreement for the provision of and use of the SNOGO with a Prospect Park operator when not in use by the Borough of Prospect Park; and

**WHEREAS**, the Borough of Prospect Park is agreeable to allowing the Borough of Elmwood Park to benefit from the provision and use of the SNOGO under certain terms and conditions; and

**WHEREAS**, the Uniform Shared Services Consolidation Act, *N.J.S.A. 40A:65-1*, et seq. authorizes local units of the State to enter into a contract with any other local unit or units for the joint provision of any service which any party to the agreement is empowered to render; and

**WHEREAS**, governing bodies of both the Borough of Prospect Park and Borough of Elmwood Park (the “Parties”) now wish to memorialize their contractual agreement as a Shared Services Agreement as authorized by the Uniform Shared Services Consolidation Act, *N.J.S.A. 40A:65-1*; and

**WHEREAS**, by way of Resolution 272-21, the Borough of Elmwood Park authorized the negotiation and entry into a Shared Services Agreement with the Borough of Prospect Park for the provision of and use of the SNOGO with a Prospect Park operator when not in use by the Borough of Prospect Park;

**NOW, THEREFORE, BE IT RESOLVED** by the Council of the Borough of Prospect Park that it hereby authorizes the entry into a shared services agreement with the Borough of Elmwood Park for a term of one (1) year commencing August 1, 2022 through July 31, 2023 for the provision of and use of the SNOGO with a Prospect Park operator at a cost of three hundred dollars (\$300.00) per hour as will be set forth in the Shared Services Agreement; and

**BE IT FURTHER RESOLVED** that the Mayor, Borough Administrator, and any other employee and/or official are authorized and directed to take any further action necessary to effectuate this Resolution, including but not limited to the final negotiations of the specific terms and conditions of the final form of the Shared Services Agreement; and

**BE IT FURTHER RESOLVED** by the Council that the Mayor is authorized to execute the final negotiated Shared Service Agreement by and between the Borough of Prospect Park and the Borough of Elmwood Park, consistent with the terms of the within Resolution, acceptable in form by the Mayor, Borough Administrator, and legal counsel; and

**BE IT FURTHER RESOLVED** that the Borough Administrator and any other employee and/or official are authorized and directed to take any further action necessary to effectuate this Resolution and the implementation of the final negotiated Shared Services Agreement.


