**TITLE: RESOLUTION APPOINTING BOROUGH ATTORNEY AND AUTHORIZING A PROFESSIONAL SERVICE CONTRACT TO WEINER LAW GROUP FOR THE PROVISION OF LEGAL SERVICES TO THE BOROUGH OF PROSPECT PARK**

**WHEREAS**, the Borough of Prospect Park (the “Borough”) has determined that it is necessary to retain the services of consultants in connection with the provision of general legal services for the Borough of Prospect; and

**WHEREAS**, said services are of the nature of a professional service pursuant to N.J.S.A. 40A:11-5 (1) (a) (i), and, therefore, a contract for the services may be negotiated and awarded by the Board without public advertising for bids and bidding therefore; and

**WHEREAS**, said services are of the type contemplated by the New Jersey Local Unit Pay-To-Play law (N.J.S.A. 19:44A-20.4, et seq.) , and, therefore, a contract for the services must be awarded pursuant to a “fair and open” or “non-fair and open” process, both of which are defined in the law; and

**WHEREAS**, the Borough has determined that it is in its best interests to proceed in a fair and open manner to obtain said services through the public advertising of a Request for Proposals/Qualifications (the “RFP/RFQ”) pursuant to the Local Public Contracts Law (N.J.S.A. 40A:11-1, et. seq.); and

**WHEREAS**, the Borough of Prospect Park’s Request for Proposal/Qualifications was advertised and on or before December 10, 2020, the Borough received various proposals/qualifications from professional legal services to serve as Borough Attorney; and

**WHEREAS**, a proposal/qualifications to provide said services was submitted by the firm of Weiner Law Group; and

**WHEREAS**, the Borough is satisfied, based upon Weiner Law Group’s, proposal/qualifications, that the firm has the knowledge and experience required by the Borough; and

**WHEREAS**, the Borough has determined it to be in its best interests to enter into an Agreement for legal services to be performed by Weiner Law Group for a period of twelve (12) months at a rate of \$165.00 per hour;

**NOW, THEREFORE, BE IT RESOLVED**, by the Borough of Prospect Park as follows:

1. Denis Murphy of Weiner Law Group is hereby appointed as Borough Attorney and the Mayor is authorized to execute and deliver on behalf of the Borough a contract for the provision of legal services by and between the Borough and Weiner Law Group for a period of twelve (12) months at the billable hour rate of \$165.00; and


2. The foregoing contract is awarded in accordance with the Local Public Contracts Law and as the result of a fair and open process; and
3. The Chief Financial Officer has certified funds in Account Number 0-01-109-211 in an amount estimated not to exceed \$75,000.00; and
4. A copy of this Resolution shall be filed with Municipal Clerk of the Borough of Prospect Park and notice of the award of contract shall be published in the TapintoHawthorne, Herald News, and The Record in accordance with the requirements of the Local Public Contracts Law.


