Dear Mayor Khairullah and Members of the Council:

In accordance with your request, this letter shall serve as our proposal for the preparation of construction plans and specifications and providing construction inspection for the above-referenced project.

The New Jersey Department of Transportation State Local Aid Grant for Improvements to North 12th Street is **\$220,300.00**.

The following is an outline of the scope of the work and the estimated fee for our design and construction inspection services.

SCOPE OF WORK

The scope of the project consists of the Improvements to North 12th Street from Haledon Avenue to Dead End Approximately 1850 linear feet. The improvements include milling and paving of the roadway, reconstruction of the handicap ramp according to the ADA standards, Spot-fixing of concrete curb replacement of inlet grates with bicycle safe grate, replacement of cast iron inlet curb piece with environmental approved cast iron inlet curb piece reconstruction of existing deteriorated concrete curb and concrete sidewalk where required, installation of traffic stripes and marking, replacement of curb piece with type N – ECO and other incidental roadway items.

It is important to note that the Borough is eligible to be reimbursed for construction inspection and material testing costs up to 15% of the construction cost.

SCOPE OF SERVICES

Fastech Consulting Engineers will perform the following scope of services:

- 1. Perform a topographic survey within the project limits.
- 2. Prepare roadway construction plans in accordance with current New Jersey Department of Transportation (NJDOT) requirements.
- 3. Prepare specifications in accordance with NJDOT and the Borough of Prospect Park requirements
- 4. Prepare bid documents and advertise the project.
- 5. Review contractor's bids and make a recommendation to the Borough of Prospect Park

- 6. Coordinate and attend a pre-construction meeting with appropriate Borough officials, utility companies, and other parties affected by the construction activities.
- 7. Provide construction inspection services during the construction phase.
- 8. Review contractor's invoices for the Borough of Prospect Park
- 9. Make a final inspection of the project improvements.

FEE PROPOSAL

Fastech Consulting Engineers will perform the services outlined in the proposal for the total professional fees of \$55,075 as stipulated below:

- A. Engineering Design Services......\$22,030.00
- B. Construction Management Services......\$33,045.00

The billing will be based on our hourly rate in effect at the time the work is performed.

ITEMS NOT INCLUDED IN THE ENGINEERING FEE

The following items are not anticipated to be required and are therefore excluded:

- 1. Soil Erosion and Sediment Control Plan Certification
- 2. Permit Fees
- 3. New Jersey Department of Environmental Protection Permits
- 4. Right-of-way and/or Easement Plans or Descriptions
- 5. Structural Plans (Including Retaining Walls)

Additional work above and beyond what is outlined in the proposal will be performed as authorized by the Borough.
