TITLE: RESOLUTION AUTHORIZING THE RENEWAL OF THE INTERLOCAL SERVICES AGREEMENT WITH THE BOROUGH OF HALEDON FREE LIBRARY BOARD OF TRUSTEES FOR USE OF ITS FREE PUBLIC LIBRARY BY PROSPECT PARK RESIDENTS

WHEREAS, the Borough of Prospect Park entered into an Interlocal Services Agreement with the Haledon Free Public Library Board of Trustees in accordance with the Interlocal Services Agreement Act N.J.S.A. 40:8A-1 et seq. and N.J.S.A. 40:54-29.1, et seq.; and

WHEREAS, the Uniform Shared Consolidation Act (*N.J.S.A. 40A:65-1 et. seq.*), authorizes public entities to enter into a contract to render said services; and

WHEREAS, the Interlocal Agreement is due to expire and Haledon Free Public Library Board of Trustees has expressed an interest to renew the Interlocal Services Agreement for another year, April 21, 2021-April 21, 2022, under the same terms and conditions as the current agreement; and

WHEREAS, the Borough of Prospect Park Council has determined that the Interlocal Services Agreement benefits the residents of Prospect Park by permitting residents of the Borough of Prospect Park to use the facilities of Haledon Free Public Library; and

WHEREAS, the Borough Council of the Borough of Prospect Park deems it in the best interests of the residents of the Borough of Prospect Park to renew the Interlocal Services Agreement with Haledon Public Library under the same terms and conditions as the existing agreement for a term of one year.


NOW THEREFORE BE IT RESOLVED, by the Council of the Borough of Prospect Park that the Mayor and Municipal Clerk are hereby authorized to renew and execute an Interlocal Services Agreement with the Haledon Free Public Library Board of Trustees for the purpose of providing the aforesaid service in a form the same as or substantially similar to the existing contract.

BE IT FURTHER RESOLVED by the Council of the Borough of Prospect Park that it hereby authorizes all Borough officials shall take all necessary actions to in order to effectuate the within resolution, including but not limited to the Mayor and Clerk are hereby authorized to execute an Interlocal Services Agreement on behalf of the Borough of Prospect Park in a final form acceptable to the Mayor and Borough Administrator and

to take any further action necessary to implement and comply with the terms and conditions of the executed agreement.
