**TITLE: RESOLUTION AUTHORIZING RENEWAL OF AN INTERLOCAL SERVICES AGREEMENT WITH THE BOROUGH OF HAWTHORNE FOR USE OF LOUIS BAY 2<sup>ND</sup> PUBLIC LIBRARY BY PROSPECT PARK RESIDENTS**

**WHEREAS**, the Borough of Prospect Park entered into an Interlocal Services Agreement with the Borough of Hawthorne for the provision of public library services from the Louis Bay 2<sup>nd</sup> Public Library to residents of the Borough of Prospect Park, with the most recent term commencing July 1, 2018 and expiring June 30, 2021; and

**WHEREAS**, the Borough of Prospect Park determined the need to renew the Interlocal Services Agreement for the best interest of its residents; and

**WHEREAS**, the modified terms of the renewal agreement are incorporated in the Shared Services Agreement on file with the Borough; and

**WHEREAS**, a shared service agreement is authorized by N.J.S.A. 40A:65-1, et seq; and

**NOW, THEREFORE, BE IT RESOLVED**, by the Borough of Prospect Park that it hereby authorizes the Mayor and Borough Administrator to execute the Interlocal Services Agreement for the extension of the Interlocal Services Agreement with the Borough of Hawthorne for the provision of public library services to the residents of Prospect Park, commencing July 1, 2021 and ending June 30, 2024, upon the same terms and conditions agreed between the parties; and


**BE IT FURTHER RESOLVED**, by the Borough of Prospect Park that it hereby upholds the authorization of the Borough Administrator/Deputy Municipal Clerk of Prospect Park to charge a \$20.00 per person and \$15.00 per senior citizen administrative fee to offset the administrative costs to the Borough of Prospect Park for the provision of library services to the residents of the Borough; and


**BE IT FURTHER RESOLVED**, that a copy of this Resolution shall be delivered to the Borough of Hawthorne and filed with the Clerk of the Borough of Prospect Park.
