RESOLUTION NO. 2021-95

TITLE: RESOLUTION APPOINTING KURTIS REED A FULL-TIME POLICE OFFICER TO THE BOROUGH OF PROSPECT PARK POLICE DEPARTMENT.

WHEREAS, the Mayor and Council of the Borough of Prospect Park deem it in the best interest of the health, safety and welfare of the residents of Prospect Park to hire an additional full-time officer to the Borough of Prospect Park Police Department; and

WHEREAS, Kurtis Reed, who currently serves as a Special Class II Police Officer for the Borough of Prospect Park has expressed an interest in an appointment to the Borough of Prospect Park Police Department as a full-time police officer; and

WHEREAS, the Chief of Police has reviewed the credentials of, and the Chief personally interviewed, and conducted the necessary background investigation of Kurtis Reed; and

WHEREAS, the Police Committee of the Borough of Prospect Park has reviewed the credentials of and personally interviewed Kurtis Reed; and

WHEREAS, the Police Committee recommends the appointment of Kurtis Reed to the police department; and

WHEREAS, Mayor Mohamed Khairullah as the designated "Appropriate Authority" appoints and requests the consent of the Borough Council for the appointment of Kurtis Reed to the Borough of Prospect Park Police Department as a full-time police officer; and

WHEREAS, Borough Ordinance 14-11 provides that each person appointed to a permanent position of Police Officer shall serve a probation period of six (6) months from the date of graduation from his assigned Police Academy or from the date of his appointment if such person is not required to attend a Police Academy;

NOW, THEREFORE, BE IT RESOLVED, by the Mayor and Council of the Borough of Prospect Park that Kurtis Reed is hereby appointed to the Borough of Prospect Park Police Department as a full-time police officer for a probationary period of six (6) months; and

BE IT FURTHER RESOLVED that the Council of the Borough of Prospect Park hereby authorizes all other appropriate Borough of Prospect Park officials and personnel to take all necessary action to effectuate the within Resolution.
