TITLE: RESOLUTION AUTHORIZING THE EXECUTION OF A HOFSTRA PARK TURF SOCCER FIELD USE AGREEMENT FOR SPRING AND FALL SEASON PERMITS WITH TSF ACADEMY

WHEREAS, the Borough has completed the construction of the Hofstra Park Turf Soccer Field and wishes to provide for the use for soccer programs; and

WHEREAS, TSF Academy (“TSF Academy”), a soccer club, has requested that the Borough provide TSF Academy with “Seasonal Permits” for various times for the use and access to the Hofstra Park Soccer Field located in the Borough of Prospect Park for the Spring and Fall Seasons; and

WHEREAS, the Soccer Field will require ongoing maintenance costs to be incurred by the Borough of Prospect Park; and

WHEREAS, the Borough believes that it would benefit the public to promote the use of the Hofstra Park Soccer Field and to offset the maintenance costs of the Soccer Field by the Borough; and

WHEREAS, due to the fact that TSF Academy seeks bulk permits for times for the use of the Hofstra Park Soccer Field, the Borough has determined to provide TSF Academy, an Agreement (Hofstra Park Turf Field Use Agreement), for Seasonal Permits for the Spring and Fall Seasons at the bulk rates for the Permit Fees contained in the Borough Ordinances.

NOW, THEREFORE, BE IT RESOLVED by the Mayor and Council of the Borough of Prospect Park, in the County of Passaic, as follows:

1. The Borough Council hereby approves and authorizes the execution of a Hofstra Park Turf Field Use Agreement with an anticipated term commencing on or about March 17, 2024 to on or about June 16, 2024 for the Spring Season Permit and commencing on or about September 3, 2024 to November 24, 2024 for the Fall Season Permit with TSF Academy, subject to the availability of the field as determined by the Borough Administrator in consultation with the Recreation Director.
 2. The Mayor and Borough Clerk are hereby authorized and directed to execute a Hofstra Park Turf Field Use Agreement with TSF Academy consistent with the rates contained in the Borough Ordinances and in the form acceptable to the Borough Administrator and Mayor.
 3. A copy of this Resolution and the final executed Hofstra Park Turf Field Use Agreement shall be filed with the Clerk of the Borough of Prospect Park.
