Meeting Called to Order

Mayor Jernigan called the meeting to order.

Non-Profit Funding Request Discussion

The Girl Scouts Carolinas Peaks to Piedmont requested funding in the amount of \$475.00. The request would cover vendor registration fees for the Market & Music. The group is not interested in selling a product, only to distribute informational material.

Instead of funding the organization the Board discussed establishing a policy that non-profits providing a service to our community participating only to distribute information could display at no charge contingent on available space.

Randolph Community College has also requested space to distribute informational materials.

A motion to waive the fee if space allows until a policy could be established was made by Alderwoman Bryant seconded by Alderman Betts and unanimously approved.

A fee policy waiver for organizations that provide a service to our community and would like to provide informational materials only will be provided for Board review by Administration.

Randolph County Senior Adults Association, Inc. requested funding in the amount of \$21,566.00. This requested amount shows no increase from the previous allocated amount. The Board recognized the need for this vital organization.

Randolph County Economic Development Corporation requested \$8,000.00. Previously the City provided \$6,000.00 for Industrial Development. The Board requested information pertaining to the proposed increase.

Bob Wilhoit talked with a representative with the EDC and Bucky received an email from Walter Spouse indicating that the groups efforts had been centered around the Megasite and more advertising would be concentrated on the West Randleman Industrial Park, thus the need for an increase. The Board would like to allocate \$7,000.00 and contribute the balance if more efforts to promote the West Randleman Park is indicated.

North Randolph Historical Society – St Paul’s Museum did not request a set amount. It was discussed that \$2,800.00 could be allocated with an option for more if circumstances warranted.

Randleman Chamber of Commerce is requesting funding in the amount \$11,500.00. The City allocated \$2,500.00 last fiscal year. The Board has requested that representatives of the Randleman Chamber Board of Directors meet with the Board of Aldermen to elaborate and present documentation (receipts, purchase orders, etc.) of ideas to promote Randleman.

The City provides in-kind services (Police, Sanitation and Public Works) in the approximate amount of \$3,000.00 for NASCAR Days.

After discussing all request for funding, the consensus of the Board was to prioritize Capital Projects and the City’s infrastructure needs.

Worthville Beach Area safety issues and signage were discussed. Bob Wilhoit suggested that we consult NC GS § 160A-176 for guidance.

The proposed budget will reflect designated funding.

Adjourn

A motion to adjourn was made by Alderman Fogleman seconded by Alderwoman Bryant and unanimously approved.
