- Vendors are limited to 1 space. Additional spaces may be requested for limited periods of time when the vendor has additional products to bring to market. The number of spaces you are allocated is based on the amount of product you regularly bring to the market, not the size of your vehicle.
- If a Vendor is required to have licensing to sell their product a copy of all Applicable license(s) must be included with the application.
- The signed application confirms your intention to abide by all rules, regulations and codes of conduct and must be signed to be considered for space at the Commerce Square Park Thursday/Sunday Farmers' Market.
