

# Minutes of the Rappahannock County Electoral Board Meeting

## June 13, 2022

### Call to Order

The meeting of the Rappahannock County Electoral Board (EB) was called to order at 12:41 P.M. by Chair, Denise Chandler, at the Office of the Director of Elections, 262A Gay Street, Washington, VA 22747.

In attendance were EB members Denise Chandler, Chair (by phone); Ken Reid, Vice-Chair; and Robert Klaus, Secretary.

Also present: Kim McKiernan, Director of Elections.

Vice-Chair Reid proposed review of Draft Minutes May 4, 2022 meeting, which had been distributed for review by email. Minor revisions were inserted. After discussion, Reid moved to approve the 4 May Minutes. The motion was approved unanimously.

### NEW BUSINESS

1. Reports of the Electoral Board officers
  - a. (None)
2. Reports of the Director of Elections and staff
  - a. Deputy Registrar Position
    - i. Advertised 18 May
    - ii. Received Resume from Kendall Trout dated 20 May
    - iii. Registrar McKiernan interviewed candidate and offered her the job; offer was accepted on 12 June, but it will be a delayed start (1 July)
  - b. Election Official Recruitment
    - i. 7 new EOs have been recruited and referred to online training to establish a base understanding of their roles.
    - ii. It was suggested that we advertise in local papers for more recruits; the Registrar will look into this.

- c. Redistricting status
  - i. Our attempts to post the revisions were iterated extensively with the GIS consultant who is supporting our efforts, and have now been accepted by ELECT.
  - ii. The Registrar and the County Administrator will be working with the GIS consultant, in the future, to create an online lookup tool for voters and residents alike.
  - iii. New voter ID cards will be issued when newly assigned addresses can be verified and updated in the state database (VERIS) as a result of redistricting.
- d. Old laptops (former pollbooks)
  - i. The hard drives are being wiped and units are being restored to factory settings, after which they will be offered, in accordance with county policy #410, to other County Departments, Fire/Rescue organizations, then to 501(c)(3) charities. Any remaining units will be disposed of through surplus auction.


The meeting was adjourned by the Chair at 1:38 P.M. The next EB meeting is tentatively scheduled for 1 July, 2022.
