## QUARTERLY REPORTS

## Chairman

Chairman Bainbridge stated that this is his first quarterly report since he just started in July. Things have been very busy and it hasn't slowed down.

Chairman Bainbridge had numerous meetings that included DWD, DOC, and DOJ. These meetings' discussions were revolved around the services that the Tribe should be utilizing. All the programs will help the community.

Chairman Bainbridge stated that the Council had their meeting with the Bayfield School Board and was disappointed in the turnout. Trying to get meetings where all the Council and the School Board are present.

Chairman Bainbridge attended the GLITC meeting in Milwaukee, WI and was asked to participate in the opening ceremony for the Indian Summer Fest. It was an honor and great experience for him to be a representative for our Nation.

Jeanne Gordon moved to approve the Chairman's Quarterly report. Seconded by Marvin Defoe. Motion carried.

## Vice Chairman

Vice Chairman Gordon started off by thanking the community and the membership for the opportunity to sit as the Vice Chairperson again.

Vice Chairman Gordon talked of his many meetings and various activities in the past 3 months. He mentioned meeting with staff on a daily basis and the numerous phone calls that he receives daily.

Vice Chairman Gordon mentioned that he attended the ECC Graduation ceremony and being part of the annual Red Cliff Pow Wow.

Marvin Defoe moved to approve the Vice-Chairman's Quarterly report. Seconded by Jeanne Gordon. (1 abstention: Nathan Gordon). Motion carried.

## Planner

Jeff Benton was here to present the report. Jeff mentioned that this quarter the transit bus had close to 4000 people and riders. This is the highest count so far.

Jeff also mentioned that they received a COPS DOJ re-hire grant in the amount of \$125,000 to fund an officer.

Jeanne Gordon moved to approve the Tribal Planner's Quarterly report. Seconded by Laura J. Gordon. Motion carried.

## Chief Financial Officer (CFO)

Rick Petersen said he will send a written report to Laura J. Gordon for the Council.

Rick mentioned that the Compliance office has become more active in the contracts and budgets.

Hired a new IT Coordinator and he has installed a new email system, which has more storage than the previous system. He also installed the new time clock system.

Jeanne Gordon moved to approve the Chief Financial Officer (CFO)'s Quarterly report. Seconded by Nathan Gordon. Motion carried.

## **Division Administrator Manager**

Rob Goslin spoke of all his meeting with the staff and his duties for the quarter. Finished evaluations, met with Administrator individually, sat on the hiring board, and attended the Tribal Council retreat. Rob also mentioned that he attended Indirect Cost training.

Dee Gokee-Rindal spoke of the happenings in the Education department. They held their 20<sup>th</sup> annual ECC ceremony. Was a great success with over 300 people in attendance.

Rob had assisted with the Red Cliff Pow-Wow and the Indigenous Arts & Science Fair. She mentioned the numerous site visits that the ECC had in this quarter. Also, she mentioned that the ECC staff had a two week lay-off due to not receiving the extra pot of money to cover the cola increases.

Patty Deragon-Navarro stated that the clinic was involved in the Pow Wow this quarter and the Grandfather Feast which was held at Legendary Waters Casino.

Patty also mentioned that they are looking at ways to come up with for in-patient treatment for Behavioral Health issues.

Dan Duffy asked if the facility maintenance is getting Taylor Woodstone to come back and fix the inspection problems. Patty said that they are staying on top of this issue so that it can be resolved.

Lorna Gamble mentioned that they had Approximately 1870 Clients served and 1863 Families that the programs had served.

Lorna had touched on all the meeting and events that the programs did in this quarter.

There was a question on the Domestic Violence Program long term goal of having a crisis line for sexual assault women. Lorna stated yes that line would have to be monitored 24 hours a day and right now Susan Moore and she answer calls right now if they get them.

The re-entry program has received a no cost extension with an end date of September 30, 2016.

Mark Duffy was here to present the Natural Resource Division report. Mark mentioned the activities that have been held. This included CPR/First-Aid training and the family ricing event. Also, they did an ATV safety course.

Mark also mentioned that the division offered the 3 summer youth workers a scholarship in the amount of \$250.00 each for furthering their education.

Steven Boyd moved to approve the Division Administrator Manager's Quarterly report.

Seconded by Jeanne Gordon. Discussion: Robert Powless, Public Works Department Director and Bill Mertig, Public Safety Administrator to come back with a six (6) month report at the next Quarterly report meeting which is in January of 2016. The report will be from July 1, 2015 thru December 31, 2015. Motion carried.

## **Utilities Commission**

Marvin Defoe moved to Table the Utilities Commission report until the next Tribal Council meeting. Seconded by Nathan Gordon. Motion carried.

## Red Cliff Housing Authority

Mike Babineau was here to discuss the happenings at the Housing Authority. He mentioned the start of the new Supportive Housing has begun. Marvin Defoe asked when they are thinking of opening for the tenants. Mike replied that they are looking at spring time for tenants to be moving in.

Marvin Defoe asked if the Housing was planning on replacing the playground equipment in the New Housing. Mike said the equipment was insured so they are looking to replace it but might not install until spring.

Laura J. Gordon moved to approve the Red Cliff Housing Authorities Quarterly report. Seconded by Jeanne Gordon. Motion carried.

## Legal

Dave Ujke and Wade Williams were here to present the 1<sup>st</sup> Legal Department report. Dave spoke of the many meetings and projects that he is currently working on. These include SMSC Casino Financing, Fee lands tax issue, KBIC Hog Farm Issue, Night Hunt Appeal, and the Lake Superior Management Agreement Negotiations.

Wade spoke of his numerous contracts that he has approved. He also mentioned that they are working on getting a better system for the PAC review. This will include policy and procedure improvements and possible code revisions.

Wade also mentioned that there was a new Network Storage Server installed at the Legal Department. This will allow for more secure file-sharing. This will also improve the effiency of the team work in the Legal Department.

Jeanne Gordon moved to approve the Legal Department's Quarterly report. Seconded by Marvin Defoe. Motion carried.
