Response to Recent Area Event and COVID-19

July 9, 2020

Dear Community Members,

Recently there have been a number of confirmed COVID-19 cases attributed to a large gathering in Ashland County. These cases come from a public event that included local families and groups from out of the area.



Thus far, 13 cases of COVID-19 have been attributed to this event, with several more tests pending. To date, this cluster includes 1 local case, 9 cases in Michigan, and 3 cases in Minnesota. Cases have been confirmed in both children and adults. There are no cases in the Red Cliff Reservation. We anticipate that this number will grow as more test results are confirmed.

In addition to the direct health effects on families that have contracted COVID-19, it is important to note the ripple effects within the greater community:

Public Health: In order to fulfill the contract tracing requirements related to this event, the Public Health Departments in Ashland and Bayfield County have been working well-above capacity for the past week. Time spent on contract tracing detracts from time spent on other critical prevention efforts that are an essential part of pandemic response.

Businesses: A handful of businesses in the area have temporarily closed, or suspended portions

of their operations, based on potential staff exposure to COVID-19 due to this single event. These types of closures have a significant impact on the reputation and economic viability of a business, and the health and financial well-being of staff members that rely on these businesses for their livelihoods.

Medical facilities: Local medical providers have experienced an extraordinarily high volume of testing requests related to this single event, putting significant pressure on an already limited supply. Simultaneously, many staff members have been required to quarantine based on potential exposure stemming from this event resulting in decreased capacity of our medical partners to respond to both COVID and non-COVID related events.

We share this information to inform local residents about the effects one event can have on the medical, public health, and economic infrastructure of the area. Over the previous four months, public health representatives from Ashland County, Bayfield County, Iron County, Bad River, Red Cliff, and Memorial Medical Center have been working together to proactively increase the regional response capacity to COVID-19. While great strides have been made, the cornerstone of an effective COVID-19 response still relies heavily upon the willingness of regional residents to comply with recommendations.

In the best interests of community health and well-being, it is critical that local residents and visitors to the region adhere to best practices in order to limit the spread of COVID-19.

- Limit contact with people outside of your household and maintain six feet of distance in public settings.
- Wear a mask at all times when in contact with people outside your household.
- Avoid travel to virus hotspots and do not attend or host large group gatherings.

Thank you for your willingness to do your part in slowing the spread of COVID-19. The future health and safety of our community depends upon it.

Annual Water Quality Report

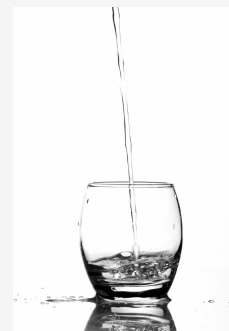

Community Input Request



At the onset of the COVID-19 Health Pandemic, it was the primary goal of Health services to ensure the Emergency Medical Services be operating at its best to better the response time to any health emergencies. It has been identified that the two ambulances need to be replaced due to their age, condition and size. The new ambulances would be too large for the current ambulance bays and it's been determined not feasible to remodel the existing space.

Red Cliff has sought financial assistance through the CARES Act Indian Community Development Block Grant Imminent Threat to replace two ambulances and build a new EMS hall at the Health Services Campus in the amount of \$900,000. The new hall would provide training space, overflow exam space, emergency response headquarters, and an on-site isolation space.

GLIFWC Job Opening Outreach Coordinator

This is a 1-year full time position that may be renewed with continued funding through the Great Lakes Indian Fish and Wildlife Commission's (GLIFWC's) Great Lakes Restoration Initiative grants.

GLIFWC is located on the Bad River Indian Reservation in Odanah, Wisconsin.

Under the direction of the Director of the Public Information Office, the Wildlife Section Leader, the Environmental Biologist and the Great Lakes Program Coordinator and the supervision of the Great Lakes Program Coordinator, the Outreach Coordinator will perform duties in a manner consistent with Commission policies and procedures.

Eligible Loan Purposes: Funding to get applicant through a time of crisis. Primarily used for food, shelter (rent or mortgage) and critical expenses.

Eligible Borrower: Enrolled members of a Wisconsin Tribe or documented descendants of Wisconsin Tribes. Employed for previous 6 months (prior to furlough or layoff) and a current Wisconsin resident.

Loan Amount: \$1,000 to \$5,000.

Payment and Amortization Schedule: Up to three months interest only payments. The

remaining months paid interest and principal. Amortization to reflect this payment schedule.

Loan Terms: Up to 2 years for loans under \$2,499.99 Up to 4 years for loans over \$2,500.00

Interest Rate: 6% for collateralized loans – 15% for non-collateralized loans

Application Fee: \$50.00

Origination and Closing Fees: 3% of loan amount and can be financed.

Serious Adverse Health Events Associated with Methanol-based Hand Sanitizers

Summary

Most commercially available alcohol-based hand sanitizers or rubs (ABHSR) contain either ethanol or isopropanol as active ingredients. On June 19, 2020, the U.S. Food and Drug Administration (FDA) advised consumers not to use any hand sanitizer manufactured by "Eskbiochem SA de CV" in Mexico, due to the potential presence of methanol, a "toxic alcohol", as an active ingredient, which can cause blindness and/or death when absorbed through the skin or when swallowed. Since then, FDA has identified additional ABHSR products that contain methanol and is working with manufacturers and distributors on a voluntary recall of these products (<https://www.fda.gov/drugs/drug-safety-and-availability/fda-updates-hand-sanitizers-methanol>).

Hand hygiene is an important part of the response to the emergence of COVID-19 in the United States. Practicing hand hygiene, which includes using ABHSR, is a simple and effective way to decrease the spread of pathogens and infections. Commercially available ABHSR usually contain either ethanol or isopropanol. However, some ABHSR that were manufactured in Mexico (<https://www.fda.gov/drugs/drug-safety-and-availability/fda-updates-hand-sanitizers-methanol>) have been found to contain a significant amount of methanol. Repeated use of these products on the skin may result in methanol poisoning. However, the highest risk for methanol poisoning is by swallowing ABHSR products containing methanol.

Recommendations for the Public

1. Seek immediate medical attention if you have swallowed alcohol-based hand sanitizer or rub or are experiencing symptoms from repeated use of these products on your skin and contact your poison center (1-800-222-1222) for advice. Signs and symptoms include headache, blurred vision or blindness, nausea, vomiting, abdominal pain, loss of coordination, and decreased alertness.
2. Do not swallow any alcohol-based hand sanitizers or rubs. These chemicals are not intended for human consumption and can lead to serious health issues, including death.
3. Only use alcohol-based hand sanitizers or rubs for their intended purpose – to clean hands.
4. Keep alcohol-based hand sanitizers or rubs out of reach of children and supervise their use.
5. Check your hand sanitizer products against the "FDA's testing and manufacturer's recalls" list (<https://www.fda.gov/drugs/drug-safety-and-availability/fda-updates-hand-sanitizers-methanol>). If your product is on this list, stop using the product and dispose of it immediately in appropriate hazardous waste containers; do not flush or pour them down the drain.

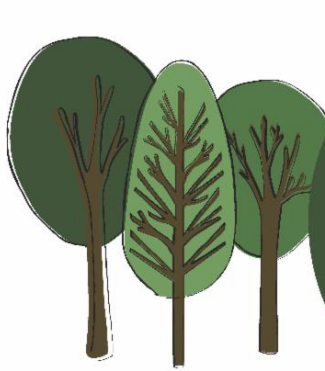

WIISAGIZI MAA'INGAN (COYOTES)

There has been an increase in recent coyote sightings within residential areas. Most coyotes that enter residential areas pose no threat to humans. Conflicts with coyotes can be reduced by eliminating attractants. Below are some tips you can use to deter nuisance wildlife from entering your property.



General Tips:

- Remove food sources from your yard such as pet food, garbage, birdseed or compost. Clean outdoor grills frequently.
- Securely cover garbage containers and go to the dump frequently.
- DO NOT DUMP food waste or grease in or near your yard.
- Closely watch small pets while outdoors and bring them indoors with you.
- Let coyotes that enter your yard know they are not welcome by “HAZING” them. Yell at them, make loud noises or use noise makers to scare them away. Throw things towards them, but do not attempt to injure them. Install motion sensing lights.
- If you see a coyote that appears sick, injured or acts aggressively contact the Red Cliff Wardens immediately.

'We Are On The Brink Of Disaster': Public Testifies On Proposed Pipeline Reroute

People expressed fears that a proposed pipeline project threatens the climate, pristine waters and Native communities in northern Wisconsin while others claim it can be built safely and provide much-needed jobs, in a virtual public hearing on Wednesday.

Around 360 people registered to provide input about the impact of Enbridge's Line 5 relocation project on northern Wisconsin waterways as part of the hearing held by the Wisconsin Department of Natural Resources on permits being considered for project. The pipeline carries up to 23 million gallons of oil and natural gas liquids per day from Superior to Sarnia, Ontario. The Canadian energy firm is proposing a roughly 40-mile reroute of Line 5 outside the Bad River Reservation in Ashland and Iron counties. Enbridge is seeking to relocate the pipeline after the Bad River Band of Lake Superior Chippewa filed a lawsuit against the company aimed at shutting down and removing Line 5 from the tribe's reservation.

The company's preferred route runs south of the reservation and north of Mellen in Ashland County. The proposed route is expected to cross more than 180 waterbodies and temporarily impact at least 109 acres of wetlands.

Cathryn Hanson, Enbridge's environmental supervisor, said in a media call prior to the hearing that the route is among four the company considered.

"Our route analysis really focused on minimizing the length of the pipeline to the extent practical, while protecting resources and still being responsive to landowner and community input," said Hanson.

The company's proposed route would still reside within the Bad River Watershed, which drains more than 1,000 square miles along the shore of Lake Superior. The Kakagon and Bad River sloughs — referred to as the "Everglades of the North" — lie at the mouth of the watershed, comprising around 16,000 acres of internationally recognized wetlands.

Hanson said the preferred route is about 60 miles shorter with fewer environmental impacts than the longest alternative route outside the watershed.

Bad River Tribal Chairman Mike Wiggins has said the tribe intends to fight to remove Line 5 from the region due to the significance of the watershed. Enbridge has offered the tribe a \$30 million settlement, while Bad River has asked for \$45 million for trespassing in addition to shutting down and removing the Line 5 from the Bad River watershed.

Lac Du Flambeau Canoe-BUILDER Valliere Earns Top National Arts Honor

A traditional birchbark canoe builder from Lac du Flambeau is now one of the nation's top honorees in folk and traditional arts.

Wayne Valliere Sr. was selected as a 2020 National Heritage Fellow by the National Endowment for the Arts (NEA).



"I was shocked. I was literally shocked. I understand what the award is," Valliere said. "People like B.B. King and a lot of famous people that did really great things in the art world for the betterment of mankind [have been honored]. Just to have my name in the pool of people like that is an honor. It's beyond belief."

Valliere is one of just a handful of master birchbark canoe builders remaining in the Midwest. "The art forms that I'm known for, they don't belong to me. The knowledge belongs to my people," he said. "That's one of the reasons why I won the award, I guess, is because I've been sharing this canoe culture in communities throughout the Midwest."

Since 1982, Heritage Fellowships have been won by icons like King, the legendary bluesman.

"It is intended as the highest honor in the folk and traditional arts bestowed by the United

States Government,” said Cliff Murphy, the Director of Folk and Traditional Arts at the NEA. Murphy pointed out Valliere seeks to teach canoe-building while teaching other traditional skills and ways of life.

“He brings young people into the process to learn how to make canoes. In the process, they’re learning about language. In the process, they’re learning about fishing, harvesting of wild rice, all of these things that are so important to the lifeways and identity and sacred practices of this community,” Murphy said.

Valliere said he’s currently working on another canoe now with an apprentice who will soon become a master canoe builder himself.

“It’s my life work,” Valliere said. “If I can teach one person to carry this craft forward, then I know that it will live for at least one more generation.”

The lifetime honor awards include a \$25,000 prize.

Iroquois Raised Beadworker Karen Ann Hoffman of Stevens Point, an Oneida Nation tribal member, is one of the other eight honorees this year.

They include soul singers, West African dancers, and fiddlers from around the country.
