What is a Legislative Priority?

- Policy positions and bonding requests the city supports at the state level
 - Priorities help steer the City's legislative advocacy, outreach and partnership in the coming year
 - Legislative priorities may change based on bonding vs. non-bonding year
 - Best practice- City Council formally adopt

Equitable



As the City of Richfield we....

- Support legislation that addresses the widening existing economic, racial, health and education gaps, and the adverse impacts a warming climate will have on our most vulnerable communities.
- Support local officials who know what tools and programs best support our residents.
- Oppose the imposition of legislative mandates that increase local costs without a corresponding state appropriation or funding mechanism.



2023 Legislative Priorities

- Legislative platform includes 3 top city priorities
- Council formally adopts
 legislative platform
- Within the City's scope of influence



Top 2023 Legislative Priorities

- **1. Support** a bonding bill for a new Wood Lake Nature Center facility
- 2. Support legislation which would provide the City of Richfield the authorization to propose a local sales tax (LST) to support regionally significant park projects.
- **3. Support** local control of Emergency Medical Services (EMS).



1. Support a bonding bill that appropriates \$10,000,000 towards a new Wood Lake Nature Center facility

- This beloved and vital regional asset is turning 52 years old in 2023
- Center needs a new building and improved trail system
- 22,500+ people attend programs each year
- Serves people from all areas of the Twin Cities metro including visitors from greater Minnesota





2. Support legislation which allows Richfield the authorization to propose a local sales tax (LST)

- LST funds would support regionally significant park projects.
- The projects must also include the length of time the funding will be in effect
- Will be discussed further at a work session on December 8, 2022
- Provides additional long-term funding for future large-scale public projects
 - 2022 half cent sales tax estimate is \$2.8- \$3.4 million annually



3. Support local control of Emergency Medical Services (EMS).

- Allow local units of government to designate which licensed ambulance service or provider(s) may serve their communities to ensure the appropriate level of service
- Local units of government should be provided with tools and authority to ensure transparency and responsiveness by EMS providers



Additional Legislative Positions

- Each department has identified additional priorities to be part of the city's complete legislative platform
- The final legislative platform will be sent to our state representatives and posted to our website.

Next Steps

- The final legislative priorities will go to the City Council for adoption at the December 13 council meeting
- Adopted legislative platform will be presented to elected representatives at the annual legislative breakfast
- Breakfast scheduled at 7:45 a.m on December 20 at the WLNC
