

**SAGAMORE HILLS TOWNSHIP
RULES AND REGULATIONS GOVERNING SOLICITING IN
SAGAMORE HILLS TOWNSHIP**

RESOLUTION introduced by Paul Schweikert.

- WHEREAS,** the Sagamore Hills Township Board of Trustees seeks to prevent crime, fraud, and harassment of the citizens of Sagamore Hills Township and to protect the privacy of the residents of Sagamore Hills Township; and
- WHEREAS,** the Ohio Revised Code §505.94 authorizes the Sagamore Hills Township Board of Trustees to prohibit solicitation at any residence at which the owner or tenant has posted a sign on the property prohibiting solicitation or for which the owner or tenant has filed a no solicitation registration form with the township, on a form prescribed by the board.
- WHEREAS,** the Sagamore Hills Township Board of Trustees requires that all solicitors must register in person with the Sagamore Hills Police Department and fill out a solicitor's application in full.
- WHEREAS,** solicitation hours are from Monday through Friday, 10:00 a.m. to 5:00 p.m.
- WHEREAS,** the Sagamore Hills Township Board of Trustees requires a charge of \$150.00 per solicitor for a period of ninety (90) days from issuance. There is no charge for non-profit organizations.
- WHEREAS,** all solicitors in Sagamore Hills Township are required to wear a photo ID badge with their name and the name and address of the company they represent. This badge shall be clearly visible at all times and will not be supplied by the Sagamore Hills Police Department.
- WHEREAS,** solicitors will be given a "No Knock" list of addresses. If on the "No Knock" list or a sign is displayed at a residence, the solicitor shall not go to the residence.


NOW THEREFORE BE IT RESOLVED by the Board of Trustees of Sagamore Hills Township, Summit County, Ohio requires that all solicitors must be registered with the Sagamore Hills Police Department and fill out a solicitor's application in full; solicitation hours are from Monday through Friday, 10:00 a.m. to 5:00 p.m.; there is a charge of \$150.00 per solicitor; no charge for non-profit organizations and is good for a period of forty-five (45) days from issuance; all solicitors in Sagamore Hills are required to wear a photo ID badge with their name and address of the company they represent clearly visible at all times and such badge shall not be supplied by the Sagamore Hills Police Department; solicitors will be given a "No Knock" list of addresses. If on the "No Knock" list or a sign is displayed at the residence, the solicitor shall not go to the residence.

A certified copy of this resolution shall be filed with the Summit County Prosecutor's Office.






