A RESOLUTION DESIGNATING AN AGENT AND ALTERNATES TO APPLY FOR AND COMPLETE ALL REQUIRED FORMS AND DOCUMENTS FOR THE PURPOSE OF OBTAINING FINANCIAL ASSISTANCE UNDER THE ROBERT T. STAFFORD DISASTER RELIEF AND EMERGENCY ASSISTANCE ACT RELATIVE TO THE DISASTER EMERGENCY KNOWN AS THE REMNANTS OF HURRICANE IDA

WHEREAS, on September 11, 2021, President Joseph R. Biden, Jr., approved a Major Disaster Declaration for certain counties in Pennsylvania including Montgomery County relative to the remnants of Hurricane Ida ("Storm Ida"); and

WHEREAS, as a result of the Declaration of Disaster, Federal disaster assistance is available to the Commonwealth of Pennsylvania to supplement Commonwealth and local recovery efforts in the areas affected by Storm Ida; and

WHEREAS, the Borough of Schwenksville has sustained substantial damage resulting from Storm Ida and is eligible to apply for public assistance through the Pennsylvania Emergency Management Agency ("PEMA") and the Federal Emergency Management Agency ("FEMA"); and

WHEREAS, the Borough of Schwenksville, through its authorized agents, has submitted an application for public assistance through PEMA and FEMA.


