<u>Finance Report:</u> Mrs. Klepfer read the summary Financial Report. For the Period January 1, 2016 through December 31, 2016, total income for General Fund and Liquid Fuels Funds was \$581,798.10 and Total Expenditures was \$557,533.67 for a net gain of \$24,264.43. General Fund experienced a net gain of \$18,515.41. General Fund Assets total \$283,300.39, Capital fund Assets total \$26,639.33 and Liquid Fuels Fund Assets total \$28,245.56 for a combined Assets total of \$338,405.28.

<u>Ballot Question- Local Police – Council discussed contracting for local police services from Lower Frederick Township at a cost of \$125,000 per year.</u> An estimated 2mil tax increase for the Borough

would be needed which is estimated at \$400 per household. Council decided that if the move forward with this project it can be placed on the Fall Ballot as a non-binding referendum. Mrs. Klepfer should confirm that it would be non-binding and continue to work a ballot question suitable to the County Board of Elections.

<u>Committee Reports</u>: Ms. Miller did mention the first public meeting is January 12, 2017 for the Swamp Creek Greenway and Sunrise Trail Feasibility Study. The study will determine the feasibility of a public trail network along the Swamp Creek from Schwenksville to New Hanover Township.

**Revitalization Task Force:** Ms. Miller reported that on December 4, 2016 a mural concept meeting was held.

Other Business: In attendance were 2 Boy Scouts from Troop 105 to observe the Council meeting and to ask questions. They also talked with Council members after the meeting.
