

Dear Residents,

We know it has been a while since our last enews; a lot has happened since the last one. Schwenksville Borough sustained extensive damage from the remnants of Hurricane/Tropical Storm Ida passing by. We sincerely hope that everyone is recovering



from the storm, and that everyone is OK. Our hearts go out to those who have been impacted! The damage sustained includes severe damage to the new Borough Hall and Community Center which has caused a disruption in communication and business operations. We apologize. We are doing the best we can to resume operations and services. To do this, we have been and will continue to rely on the assistance of good citizens to help us overcome the challenges the storm damage has created. Please read through this e-news to see if there is a way that you can assist your community and help us through this difficult and challenging time. We've also included information and links for residents and business owners who are also feeling the stress of recovery.

Best Way to reach us

Borough Hall sustained approximately 24"of water damage throughout the building. The first step towards restoration was hiring Eastern Diversified Services to remove the flooded materials, sanitize and dry the building. This work was completed very quickly, but it will not be possible for us to return to work until the restoration work is completed.



All permit applications can be submitted electronically from submittable forms available at www.schwenksville-pa.org. Additional information, attachments or PDF applications should be emailed to info@schwenksville-pa.org. Barry Isett and Associates is assisting us with monitoring the electronic submission of all applications. Please note that it is very important that you get all of the required permits and inspections when completing projects resulting from natural disasters. Insurance companies may ask for

that information for claims or future claims.

Many residents have reached out to offer help with clean-up activities, and we're very grateful for those who stepped in on short notice to assist. The Borough <code>is</code> in need of volunteers to help with both clean-up from the flood and fall maintenance activities around Borough Hall and in Meadow Park. Several work parties are planned, and there are also opportunities for individuals or small groups to take on particular tasks on your own




time schedule. Those interested in assisting are asked to e-mail Parks Chairperson Sarah Knickerbocker at sknickerbocker@schwenksville-pa.org to get on our mailing list for work parties. Please also let us know if you are able to assist with any of the specific items below. You can also fill out a Volunteering information form from our website for all advisory boards, committees and general volunteering.

- --The first Work Session will take place this **Saturday, September 18** from 9am to approximately 11:30. The focus of this session will be on cleaning up the playground and other equipment so they are safe for re-use, and picking up debris. Please let us know if you are coming, so we can plan the extent of the activities and let you know what tools might be helpful to bring if you have them.
- --Looking for free firewood? There are 3-4 large logs from the removal of a standing dead ash tree. A chain saw will be needed and trailer or truck to

transport. If interested, please contact the Borough at info@schwenksville-pa.org. <u>A waiver of liability form</u> is needed. The person who submits the signed waiver first and can remove it fairly quickly will get our approval.

- --Do you have a chainsaw, gas power pruner, bush hog attachment or pressure washer? Individuals with these items who wouldn't mind devoting a few hours would be greatly appreciated.
- --Have a truck you wouldn't mind loading with logs and brush and taking to the recycling center or otherwise disposing of? Can be timed with a work session so volunteers will do the loading.
- --Like to weed and garden? Love to prune? We are looking for individuals to help maintain various garden areas on a seasonal or regular basis.
- --Only interested in helping with cleaning? <u>Let us know</u>. Any and all donations of time is appreciated.







Borough Hall, located at 300 Main Street was surrounded by floodwater from the Perkiomen Creek.
Approximately 24" of water was inside the building. To our knowledge, this is the first time this land has flooded since perhaps Hurricane Agnes in 1972.



In addition to Borough Hall, the Borough sustained flood damage to critical infrastructure such as roadways, traffic signal control Box and damage to Meadow Park.

We estimate the Perkiomen crested at between 22' and 23', approximately 4' higher than the last record.

On September 10, 2021, President Biden approved Major Disaster Declarations (MDD) for portions of Pennsylvania, **including Schwenksville Borough****. The incident period for both declarations is from August 31 – September 5, 2021, and authorizes FEMA to provide federal disaster assistance to impacted areas. About Disaster Assistance

Federal disaster assistance from FEMA may be available for certain expenses which are not covered by insurance policies (Homeowner, Renter, Flood, etc.) or from active Voluntary Agencies/Mass Care (emergency food, shelter, clothing, medical, etc.). For counties with major disaster declarations, this can include grants for temporary housing and home repairs, low-cost loans to cover uninsured property losses, and other programs to help individuals and business owners recover from the impact of Hurricane Ida. Apply for Federal Assistance

You may <u>apply online</u> for individual assistance from FEMA or constituents may call the application phone number at 1-800-621-3362 (TTY: 800-462-7585).

Please be sure to read the above Sequence of Delivery Fact Sheet. Residents who wish to seek assistance are urged to apply as soon as possible to ensure their receive available assistance. There may be caps on funding available, and all applications must be received by FEMA within 60 days of the declaration date (September, 10th).

Tips for Applying

When you apply for assistance, have the following information readily available:

- A current phone number where you can be contacted
- Your address at the time of the disaster and the address where you are now staying
- Your Social Security number, if available
- A general list of damage and losses
- If insured, the policy number or the agent and/or the company name
- Remember to document everything take photos and document all damages and keep all receipts related to cleanup and repairs.
- Apply for Assistance from the Small Business Administration

Apply for Assistance from the Small Business Administration

In addition to FEMA assistance programs, the U.S. Small Business Administration (SBA) offers low-interest disaster loans for homeowners, renters, businesses of any size, and most nonprofits. Similar to FEMA claims, SBA cannot duplicate benefits for losses covered by insurance. For small businesses, those engaged in aquaculture and most nonprofits, loans up to \$2 million is available for working capital needs even if there was no property damage, with a \$2 million maximum loan for any combination of property damage and working capital needs.

For homeowners: loans up to \$200,000 is available to repair or replace their primary residence.

For homeowners and renters: up to \$40,000 is available to replace personal property, including vehicles.

How to Apply to SBA

For questions and assistance completing an application, call 800-659-2955 or email <u>DisasterCustomerService@sba.gov</u>. The SBA will answer specific questions about how a disaster loan may help each survivor recover from the disaster damage

Hurrican Ida Response Info from Montgomery County

Please find the latest Hurricane Ida recovery updates below.

SHELTER

The Red Cross Shelter at Norristown Area High School has been closed.

Montgomery County is offering resources to individuals and families who are currently experiencing homelessness or are at risk of homelessness due to the impacts of Hurricane Ida. Residents should **contact Your Way Home by dialing 2-1-1or texting their zip code to 898-211** to check availability of resources, which may include short term hotel housing in certain cases.

Short term hotel housing is prioritized for individuals or families who are:

- · Sleeping outside
- · Sleeping in a car
- · Staying in overcrowded or unsafe housing conditions
- · Staying in a hotel and are at risk of being displaced
- · Staying in housing that is now condemned or otherwise deemed unsafe Short-term hotel housing is offered at no cost to Montgomery County residents who have been displaced.

FREE ON-DEMAND TRANSPORTATION

No cost transportation through Gogo Grandparent is available for anyone who has been impacted by Hurricane Ida for basic transportation needs. Transportation is for anyone, not just seniors! Montgomery County residents can request free roundtrip transportation through the following process:

- 1. Step 1 Sign Up:
- a. Call 1 (855) 464-6872 and tell them you would like to sign up as part of Montgomery County, or
- b. Visit https://gogograndparent.com/montco to sign up
- 2. Step 2 Request a Car:
- a. Call 1 (855) 464-6872
 - i. Press 1 for a car to your home
 - ii. Press 2 for a car to where we dropped you off last
 - iii. Press 0 to speak with an operator
- 3. Step 3 A car comes to you!

This week, FEMA representatives will be going door to door in our hardest hit communities to make residents aware of the resources and funding available and to sign them up in person.

Before you apply for assistance, follow the below steps to start your recovery process:

- 1. Step 1: Take photos of your damaged home and belongings.
- 2. Step 2: Make a list of damaged/lost items.
- 3. Step 3: If you have insurance, you must file a claim with your insurance company. If you do not have insurance, continue to Step 4. (FEMA assistance cannot aid with losses already covered by insurance.)
- 4. Step 4: Apply for disaster assistance using one of the below methods:
- a. Online

at www.disasterassistance.gov (Espanol: https://www.disasterassistance.gov/es)

- b. Over the phone at 1-800-621-3362 / TTY 1-800-462-7585 (7 a.m. to 1 a.m. ET, 7 days a week)
- c. Via the FEMA smartphone application: Google Play or Apple App Store
- d. In-person at a Disaster Recovery Center (DRC) -location and other details to be announced soon

Montgomery County will announce the location of a Disaster Recovery Center (DRC) in the coming days. At the DRC residents can apply for aid in person, visit for information about FEMA or other disaster assistance programs, or ask questions related to their case. ARE YOU READY MONTCO?



If you want to be alerted to emergencies and be informed, consider being "ReadyMontco"!
Schwenksville Borough is striving to use
ReadyMontco to send its emergency notifications.
It's your official source for notifications about emergencies, severe weather, crime alerts and disasters. With ReadyMontco, you can choose to receive alerts via text, email and/or phone. You can

also choose to receive alerts from other parts of Montgomery County -maybe from where you work or whether other family members live.

ReadyMontco is administered by the **Montgomery County Department of Public Safety** and comes to you free of charge (text messaging and voice rates may apply). All it takes is about 10 minutes to create a profile and you'll be READY to go! **To sign up go to www.readymontco.org** and click on the **Sign Up tab at the top of the page.** If you need assistance, consider reaching out to a family member or neighbor. There is also a short "how to sign up" video you can watch. You will need to provide an email address to register, if you don't use email regularly, consider asking a friend to help you set up a GMAIL Account. You'll be prompted to enter basic contact information about how you would like to be contacted. If you have a smart phone, you can download the Everbridge Mobile Member from the App Store on your iPhone or Android. Smart 911 is here!

In an emergency, seconds count! Montgomery County has partnered with Smart911, allowing you to create an online profile that provides key information to 911, and first responders. You can upload as much, or as little information as you would like. Your profile can include information about your address, members of your household (2 and 4 legged!), or any medical information such as preexisting conditions or medication.

How does the system work in an emergency? When you dial 911, your profile will appear for the 911 call taker and dispatcher allowing them to access the information you have shared. Pertinent information can then be relayed to first responders. The information is safe, secure, and is only available when you call 911-The system is not accessible without the completion of a 911 call.
