The proposed billboard site is at located on an M-1 (Light Industrial) zoned property at 9854 S. DeWolf Avenue (APN: 348-072-10).
- 3) Consideration and Necessary Action of a resolution for approval of a Conditional Use Permit (2022-0019) for the construction and use of a static billboard. The proposed billboard site is located on an M-1 (Light Industrial) zoned property at 3971 DeWolf Avenue (APN: 348-072-04).
