## CITY OF SELMA REGULAR COUNCIL MEETING October 21, 2013

**MEASURE "S" UPDATE**: Chairperson Dr. Stan Louie stepped forward to report that the Measure "S" Oversight Committee reviewed and approved the revenue received from the Measure "S" funds and that the expenditures were allocated appropriately for fiscal years 2011-12 and 2012-2013.

## PRESENTATION OF MADD (MOTHERS AGAINST DRUNK DRIVING) AWARD

It was the consensus of Council to direct staff to continue as with previous years and encourage commercial landscapers and homeowners to place leaves into the green waste cans and not to rake them into the street.

Community Services Director Kirchner and Police Chief Garner presented Council with their social media website pages that they established for community outreach. They were both thanked by Council for their presentations.

**COUNCIL REPORTS**: Council member Avalos reported on attending the Fresno Fair, and thanked staff for their hard work.

Council member Robertson reported on attending the 100<sup>th</sup> anniversary of St. Joseph's Catholic Church. He also announced that Selma Chamber of Commerce Executive Director Cindy Howell will be retiring in December.

Council member Derr reported on on the progress of the upcoming Best Christmas Play Ever.

Mayor Grey reported on the upcoming events at the Selma Arts Center and the Band Festival Parade.
