#### Rent and Evictions (AB 3088)

- No COVID-19-related evictions until February 1, 2021
- September 1, 2020 January 31, 2021: Must provide declaration of hardship and pay at least 25% of the rent
- Landlords may begin to recover unpaid rent starting on March 1, 2021
- Significantly Increases Penalties on Landlords Who Do Not Follow Court Evictions Process

### Illegal Evictions

Your landlord must obtain a court order to evict you from your rental unit. You are entitled to peaceful possession until the court awards your landlord possession. It is unlawful for your landlord to do any of the following to get you to leave:

- Change your locks
- Turn off your utilities
- Lie to you or to the police about your right to possession of your rental unit
- Harass or threaten to harm you or your family
- Enter your rental unit without your permission
- Threaten to report your immigration status or the status of another occupant, family member or friend
- The civil penalty for each violation is up to \$2,000.

Call the police or the sheriff for help getting in if your landlord changes your locks. Or, you can call a locksmith to change the locks so that you can get in.

If you suspect that your landlord might attempt to evict you unlawfully, carry proof that you live at the address of your rental unit so that you can show the police, sheriff or locksmith that you are entitled to possession. Ideally, you have a written lease to prove your right to possession, but you could show any document addressed to you at the address of your rental unit, including a utility bill, phone bill or credit card bill.



#### When Fresno County moves to RED

- Once we meet the numbers for two weeks and stay in a one week holding period:
- Schools can open for in-person classes (limited)
- More businesses can re-open indoors
  - Places of Worship (25% or 100 people whichever is fewer)
  - Movie Theaters (25%)
  - Restaurants (25 % or 100 people whichever is fewer)
  - Personal Care Services
  - ► Gyms (10% capacity)

### Outdoor Services Only

- Places of Worship
- Wineries (not breweries)
- Gyms and Fitness (dance studios, boxing etc.)
- Offices for non-essential (non-critical infrastructure) sectors
- Personal Care Services (nail salons, body waxing etc)
- Cardrooms/Racetracks
- Zoos and Museums
- Movie Theaters and Family Entertainment Centers



### What <u>is not</u> Open

- Tattoo Parlors
- Bars / Breweries
- Nightclubs
- Concert Venues
- Festivals
- Theme Parks



### Public Input

- Closures feel unfair and enforcement across cities/county not in sync:
  - Big box stores with large customer volume vs. small restaurants and family entertainment establishments
  - Why barbers/hair salons and not nail, massage and other personal services?
  - Small businesses can't sustain extended closures and are starting to close permanently

# What is UCR?





The EDI has gathered crime statistics from law onforcement agencies across the nation that have voluntarily participated in the Unitorm Crime Reporting (UCR) Program since 1930. These data have been published each year, and since 1958, have been available in the publication *Crime in the United States* (*CIUS*). As a supplement to *CIUS*, the FBI, in cooperation with the Bureau of Justice Statistics, provides this site that allows users to build their own customized data tables.

The UCR Program collects statistics on violent crime (murder and nonnegligent manslaughter, rape, robbery, and aggravated assault) and property crime (burglary, larceny-theft, and motor vehicle theft). By congressional mandate, arson was added as the eighth Part I offense in 1979 Arson statistics are not available for access on this site. By using the table building tool, users can specify offenses, locality (city, county, state), and year(s).

#### **Aggravated Assault**

#### Definition

The FBI's Uniform Crime Reporting (UCR) Program defines aggravated assault as an unlawful attack by one person upon another for the purpose of inflicting severe or aggravated bodily injury. The UCR Program further specifies that this type of assault is usually accompanied by the use of a weapon or by other means likely to produce death or great bodily harm. Attempted aggravated assault that involves the display of—or threat to use—a gun, knife, or other weapon is included in this crime category because serious personal injury would likely result if the assault were completed.



- <u>Armed Gang Member Apprehended After Foot Pursuit</u>
- On August 27, 2020, at 9:20 am, a Selma Police police officer was patrolling the shopping center at the southwest corner of Floral and Whitson which has been frequented by transients over the last several weeks. Several have been sleeping on the patio of abandoned business Poke-cubed, 2735 Whitson, and they have received trespass notices by the same officer. The officer made contact with 4 transients on the patio and he recognized Suspect Randy Ramirez, 26 years of age, as a gang member and drug dealer from prior contacts.

- As the officer contacted the transients, Suspect Ramirez immediately ran eastbound through the parking lot and as he ran a loaded 357 revolver handgun fell out of his waistband. The officer chased Ramirez across Whitson and was able to capture him in the parking lot of Circle K. He was immediately handcuffed. Ramirez was processed at the Selma Police Department and was later booked at Fresno County Jail on the following charges:

- Carrying a loaded handgun by a gang member;
- Felony probation violation;
- Possession of controlled substance while armed, and
- Carrying a loaded firearm while not being the registered owner.

### **Gun Arrest During Traffic Stop**

- Today during day shift, a Selma police officer while on a vehicle stop observed a loaded Ruger Taurus .357 revolver on the front seat. After subjects were detained the handgun was found to be stolen out of Fresno.
- Arrested was 32 year old Fernando Salinas of Selma and 25 year old Carmelita Perez Bernal of Selma. Salinas was arrested on charges of PC 3056 VIOLATION OF PAROLE, HS 11364(a) POSSESSION DRUG PARAPHERNALIA, and VC 14601.2(a) DRIVING ON SUSPENDED LICENSE (DUI). Bernal was arrested on charges of PC 25850(c)(3) CARRYING LOADED FIREARM AS A GANG MEMBER, HS 11379(A) TRANSPORT CONTROLLED SUBSTANCE, HS 113701(a) POSS CONTROLLED SUBSTANCE WHILE ARMED W/LOADED FIREARM, PC 25850(C)(6) CARRYING LOADED HANDGUN: NOT REGISTERED OWNER, and PC 25850(C)(2) CARRY LOADED STOLEN HANDGUN.
