A video was presented on the Selma Active Transportation Grant which provides citizens a view of what the City has planned for these grant funds and the option to submit a survey on the projects was also presented. City Manager Gallavan also stated that Pacific Gas & Electric has provided notice of possible power outages and relayed that these notices have been posted on the City's Facebook page requesting citizens to conserve energy and power.

Assistant City Manager Moreno provided updates on current projects.

Fire Chief Petersen provided Strike team updates on out of town assignments.

Police Chief Gomez provided a brief power point presentation on recent arrest made.

Community Services Director Kirchner provided updates on two mural projects and on the cooling center.

COUNCIL REPORTS: Council member Avalos thanked Police Chief Gomez and the department for protecting the City of Selma.

Council member Robertson thanked Police Chief Gomez and his staff for working with other agencies. He also thanked Fire Chief Petersen for sending his personnel on the Strike Team assignments. He thanked Fresno County Board of Supervisor Mendez for his assistance in obtaining the CARES Act money for Selma as well as thanking the City Staff for providing the Surface Pro tablets and providing more efficiency and productivity. He also thanked the Selma Healthcare district for providing funding for the City.

Council member Trujillo provided an update on the SKF meeting he recently attended and thanked Assistant City Manager Moreno on the CIP project updates he provided.

Mayor Pro Tem Guerra provided an update on the recent Five Cities meeting, and stated that they will no longer be called Five Cities it will be called "Center Point" because there are more than five member cities. Mayor Pro Tem Guerra also reiterated the need to address encampment issues as she continues to receive complaints on dumping issues.

Mayor Franco provided an update on the parade held for Axel Santos, an 8 year old cancer patient. He reported on attending a recent meeting with Mr. Dwight Nelson and City Staff, and a meeting with Caltrans Director Diana Gomez. He also reported on storm drain issues throughout the City.

DISCUSSION: Section 36506 of the Government Code of the State of California provides that the City Council shall, by resolution or ordinance, fix the compensation for all appointive officials and employees. Pursuant to Section 570.5 of Title 2 of the California Code of Regulations pay rates must be approved and adopted by the City Council and be publicly available in a salary schedule which identifies the position title, the pay rate for each position, which may be stated as a single amount or as multiple amounts within a range, and that indicates the time base, including, but not limited to, whether the time base is hourly, daily, bi-weekly, monthly, bi-monthly, or annually.

California Public Employees' Retirement System (CalPERS), pursuant to its interpretation of Title 2, California Code of Regulations section 570.5, recommends all CalPERS employers maintain their compensation levels in **one** publicly available document, approved and adopted by the governing body, which meets all of the requirements of Title 2 CCR section 570.5. CalPERS has indicated it may revisit their interpretation of Title 2 CCR section 570.5, however, at this time no documented change to their interpretation has been published. Therefore, in an effort to comply with CalPERS' current recommended interpretation of Title 2 CCR section 570.5 the City's various salary schedules, which have been previously individually approved and adopted by the City Council, have been consolidated into a single salary schedule.

Approval of the attached amended Master Salary Schedule, reflecting the new salary ranges effective March 1, 2021, will fix the compensation for all appointive officers and employees of the City, satisfying Section 36506 of the Government Code of the State of California and California Code of Regulations section 570.5.

RECOMMENDATION: Adopt the Resolution approving the amended Master Salary Schedule for all Employees of the City of Selma.

WHEREAS, the City desires to adopt the amended master salary scheduled attached as Exhibit "A" to this resolution in conformance with Section 36506 of the California Government Code and Title 2, CCR section 570.5.

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

Section 1. The above recitals are true and correct and are incorporated herein by reference.

<u>Section 2.</u> The City Council hereby adopts a single consolidated Master Salary Schedule that meets all of the requirements of Title 2 CCR section 570.5, attached hereto as Exhibit A, and incorporated herein by reference.

MEMORANDUM FROM INTERIM CITY ATTORNEY

February 25, 2021

RE: Mayor and City Council Roles in Appointments to Boards, Commissions, and Committees

This memorandum is offered to provide some guidance to the Mayor and Council as to their respective roles regarding appointments to boards, commissions, and committees.

State Law Governs Appointments in General Law Cities

Government Code section 40605 provides as follows:

In general law cities where the office of mayor is an elective office pursuant to Article 5 (commencing with Section 34900) of Chapter 7 of Part 1 of Division 2 of Title 4, the mayor, with the approval of the city council, shall make all appointments to boards, commissions, and committees unless otherwise specifically provided by statute.

Questions have arisen in other jurisdictions as to the respective authority of the Mayor and the City Council in making appointments. While there is no case law interpreting Government Code section 40605, Attorney General Opinions have been issued that interpret it.

In 1998, the California Attorney General issued 81 Ops. Cal. Atty. Gen. 75 (hereafter 1998 AG Opinion). There, the Attorney General concluded that the process in Section 40605 applies to appointments (i) to regional boards, commissions, and committees, (ii) that a city ordinance requiring that appointments be made by the City Council, and (iii) to subcommittees of a city council.

The Attorney General noted that a city council's authority under Section 40605 may not be construed "to direct the mayor to appoint a particular person to a board, commission, or committee." It further reasoned: "Where section 40605 applies, it is the mayor's prerogative to make the appointment and the city council's responsibility to approve or reject the appointment." This quote followed with footnote 4 stating in part: "In this respect, section 40605 is similar to the 'advice and consent' provision of the United States Constitution."

A city does not have legal authority to adopt an alternative selection process by ordinance or resolution that is inconsistent with state law. See the 1998 AG Opinion.

Statutory Selection Under Section 40605

The general rule under Government Code section 40605 is not applicable where the State legislature has adopted statutes governing the process (per the language at end of the section which states "unless otherwise specifically provided by statute"). As explained by the Attorney General in the 1998 AG Opinion:

It is to be observed that some regional boards, commissions, and committees do not have their members selected by mayoral appointments, as specified in various state statutes. (See, e.g., Health & Saf. Code, § 40420 [South Coast Air Quality Management District]; Pub. Resources Code, § 29735 [Delta Protection Commission]; Pub. Utilities Code, § 30201 [Southern California Rapid Transit District]; Harb. & Nav. Code, § 16 [San Diego Unified Port District].

For this reason, the statutory selection process would be applicable to bodies such as the Mayors Selection Committee and the Selma-Kingsburg-Fowler County Sanitation District ("SKF").

The Mayors Selection Committee is governed by state law. Government Code Section 50270 provides in part: "The membership of each such city selection committee shall consist of the mayor of each city within the county." Government Code Section 50271(a) further provides: "When the mayor is unable to attend a meeting of a city selection committee, the mayor shall designate another member of the city's legislative body to attend and vote at the meeting as the mayor's representative." Thus, the statutory selection process applies, and the general rule under Government Code section 40605 does not come into play.

This statutory selection process would also be applicable to appointments to the SKF Board. (See email to Mayor and Council dated 2/6/21 and attached to this memo.) The County Sanitation District state legislation provides that the Mayor sits on the SKF Board in the first instance and if the Mayor is absent, unable, or unwilling to attend an SKF Board meeting, the City Council may designate a member of the Council to serve.

Joint Powers Agreements

The general rule under section 40605 is not applicable where controlled by a joint powers agreement. As explained by the Attorney General in the 1998 AG Opinion:

Somewhat unique is a joint powers agency established under the Joint Exercise of Powers Act (§§ 6500-6599.) The composition of an agency's governing body is controlled by the terms of the agreement. (§ 6508; see 78 Ops.Cal.Atty.Gen. 60, 65 (1995); 57 Ops.Cal.Atty.Gen. 295, 301 (1974).) Assuming the agreement does not specify how the selection is to be made, section 40605 requires the mayor to make the appointment subject to the approval of the city council.

Based on this, the general rule under Government Code section 40605 does not apply if the joint powers agreement regulates the selection process. If it does not regulate the process, only then does the general rule under Government Code section 40605 apply.

An example of this would be the joint powers agreement creating the Fresno COG. That agreement provides for by-laws which state that each city will be represented by the "Mayor and in Mayor's absence such councilman as may be present." Based on this, the Mayor is the primary representative and if the Mayor does not attend an alternate may attend.

Summary

The following from the 1998 AG Opinion sums up the general rule regarding the Mayor and Council's respective roles under Government Code section 40605: "We believe, instead, that the Legislature intended to create a system of checks and balances by placing the appointment authority in the hands of the elected mayor, while giving the city council the right to reject mayoral appointments. If a statute or a joint powers agreement addresses the appointments for particular entities, the statutory or agreement language for appointments would need to be followed.

Dear Mayor & Council,

The following is a response to Mayor Robertson regarding an apparent question that was raised at the January 19, 2021, Council meeting. Mayor Robertson asked that I confirm his understanding is correct and share my view with the Council.

Health & Safety Code § 4730.1 provides for the composition of a County Sanitation District's governing body. Relevant to the question at hand is Subsection (a)(2) which states:

(2) If the district includes territory which is within a city, other sanitation district, or public agency, the board of directors shall be composed of the presiding officer of the governing body of each city, other sanitation district, and public agency and the chairman of the county board of supervisors.

Per this language, the Mayor is correct that the Mayor of each member city of SKF sits on the SKF Board.

Health and Safety Subsection (a)(3) of Health and Safety Section 4730.1 addresses the question as to who sits on the Board in the event the Mayor does not. It provides:

(3) The governing body of each county, city, sanitation district, and public agency having a representative on the board of directors may designate one of its members to act in the place of its regular member in his or her absence or his or her inability or refusal to act.

I agree with the Mayor that if the Mayor is absent, unable, or unwilling to attend an SKF Board meeting, then the City Council may designate one of its members to serve on the SKF Board.

Additionally, I note that SKF Resolution No. 1 adopted in April 1970, is consistent with the above.

Please let me know if you need additional information regarding this matter.

4730.

The governing body of a sanitation district is a board of directors of not less than three members. The presiding officer of the governing body of each city, the whole or part of which is included in the sanitation district, is a member of the board. A member of the governing body of each sanitary district, the whole or part of which is included in the sanitation district, is a member of the board.

If the sanitation district includes territory which is unincorporated and not included in a sanitary district, then the presiding officer of the county board of supervisors is a member of the board.

The governing body of each city with a population of under 2,500,000, as found by the latest census, and the board of supervisors shall each select one of its members, other than its presiding officer, as an alternate director to act as a member of the district board in place of the presiding officer, or in place of the other member of the governing body of the city or county where there are two members from the city or county on the board of directors of the district, during such person's absence, inability, or refusal to act.

The presiding officer of the governing body of a city with a population of 2,500,000 or over shall select one of the other members of the governing body as an alternate director to act as a member of the district board in place of the presiding officer, or in place of the other member of the governing body of the city where there are two members from the city on the board of directors of the district, during such person's absence, inability, or refusal to act. The governing body of each sanitary district represented on the board of directors of a sanitation district shall select one of its members as an alternate director to act as a member of the district board in place of its regular director, or in place of the other member of the governing body of the sanitary district where there are two members from the sanitary district on the board of directors of the district, during such person's absence, inability, or refusal to act.

If the sanitation district includes unincorporated territory and all or part of one city and no sanitary district, or unincorporated territory and one sanitary district and no city, then the presiding officer and one other member of the board of supervisors are members of the board, unless the population included in the city or sanitary district is more than half of the population of the whole sanitation district, in which case the presiding officer of the board of supervisors and the presiding officer and one other member of the governing body of the city or two members of the governing body of the sanitary district, as the case may be, constitute the board of directors.

If the total number of cities and sanitary districts included in the sanitation district in whole or in part is two and if the sanitation district does not include any territory not in cities or sanitary districts, then the district board includes the presiding officer and one other member of the governing body of the city or two members of the governing body of the sanitary district having the greatest population and the presiding officer of the governing body of the city or one member of the governing body of the sanitary district having the least population.

If the total number of cities and of sanitary districts wholly or in part within the sanitation district is two or more, and if, in addition, the district contains unincorporated territory, then the district board includes the presiding officer of the board of supervisors, the presiding officer of the governing board of each city, and a member of the governing board of each sanitary district.

If the district includes no territory which is in cities or sanitary districts, then the county board of supervisors is the board of directors of the district.

If the territory of the district lies wholly within a city, the legislative body of said city is the board of directors of the district.

A city within a sanitation district, the sewered portion of which city lies entirely within a sanitary district, shall have no representation on the board.

Notwithstanding the foregoing provisions of this section, whenever a sanitation district includes unincorporated territory and all or part of one city and no sanitary district, the governing body of such city may designate the board of supervisors of the county as the district board of directors, unless the population of the incorporated portion of the sanitation district is more than half of the population of the whole district. If the population of the incorporated portion of the sanitation district is more than half of the population of the whole district, the board of supervisors of the county may designate the governing body of the city as the district board of directors.

The term "sanitary district" as used in this section shall mean a sanitary district formed prior to the formation of the sanitation district in which it is included in whole or in part. The term "sanitary district" as used in this section shall also include a county water district which on or before July 1, 1977, assumed the responsibilities, rights, duties, assets, liabilities, and obligations of a sanitary district which at the time of such assumption had representation on the board of directors of the sanitation district by the provisions of this section.

(Amended by Stats. 1979, Ch. 35.)

4730.1.

- (a) Notwithstanding the provisions of Section 4730, the resolution of intention to form the district and the order of formation of the district may provide that the governing body of the sanitation district shall be constituted in accordance with this subdivision or subdivision (b) or (c).
- (1) If the district includes no territory which is within a city, other sanitation district, or public agency, the county board of supervisors is the board of directors.
- (2) If the district includes territory which is within a city, other sanitation district, or public agency, the board of directors shall be composed of the presiding officer of the governing body of each city, other sanitation district, and public agency and the

chairman of the county board of supervisors. If the chairman of the county board of supervisors and the presiding officer of the governing body of each city, sanitation district, and public agency constitute an even number, a member of the county board of supervisors appointed by the board of supervisors or, in the alternate as determined by the board of directors, a resident of the district elected by the registered voters of the district for a four-year term, shall be a member of the board of directors of the district.

- (3) The governing body of each county, city, sanitation district, and public agency having a representative on the board of directors may designate one of its members to act in the place of its regular member in his or her absence or his or her inability or refusal to act.
- (4) The governing body of any city, sanitation district, or other public agency may designate a member of the county board of supervisors to serve as its representative member on the board of directors of the district in the place of the presiding officer of its governing body; in that case, the supervisor shall have one vote for each city, sanitation district, and public agency represented by him or her.
- (b) (1) The board of directors may be composed of directors who are residents of the district elected by the registered voters of the district for four-year terms.
- (2) The number of directors on an elected board shall be determined, subject to the requirements of Section 4730 and subdivision (c), by the board of directors of the district, if any, in existence prior to the election.
- (c) (1) In the Arvin Sanitation District in Kern County only, if no board of directors is in existence prior to the election, the county board of supervisors shall determine, subject to the requirements of Section 4730 and subdivision (d), the number of directors on an elected board.
- (2) The district shall reimburse the county for any reasonable costs incurred by it for the conduct of elections required by this subdivision.
- (d) The governing body of a sanitation district is a board of directors composed of an odd number of not less than three members.
- (e) "Public agency" as used in this section means any sanitary district, public utility district, resort district, county water district, municipal water district, sewer maintenance district, or county maintenance district, engaged in the collection, transportation, treatment, or disposal of sewage or any other public agency empowered to, and engaged in, the collection, transportation, treatment, or disposal of sewage.

EIGHTH AMENDMENT TO FRESNO COUNCIL OF GOVERNMENTS JOINT POWERS AGREEMENT

This eighth amendment to the Fresno Council of Governments' Joint

Powers Agreement ("JPA") is made and entered into by and between the County
of Fresno, a political subdivision of the State of California, and the Cities of
Fresno, Clovis, Coalinga, Firebaugh, Fowler, Kerman, Kingsburg, Mendota,
Orange Cove, Parlier, Reedley, Huron, Sanger, San Joaquin, and Selma all
being municipal corporations of the State of California (hereinafter collectively
referred to as "the member agencies").

WHEREAS, the member agencies entered into a JPA creating the Fresno Council of Governments ("FCOG") on March 25, 1976 and thereafter amended such JPA on seven separate occasions; and

WHEREAS, the FCOG and its member agencies desire to amend the FCOG JPA for an eighth time to allow the County of Fresno, Board of Supervisors to decide which of its members will represent the County of Fresno on the FCOG.

NOW, THEREFORE, the member agencies agree as set forth below:

- Chapter 1 <u>Organization</u>, section 1.21 <u>Council</u>, shall be deleted in its entirety and replaced with the following:
- "1.21 <u>Council</u>: The Council shall be the governing body of the Council of Fresno County Governments. The Council shall be composed of one member of the County of Fresno Board of Supervisors, or in his absence such supervisor as

may be present, and the mayors of the member cities, or in a mayor's absence such councilman as may be present."

- All other provisions of the FCOG not in conflict with this Amendment shall remain in full force and effect.
- This Amendment shall take effect upon its execution by the authorized signatories of the legislative bodies of the requisite number of member agencies.

JOINT POWERS AGREEMENT FOR COUNCIL OF FRESNO COUNTY GOVERNMENTS

THIS AGREEMENT entered into this 24th day of September 1969 is made by and among the incorporated cities of Clovis, Coalinga, Firebaugh, Fresno, Kerman, Kingsburg, Mendota, Orange Cove, Parlier, Reedley, Huron Sanger and Selma all being municipal corporations of the State of California and located within the boundaries of the County of Fresno, California, and the County of Fresno, a body politic and corporate and subdivision of the State of California, as follows:

WHEREAS, Sections 6500 et. seq. of the California Government Code
(Title 1, Division 7, Chapter 5, Article 1) provide for agreements
between two or more public agencies to jointly exercise any power
common to the contracting parties; and

WHEREAS, the City of Fresno by virtue of its charter, and other incorporated cities and the county, parties hereto, by virtue of Sections 65600 and 65604, inclusive of the California Government Code have the joint and mutual power to create an "area planning commission" (herein designated "Council of Fresno County Governments"); and

WHEREAS, the parties hereto recognize that the County of Fresno with its included incorporated cities has been designated by the Bureau of the Census as a standard metropolitan area, and is experiencing continuing expansion of its incorporated cities and the extensive development of the formerly undeveloped areas; and

WHEREAS, by reason of this growth, governmental problems affecting corporated and unincorporated areas jointly are frequently arising and are expected to increase in the near future; and WHEREAS, it is necessary and desirable that a single agency be created with authority to:

- Provide a forum for discussion and study of regional problems of mutual interest to the governments in Fresno County.
- Insure through cooperation and the pooling of common resources, maximum efficiency and economy in governmental operations which will provide every citizen with the utmost value for every tax dollar.
- Uncover, clarify, identify and comprehensively
 plan for the solution of regional problems requiring multi-city and county cooperation.
- Develop regional plans and policies for urban growth and development.
- 5. Facilitate agreements among the governmental units for specific projects or other interrelated developmental actions or for the adoption of common policies with respect to problems which are common to its members.
- Attain the greatest degree of intergovernmental cooperation possible in order to prepare for future growth and development of Fresno County.
- Carry out such other area-wide functions as the membership shall deem appropriate; and

WHEREAS, creation of such an agency, and action by it upon development projects, appear necessary to qualify the county, its various cities and special public agencies and districts, for allocations of State and Federal funds necessary to carry out such projects;

NOW, THEREFORE, it is agreed as follows:

- 1. The Council of Fresno County Governments is hereby created and established pursuant to the provisions of Section 65600 to 65604, inclusive, of the California Government Code and any amendments or successors to such sections, providing for an "area planning commission", which shall consist of the County of Fresno and each incorporated city within the County of Fresno which has executed this agreement.
- 2. Each member City shall be represented by its Mayor, or, in his absence, by the Mayor Pro-Tempore, or such Councilman as may be designated in writing by the Mayor. The County of Fresno shall be represented by the Chairman of the Board of Supervisors, or, in his absence, the Vice-Chairman, or such Supervisor as may be designated in writing by the Chairman.
- 3. In addition to the incorporated cities mentioned in this agreement, any city not now a member and any other city which may hereafter be incorporated within the boundaries of the County of Fresno and which may desire to participate in the activities of this Council may do so by executing this agreement without prior approval or ratification of the named parties to this agreement and shall thereafter be bound by all of the terms and provisions of this agreement as of the date of execution.
- 4. An organizational meeting of the Council of Fresno County Governments shall be held as soon after this agreement has been executed by all of the parties as is feasible and agreeable to the parties. The organizational meeting shall be

held to decide upon the time, place and dates of ensuing regular meetings and the special meetings, if any, and the method of calling such special meetings, the election of such officers and the employment of such personnel as it shall deem necessary and appropriate, arrangements for additional plans for organizational functions and financing, rules of procedure and any other matters properly before it, organizational or not.

- 5. The undersigned parties to this agreement pledge full cooperation and agree to assign representatives to serve as official members of this organization or any committee or subcommittee thereof who shall act for and on behalf of their cities or the County in any or all matters which shall come before the Council of Fresno County Governments, subject to any necessary and legal approval of their acts by the legislative bodies of the cities and the County.
- This agreement shall take effect upon its execution by the authorized representatives of each of the parties to this agreement.
- 7. Costs incurred by the Council of Fresno County Governments shall be shared on a proportionate basis in the following manner:
 - a. A per capita cost shall be calculated by dividing the total cost by the sum of the total population of member cities and the unincorporated population of Fresno County.
 - b. The County share shall equal the per capita cost times the unincorporated population of Fresno County.

- c. Each member city shall pay an amount equal to the per capita cost times the city's population.
- d. The population figures listed in the latest California Population report published by the California Department of Finance shall be used to determine the per capita cost.
- 8. The powers of the Council shall be advisory only. Nothing herein shall be construed as limiting in any manner the power of any of the respective parties to initiate and complete a local project within their respective jurisdictions with their own funds.
- 9. Any member may, at any time, by resolution or ordinance of its governing body withdraw from the Council. If at any time after the establishment of this Council, less than half of the eligible cities are members, or if the County ceases to be a member, this Council is disestablished.

CITY COUNCIL OF THE CITY OF EL CERRITO PROCLAMATION Recognizing June as LGBT Pride Month in the City of El Cerrito

WHEREAS, the City of El Cerrito has a diverse Lesbian, Gay, Bisexual, Transgender (LGBT) community and is committed to supporting visibility, dignity and equity for all people in the community; and

WHEREAS, many of the residents, students, city employees, and business owners within the City of El Cerrito who contribute to the enrichment of our City are a part of the lesbian, gay, bisexual, transgender, and questioning community; and

WHEREAS, various advancements have been made with respect to equitable treatment of lesbians, gay men, bisexual, transgendered, and questioning persons throughout the nation, but there continues to be some opposition against people from this community and around the world making it important for cities like El Cerrito to stand up and show support for our residents who are affected; and

WHEREAS, several cities across the United States recognize and celebrate June as LGBT Pride Month; and

WHEREAS, June has become a symbolic month in which lesbians, gay men, bisexual people, transgender, and supporters come together in various celebrations of pride; and

WHEREAS, the rainbow flag, also known as the LGBT pride flag or gay pride flag, has been used since the 1970s as a symbol of Lesbian, Gay, Bisexual, Transgender pride and LGBT social movements; and

WHEREAS, flying the rainbow flag at City Hall throughout the month of June further symbolizes the City's celebration of diversity and support for the Lesbian, Gay, Bisexual, Transgender community.

NOW THEREFORE, the City Council of the City of El Cerrito does hereby declare the month of June as LGBT Pride month in the City of El Cerrito, and invites everyone to reflect on ways we all can live and work together with a commitment to mutual respect and understanding, and further, recognizes Pride Month by flying the rainbow flag at City Hall during the month of June.

Official Recognition



RECOMMENDATION City Staff is requesting that this public hearing be taken off calendar due to a change in ownership in the property.

DISCUSSION: Staff became aware that this property was sold by previous owner MG Star LLC, to new owner GEHAM SHARHER F on December 07, 2020. Thus, the abatement process will need to start over with the new owner to ensure compliance with applicable noticing requirements.

RECOMMENDATION City Staff is requesting that this public hearing be taken off calendar as staff will be issuing corrected notices regarding abatement.

Additionally, in consideration that the City may soon have new legal counsel, Staff recommends waiting until a permanent City Attorney has been contracted to move forward with the sign abatement on this property, as well as other properties with similar issues, so that the new City Attorney has an opportunity to advise on the process.
