SUBJECT: Consideration of a Resolution Authorizing the City to Continue with

Teleconferenced Public Meetings Pursuant to Assembly Bill 361

BACKGROUND: On September 16, 2021, the California legislature passed Assembly Bill ("AB") 361, which amends Government Code Section 54953 and permits a local agency to use teleconferencing to conduct its meetings in any of the following circumstances: (A) the legislative body holds a state of emergency, and meeting during a proclaimed state or local officials have imposed or recommended measures to promote social distancing; (B) the legislative body holds a meeting during a proclaimed state of emergency for the purpose of determining, by majority vote, whether as a result of the emergency, meeting in person would present imminent risks to the health or safety of attendees; or (C) the legislative body holds a meeting during a proclaimed state of emergency and has determined, by majority vote, pursuant to subparagraph (B), that, as a result of the emergency, meeting in person would present imminent risks to the health or safety of attendees.

DISCUSSION: In order for the City Council to use teleconferencing as allowed by AB 361 after October 1, 2021, it must first adopt findings in a resolution, allowing the City Council to conduct teleconferenced meetings for a period of thirty (30) days. In addition, AB 361 requires the City to make specified findings every 30 days thereafter. City Council initially approved Resolution No. 2021-57R on September 27, 2021 and subsequently Resolution No. 2021-60R on October 18, 2021, Resolution No. 2021-67R on November 15, 2021, Resolution No. 2021-70R on December 6, 2021, Resolution No. 2021-72R on December 21, 2021, Resolution No. 2022-1R on January 18, 2022, Resolution No. 2022-6R on February 7, 2022, Resolution No. 2022-15R on March 7, 2022, Resolution No. 2022-28R on April 4, 2022, and Resolution No. 2022-38R on May 2, 2022.

RECOMMENDATION: If the City Council wishes to Continue with Remote Teleconference Meetings, the Council should adopt the attached Resolution Authorizing Remote Teleconference Public Meetings by the City Council and Commissions of the City in Accordance with Assembly Bill 361.

RESOLUTION NO. 2022 – __R

A RESOLUTION OF THE CITY OF SELMA, CALIFORNIA AUTHORIZING CONTINUED USE OF REMOTE TELECONFERENCING PROVISIONS (AB 361)

WHEREAS, the City Council of the City of Selma ("City Council") is committed to open and transparent government, and full compliance with the Ralph M. Brown Act ("Brown Act"); and

WHEREAS, the Brown Act generally requires that a public agency take certain actions in order to use teleconferencing to attend a public meeting virtually; and

WHEREAS, the City Council recognizes that a local emergency persists due to the worldwide COVID-19 pandemic; and

WHEREAS, the California Legislature has recognized the ongoing state of emergency due to the COVID-19 pandemic and has responded by creating an additional means for public meetings to be held via teleconference (inclusive of internet-based virtual meetings); and

WHEREAS, on September 16, 2021, the California legislature passed Assembly Bill ("AB") 361, which amends Government Code, section 54953 and permits a local agency to use teleconferencing to conduct its meetings in any of the following circumstances: (A) the legislative body holds a meeting during a proclaimed state of emergency, and state or local officials have imposed or recommended measures to promote social distancing; (B) the legislative body holds a meeting during a proclaimed state of emergency for the purpose of determining, by majority vote, whether as a result of the emergency, meeting in person would present imminent risks to the health or safety of attendees; or (C) the legislative body holds a meeting during a proclaimed state of emergency and has determined, by majority vote, pursuant to subparagraph (B), that, as a result of the emergency, meeting in person would present imminent risks to the health or safety of attendees; and

WHEREAS, in order for the City Council to use teleconferencing as allowed by AB 361 after October 1, 2021, it must first adopt findings in a resolution, allowing the City Council to conduct teleconferenced meetings for a period of thirty (30) days; and

WHEREAS, the City Council initially approved Resolution No. 2021-57R on September 27, 2021; and

WHEREAS, on October 18, 2021, the City Council approved Resolution No. 2021-60R; and

WHEREAS, on November 15, 2021, the City Council approved Resolution No. 2021-67R; and

WHEREAS, on December 6, 2021, the City Council approved Resolution No. 2021-70R; and

WHEREAS, on December 21, 2021, the City Council approved Resolution No. 2021-72R; and

WHEREAS, on January 18, 2022, the City Council approved Resolution No. 2022-1R; and WHEREAS, on February 7, 2022, the City Council approved Resolution No. 2022-6R; and WHEREAS, on March 7, 2022, the City Council approved Resolution No. 2022-15R; and WHEREAS, on April 4, 2022, the City Council approved Resolution No. 2022-28R; and WHEREAS, on May 2, 2022, the City Council approved Resolution No. 2022-38R; and

WHEREAS, Governor Gavin Newsom declared a state of emergency for the State of California due to the COVID-19 pandemic in his order entitled "Proclamation of a State of Emergency," signed March 4, 2020; and

WHEREAS, the California Occupational and Safety Health Administration (OSHA) continues to recommend certain social distancing requirements, as described in detail in California Code of Regulations Title 8, section 3205 Covid Prevention; and

WHEREAS, the Fresno County Department of Public Health supports the well-being of its communities and County residents and recommends ways to slow the spread of COVID-19 including through social distancing (i.e., "staying at least 6 feet (about 2 arm lengths) from others who don't live with you" and by avoiding crowds. The Fresno County Department of Public Health states "[t]he more people you are in contact with, the more likely you are to be exposed to COVID-19."

WHEREAS, the City Council hereby finds that the state and local emergencies have caused and will continue to cause imminent risks to the health or safety of attendees; and

WHEREAS, the City Council is conducting its meetings through the use of telephonic and internet-based services so that members of the public may observe and participate in meetings and offer public comment.

NOW THEREFORE, **BE IT RESOLVED**, that the recitals set forth above are true and correct and fully incorporated into this Resolution by reference.

BE IT FURTHER RESOLVED, that the City Council is conducting meetings during a state of emergency and OSHA recommends measures to promote social distancing; and/or

BE IT FURTHER RESOLVED, that the City Council has determined that given the state of emergency, holding in-person only meetings would present imminent risks to the health or safety of attendees.

BE IT FURTHER RESOLVED, that the actions taken by the City Council through this resolution shall be applied to all City committees governed by the Brown Act unless otherwise desired by that committee.

BE IT FURTHER RESOLVED, the City Council authorizes the City Manager or their designee(s) to take all actions necessary to conduct City Council meetings in accordance with Government Code section 54953(e) and all other applicable provisions of the Brown Act, using teleconferencing for a period of thirty (30) days from the adoption of this Resolution after which the City Council will again reconsider the circumstances of the state of emergency.

DISCUSSION: Each election year, prior to the election, the County Elections Department requires each city to adopt a resolution ordering the election, requesting the County to conduct the election and to consolidate the election, and determining the payment for candidate statements and for the election in general.

In addition, Elections Code Section 10229 provides that if the number of persons nominated for office in an election subject to Elections Code Section 36512 is equal to or does not exceed the number of vacancies the governing body may appoint candidates or qualified electors to office without conducting an election. The following Resolution will meet those requirements.

FISCAL IMPACT: \$25,000 is being requested in the FY 22-23 proposed General Fund budget for this purpose.

RESOLUTION OF THE CITY COUNCIL OF THE CITY OF SELMA CALLING AND GIVING NOTICE OF THE HOLDING OF A GENERAL MUNICIPAL ELECTION TO BE HELD IN SAID CITY ON TUESDAY NOVEMBER 8, 2022, FOR THE ELECTION OF CERTAIN OFFICERS OF SAID CITY AND REQUESTING THE BOARD OF SUPERVISORS OF THE COUNTY OF FRESNO TO CONSOLIDATE AND CANVASS THE GENERAL MUNICIPAL ELECTION TO BE HELD ON NOVEMBER 8, 2022 WITH THE STATEWIDE GENERAL ELECTION TO BE HELD ON THAT DATE PURSUANT TO CALIFORNIA ELECTIONS CODE SECTION 10400 ET SEQ.; TO PERMIT THE COUNTY CLERK/REGISTRAR OF VOTERS OF THE COUNTY OF FRESNO TO RENDER SPECIFIED SERVICES TO THE CITY OF SELMA RELATING TO THE CONDUCT OF SAID GENERAL MUNICIPAL ELECTION PURSUANT TO CALIFORNIA ELECTIONS CODE SECTION 10002; FOR APPOINTMENT TO OFFICE IF NO ONE OR ONLY ONE PERSON IS NOMINATED; AND AUTHORIZING REIMBURSEMENT FUNDS TO PAY FOR SAID SERVICES

WHEREAS, the next Statewide General Election to be held in the County of Fresno will take place on November 8, 2022; and

WHEREAS, the City Selma intends to call and order a General Municipal Election on Tuesday, November 8, 2022, for the election of one District 2 Council member, one District 3 Council member; each for a four year term and one at-large Mayor for a two year term; and

WHEREAS, it is the desire of the City Council of the City of Selma to adopt a Resolution requesting the Board of Supervisors of the County of Fresno to consolidate said election with the Statewide General Election pursuant to Part 3 of Division 10 of the Elections Code of the State of California (commencing with Section 10400) to be held on the same date and that, within the City of Selma, the precincts, vote center locations, ballot drop box locations, and election officers of the two (2) elections be the same; the County Clerk/Registrar of Voters canvass the returns of the General Municipal Election; and the election be held in all respects as if there were only one (1) election; and

WHEREAS, it is the desire of the City Council of the City of Selma to adopt a Resolution requesting the Board of Supervisors of the County of Fresno to render specified services to the City of Selma relating to the conduct of a General Municipal Election pursuant to Section 10002 of the Elections Code of the State of California; and

WHEREAS, Section 10002 of the Elections Code of the State of California requires the City of Selma to reimburse the County of Fresno in full for the services performed upon presentation of a bill to the City of Selma.

WHEREAS, The City Council of the City of Selma has determined that each candidate for elective office who submits a statement to be sent to the voters with the sample ballot shall be charged a sum not greater than the actual prorated cost of printing, handling and translating the candidate's statement, if any incurred by the agency as a result of providing this service.

WHEREAS, that if there is the same or an insufficient number of nominees, the City Council of the City of Selma hereby elects to fill the office by appointment; and

WHEREAS, that the City Clerk is authorized, instructed and directed to coordinate with the County of Fresno Registrar of Voters to procure and furnish any and all official ballots, notices, printed material and all supplies, equipment, paraphernalia that may be necessary in order to properly and lawfully conduct the election and the City Clerk and City Attorney are authorized to make any typographical, clerical, and other non-substantive corrections to this resolution as may be deemed necessary by the Fresno County Clerk/Registrar of Voters.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF Selma as follows:

SECTION 1. A General Municipal Election is called and ordered for the City of Selma to be held on November 8, 2022, for the purpose of the election of one member of the City Council to represent District 2; one member of the City Council to represent District 3, each for a four year term; and an at-large mayor for a two year term.

SECTION 2. Pursuant to the requirements of Section 10403 of the Elections Code of the State of California, the Board of Supervisors of the County of Fresno is hereby requested to consent and agree to the consolidation of the General Municipal Election and the Statewide General Election on November 8, 2022.

SECTION 3. In accordance with the provisions of Section 10403 of the Elections Code of the State of California, the City Council of the City of Selma acknowledges that the consolidated election will be held and conducted in accordance with the provisions of law regulating the Statewide General Election pursuant to Section 10418 of the Elections Code of the State of California.

SECTION 4. The Board of Supervisors of the County of Fresno is requested to direct the County Clerk/Registrar of Voters to take any and all steps necessary for and related to the holding of the consolidated election in a manner consistent with law, including, without limitation: the provision of all election materials and equipment; publication of notices; the hiring, training and supervision of election officers and other election personnel; the printing and distribution of ballot materials; the translation of ballot materials; the collection of submitted ballots; the tallying and canvassing of votes; and the certification of election results.

SECTION 5. Pursuant to Section 10002 of the Elections Code of the State of California, the City Council of the City of Selma authorizes reimbursement to the County of Fresno in full for the services to be performed as herein requested and that said sum be paid to the County of Fresno upon demand and presentation of a bill to the City of Selma.

SECTION 6. The candidate shall, if he/she elects to submit a statement, of no more than 200 words, to be included with the sample ballot and sent to the registered voters, pay all costs associated with said election statement; Pursuant to California Elections Code Section 13307, the candidate is required to make an estimated pre-payment to the County at the time the candidate files the nomination papers.

SUBJECT: Consideration of a Resolution Approving the submittal of an Active

Transportation Program Application for Grant Program Cycle 6

DISCUSSION: The Fresno Council of Governments (Fresno COG) administers the Active Transportation Program which provides grant funds for eligible local agencies for the purposes of increasing the proportion of biking and walking trips, increasing safety and mobility for non-motorized users, advancing the efforts of regional agencies to achieve greenhouse gas reduction goals, enhancing public health and addressing childhood obesity.

The City of Selma has prepared an application for the following project, to be submitted to for the statewide call on June 15, 2022; and consequent consideration at the regional level, as appropriate, including a resolution from the City Council, which is a requirement for consideration at the regional level:

Rose Ave Bike Route and Sidewalk Project. This project will enhance bicycle and pedestrian facilities in the southwest residential and rural area of the City through the construction of 0.38-miles of sidewalk, bike route improvements, and a total seven (7) pedestrian gap closures in sidewalks and intersection facilities addressing a lack of available safe routes to schools. These improvements are identified in the City's Active Transportation Plan, will provide critical access for safe routes to schools, and reduce vehicle miles traveled in a severely disadvantaged community.

RECOMMENDATION: Approve Staff submitting a Cycle 6 ATP Application to Caltrans, and Adopting a Resolution authorizing staff to submit a grant application for the Fresno COG Active Transportation Program Cycle 6 funding (as appropriate), and City Manager to execute the necessary grant documents if funded.

SUBJECT: Consideration of a Resolution Directing the City Engineer to Initiate and Prepare the Fiscal Year 2022-23 Engineer's Report for Landscaping Lighting and Maintenance District No. 1

DISCUSSION: The City established a Landscaping and Lighting Maintenance District ("LLMD") in 1984. The purpose of the district is to pay for landscaping, lighting, and other improvements plus services in a public area. Within the district, zones are established to create areas that benefit from the services provided. Currently there are 10 zones throughout the City.

In order to levy and collect the assessment, the City must go through several steps, the first of which is to adopt a resolution, which describes any proposed new improvements or any substantial changes in existing improvements for the LLMD, and which directs the City Engineer to prepare a report. This report will have the following information pursuant to Streets & Highways Code Section 22567:

- (a) Plans and specifications for the improvements.
- (b) An estimate of the costs of the improvements.
- (c) A diagram for the assessment district.
- (d) An assessment of the estimated costs of the improvements.
- (e) If bonds or notes will be issued pursuant to Section 22662.5, an estimate of their principal amount.

Staff does not anticipate any new improvements or any substantial changes to the existing improvements proposed for the LLMD for Fiscal Year 2022-23.

RECOMMENDATION: Adopt the Resolution directing the City Engineer to prepare the Fiscal Year 2022-23 Engineer's Report for the Landscape Lighting and Maintenance District No. 1.

SUBJECT: Consider approval of Temporary Sign / Banner Permit Application and Fee

Waiver Request from Resident Leslie Nelson

BACKGROUND: On May 2, 2022, the City Council approved revisions to the Selma Municipal Code allowing for the placement of commemorative non-commercial flags on the Selma Arts Center Building for a period no longer than 10 consecutive days, subject to approval by the Deputy City Manager (acting as Community Development Director) or by the City Council upon referral by the Deputy City Manager.

WHEREAS, Leslie Nelson requested that the City Council waive fees associated with its Temporary Sign/Banner Permit and Light Pole Banner Hanging; and

WHEREAS, the adopted City fee for a Temporary Sign/Banner is Two Hundred Thirty-Five Dollars (\$235) and the adopted City fee for Light Pole Banner Hanging is Two Hundred Sixty-Five Dollars (\$265); and

<u>SECTION 2.</u> The City Council hereby approves the fee waiver for fees associated with the Temporary Sign/Banner Permit in the amount of Two Hundred Thirty-Five Dollars (\$235) and Light Pole Banner Hanging in the amount of Two Hundred Sixty-Five Dollars (\$265);

<u>SECTION 3.</u> The provisions of this Resolution are severable and if any provision, clause, sentence, word or part thereof is held illegal, invalid, unconstitutional, or inapplicable to any person or circumstances, such illegality, invalidity, unconstitutionality, or inapplicability shall not affect or impair any of the remaining provisions, clauses, sentences, sections, words or parts thereof of the Resolution or their applicability to other persons or circumstances.

<u>SECTION 4.</u> That the City Clerk shall certify to the adoption of this Resolution and that the same shall be in full force and effect.

SUBJECT:

Consider authorizing the Selma City Manager to execute a Landowner Deposit Agreement with KB Home South Bay Inc. relating to a proposed Community Facilities District for proposed Vesting Tentative Tract Map 6019

BACKGROUND: Residential builder KB Home is proposing to build 243 homes as part of a 315-lot subdivision on the north side of Dinuba Ave between Thompson Ave and Shaft Ave under proposed Vesting Tentative Tract Map 6019. The map is currently undergoing Planning Department review and will be considered for approval by the Selma Planning Commission at a later time.

While the map is in process, KB Home would like to begin the feasibility process of establishing a Community Facilities District (CFD), also known as a Mello-Roos District, which would potentially fund the construction of the sewer main upgrade along Dinuba Ave. necessary to serve the proposed project. Property owners within the CFD boundaries would be assessed a special tax for a specified amount of time until the bonds issued to fund construction of the sewer main are repaid.

DISCUSSION: City staff is proposing to enter into a Landowner Deposit Agreement (Exhibit A) with KB Home South Bay Inc. in order to ensure that the feasibility analysis and CFD formation process is fully funded by the Developer and/or proceeds of the CFD bonds. The required deposit amount is capped at \$100,000, which is the estimated amount of funding required to reach a point where the CFD is formed and bonds can be issued (i.e. the "Initial Costs").

This agreement does not commit the City to forming a CFD and approving a bond issuance. Rather, it ensures that sufficient funds are deposited by the Developer during the CFD feasibility and formation process, thus ensuring that any costs the City incurs for advisors, legal counsel, engineering, and other technical and professional services are not funded by the City's general funds.

The initial required deposit is \$5,000, which will fund a Fiscal Impact Analysis to be presented to the City Council for review. The Council would then decide whether to move forward with the CFD formation process.

FISCAL IMPACT: None.

RECOMMENDATION: Staff recommends that the City Council authorize, by motion, the City Manager to execute the Landowner Deposit Agreement with KB Home South Bay Inc.

EXHIBIT A

LANDOWNER DEPOSIT AGREEMENT

1. <u>PARTIES AND DATE</u>:

THIS LANDOWNER DEPOSIT AGREEMENT (the "Agreement") is made and entered into as of _______, 2022, by and among the CITY OF SELMA, a legally constituted governmental entity, hereinafter referred to as the "City", and KB HOME South Bay Inc., a California corporation, hereinafter referred to as "Developer".

2. RECITALS

- 2.1 The City Council of the City (hereinafter the "City Council") proposes to establish Community Facilities District No. 2022-1 (the "District") pursuant to the provisions of the Mello-Roos Community Facilities Act of 1982, as amended, commencing with Section 53311 of the Government Code of the State of California, hereinafter referred to as the "Act". The boundaries of proposed District are depicted on the map attached hereto and incorporated herein as Exhibit A.
- 2.2 Developer has entered into a purchase and sale agreement to acquire approximately 60+ gross acres of land within the District (the "Property"). If it acquires the Property, Developer anticipates developing the Property for, among other things, residential use (the "Project").
- 2.3 The District is proposed to be formed for the purpose of funding the construction or acquisition of certain authorized sewer backbone infrastructure facilities (including incidental expenses related to the design, construction completion and inspection of said facilities) needed to develop the Property all as authorized by the Act (collectively the "Authorized Facilities").
- 2.4 Developer and the City wish to provide for the financing of the construction and for acquisition of all or a portion of the Authorized Facilities through the formation of the District and the issuance of bonds thereof (the "Bonds"), which Bonds shall be secured by special taxes to be levied on real property within the District.
- 2.5 Developer and the City wish to provide for the payment of the City's expenses in connection with the formation of the District.

3. AGREEMENT

3.1 Proceedings Deposit and Developer Contribution. The Developer has deposited the initial amount of Five Thousand Dollars (\$5,000) (the "Proceedings Deposit") with the City to cover the costs of a fiscal impact analysis of the Project and proposed District (the "Fiscal Impact Analysis"). It is expected that the Fiscal Impact Analysis will be presented to the City Council. Developer may elect to terminate this Agreement within five (5) business days after the Fiscal Impact Analysis is presented to, and acted on by the City Council for review. Developer hereby confirms that the cost of the Fiscal Impact Analysis will be \$5,000.

If Developer does not terminate this Agreement within such five-day period, any time the balance of the Deposits falls below \$1,000, the City expects to incur additional costs and Bonds are not expected to be issued within the next 30 days, then the City shall notify the Developer either by telephone or in writing prior to incurring such costs and shall provide a written statement to the Developer itemizing the costs incurred to date. Upon Developer's acknowledgement of such notice, the City, on behalf of the District, shall make written demands within thirty (30) days thereafter for additional deposits, each of which shall not exceed \$15,000. The Proceeding Deposit, together with all additional deposits (collectively, the "Deposits") required from Developer shall not, under any circumstances, exceed \$100,000. The Deposits

are to be used to pay for any costs incurred for any authorized purpose in connection with the issuance of the Bonds including, but, not limited to, (i) the fees and expense of any consultants to the City employed in connection with the formation of the District, issuance of the Bonds, including the engineer, special tax consultants, municipal advisor, bond and disclosure counsel and any other consultant deemed necessary or advisable by the City, (ii) the costs of appraisals and feasibility studies and other reports deemed necessary or advisable by the City in connection with issuance of the Bonds, (iii) the costs of publication of notices, preparation and mailing of ballots and other costs related to any hearing, election or other action or proceeding undertaken in connection with the issuance of Bonds, (iv) reasonable charges for City Staff time incurred in connection with the issuance of Bonds, including a reasonable allocation of City overhead expense directly related thereto, and (v) any and all other actual costs and expenses incurred by the City in connection with the issuance of the Bonds (collectively, the "Initial Costs"). Developer shall not be required to make Deposits in excess of a total of \$100,000. The City may draw upon the Deposits from time to time to pay the Initial Costs. If Developer fails to make any advance of funds for the formation of the District within the 30-day period described above, the City on behalf of the District may suspend all proceedings until Developer advances the amounts demanded. The City shall provide Developer with a written summary of expenditures made from the Deposits, and the unexpended balance thereof, within thirty (30) days from receipt of written request submitted by the Developer, provided that the City shall not be required to provide a summary of expenditures more frequently than one time each quarter. The cost of providing any such summary of expenditures shall be charged to the Deposits. If the Bonds are issued, the City shall reimburse the Developer, without interest, for the portion of the Deposits that have been expended or encumbered, said reimbursement to be made within thirty (30) days after the issuance of such Bonds, solely from the proceeds of such Bonds and only to the extent otherwise permitted under the Act. The City shall, within thirty (30) days after the issuance of such Bonds, return the then unexpended and unencumbered portion of the Deposits to the Developer, without interest.

Nothing herein shall act as a limitation on the City seeking reimbursement for the reasonable and customary costs it incurs in connection with the formation of the District and the issuance of Bonds in an amount in excess of the Deposits from the costs of issuance proceeds provided by the Bond issuance.

3.2 Termination. If for any reason including, but not limited to, (i) failure of the qualified electors within the District to approve the proposed special tax to be levied thereon, (ii) court action or proceeding challenging the City's compliance with the California Environmental Quality Act, (iii) a regulation, decision or order of a State or Federal regulatory agency, (iv) a voter imposed moratorium or restriction on development or the issuance of building permits which affects development of Property, or (v) the insolvency or bankruptcy of the Developer, or any such matter, the City is unable to complete the formation of proceedings of the District and issue and sell the Bonds, then the City shall, within thirty (30) days after action by the City to terminate such proceedings, return any unexpected portion of the Deposits to the Developer. The City shall not be obligated to return any portion of the Deposits which have been spent by the City for the purpose set forth in Section 3.1 hereof. The Developer may, for any reason, terminate this Agreement by written notice to the City in which case the City may pay from the Deposits any Initial Costs incurred prior to the receipt of such notice and return the remainder of the Deposits to Developer. If, at the time of termination of this Agreement, total reasonable and customary costs incurred, as agreed on by the City and Developer, exceed the total of Deposits received by the City from Developer, Developer shall reimburse the difference to the City within 15 days of termination of this Agreement. Notwithstanding the previous sentence, under no circumstances will Developer's obligation to reimburse City under this section 3.2 (Termination) exceed \$100,000; however, the City will not be prevented from seeking reimbursement for reasonable and customary costs it incurs in connection with

the formation of the District and the issuance of Bonds in an amount in excess of the Deposits from the costs of issuance proceeds provided by the Bond issuance.

- 3.3. <u>Assignment</u>. This agreement or any right or duty hereunder may be assigned by either the City or the Developer.
- 3.4 <u>Mutual Assistance and Cooperation</u>. The City and Developer will assist one another mutually in the formation of the District, the formation of special taxes to be levied within the District and the issuance of Bonds. Both parties will mutually assist one another in otherwise undertaking and furthering the goals and objectives set forth in the Agreement.
- 3.5 Notice. Any notice, payment or instrument required or permitted by this Agreement to be given or delivered to either party shall be deemed to have been received when (a) personally delivered, (b) if given by electronic communication, whether by email or telecopier upon the sender's receipt of an appropriate answer back or other written acknowledgement, (c) if given by registered or certified mail, return receipt requested, deposited with the United States mail postage prepaid, 72 hours after such notice is deposited with the United States mail, (d) if given by overnight courier, with courier charges prepaid, 24 hours after delivery to said overnight courier, or (e) if given by any other means, upon delivery at the address specified in the this Section, addressed as follows:

Each party can change its address for delivery with notice by delivering written notice of such change of address to the other party within twenty (20) days of such change.

3.6 <u>Severability</u>. If any part of this Agreement is held to be illegal or unenforceable by a court of competent jurisdiction, the remainder of this Agreement shall be given effect to the fullest extent reasonably possible.

- 3.7 <u>Binding on Successors and Assigns</u>. This Agreement shall be binding upon and inure to the benefit of the heirs, successors-in-interest and assigns of the parties hereto.
- 3.8 Entire Agreement. This Agreement contains the entire agreement between the parties with respect to the matters provided for herein. There are no oral or written representations, understandings, undertakings or agreements which are not expressly referred to or contained herein, and any such representations, understandings, undertakings or agreements are suspended by this Agreement. No evidence of any such representations, understandings, undertakings or agreements shall be admissible and any proceeding of any kind or nature relating to the terms and conditions of this Agreement shall be limited to the premises and agreements set forth herein.
- 3.9 <u>Amendments</u>. This Agreement may be amended or modified only in writing signed by both parties.
- 3.10 <u>Governing Law</u>. This Agreement and any dispute arising hereunder shall be governed by and interpreted in accordance with the laws of the State of California.
- 3.11 <u>Usage of Words</u>. As used herein, the singular of any word includes the plural, and terms in the masculine gender shall include the feminine.
- 3.12 No Third Party Beneficiaries. Except as may be specifically provided herein to the contrary, no third party shall be the express or implied beneficiary of this Agreement or any of its provisions, no such third party may bring action at law or equity with respect hereto.
- 3.13 <u>Venue and Form</u>. Any action at law or in equity arising under this agreement brought by any party hereto for the purpose of enforcing, construing or determining the validity of any provision of this Agreement shall be filed and tried in the Superior Court of the County of Fresno, State of California, and the parties waive all provisions of law providing for the filing, removal or change of venue to any other Court.
- 3.14 <u>Counterparts</u>. This Agreement shall be executed in counterparts, all of which shall be deemed original.

This Agreement and any exhibits, amendments or renewals hereto may be executed in a number of counterparts, and each counterpart signature, when taken with the other counterpart signatures, it treated as if executed upon one original of this Agreement or any amendment or renewal. A signature by any party to this Agreement provided facsimile or electronic mail (including scanned signatures) is binding upon that party as if it were the original.
