# **<u>RECOMMENDATION:</u>** Staff recommends that Council approve the resolution authorizing the City to continue with teleconferenced public meetings pursuant to Assembly Bill 361.

**DISCUSSION:** On September 16, 2021, the California legislature passed Assembly Bill ("AB") 361, which amends Government Code Section 54953 and permits a local agency to use teleconferencing to conduct its meetings in any of the following circumstances: (A) the legislative body holds a state of emergency, and meeting during a proclaimed state or local officials have imposed or recommended measures to promote social distancing; (B) the legislative body holds a meeting during a proclaimed state of emergency, meeting in person determining, by majority vote, whether as a result of the emergency, meeting in person would present imminent risks to the health or safety of attendees; or (C) the legislative body holds a meeting during a proclaimed state of emergency, meeting in person would present to subparagraph (B), that, as a result of the emergency, meeting in person would present imminent risks to the health or safety of attendees.

In order for the City Council to use teleconferencing as allowed by AB 361 after October 1, 2021, it must first adopt findings in a resolution, allowing the City Council to conduct teleconferenced meetings for a period of thirty (30) days. In addition, AB 361 requires the City to make specified findings every 30 days thereafter. City Council initially approved Resolution No. 2021-57R on September 27, 2021 and subsequently Resolution No. 2021-60R on October 18, 2021, Resolution No. 2021-67R on November 15, 2021, Resolution No. 2021-70R on December 6, 2021, Resolution No. 2021-72R on December 21, 2021, and Resolution No. 2022-1 on January 18, 2022.

WHEREAS, on September 16, 2021, the California legislature passed Assembly Bill ("AB") 361, which amends Government Code, section 54953 and permits a local agency to use teleconferencing to conduct its meetings in any of the following circumstances: (A) the legislative body holds a meeting during a proclaimed state of emergency, and state or local officials have imposed or recommended measures to promote social distancing; (B) the legislative body holds a meeting during a proclaimed state of emergency for the purpose of determining, by majority vote, whether as a result of the emergency, meeting in person would present imminent risks to the health or safety of attendees; or (C) the legislative body holds a meeting during a proclaimed state of the emergency, meeting in person would present in to subparagraph (B), that, as a result of the emergency, meeting in person would present imminent risks to the health or safety of attendees; and

**WHEREAS**, in order for the City Council to use teleconferencing as allowed by AB 361 after October 1, 2021, it must first adopt findings in a resolution, allowing the City Council to conduct teleconferenced meetings for a period of thirty (30) days; and

**WHEREAS**, the City Council initially approved Resolution No. 2021-57R on September 27, 2021; and

WHEREAS, on October 18, 2021, the City Council approved Resolution No. 2021-60R; and

**WHEREAS**, on November 15, 2021, the City Council approved Resolution No. 2021-67R; and

WHEREAS, on December 6, 2021, the City Council approved Resolution No. 2021-70R; and

WHEREAS, on December 21, 2021, the City Council approved Resolution No. 2021-72R; and

WHEREAS, on January 18, 2022, the City Council approved Resolution No. 2022-1R; and

**WHEREAS**, Governor Gavin Newsom declared a state of emergency for the State of California due to the COVID-19 pandemic in his order entitled "Proclamation of a State of Emergency," signed March 4, 2020; and

**WHEREAS**, the California Occupational and Safety Health Administration (OSHA) continues to recommend certain social distancing requirements, as described in detail in California Code of Regulations Title 8, section 3205 Covid Prevention; and

**WHEREAS**, the Fresno County Department of Public Health supports the well-being of its communities and County residents and recommends ways to slow the spread of COVID-19 including through social distancing (i.e., "staying at least 6 feet (about 2 arm lengths) from others who don't live with you" and by avoiding crowds. The Fresno County Department of Public Health states "[t]he more people you are in contact with, the more likely you are to be exposed to COVID-19."

**WHEREAS**, the City Council hereby finds that the state and local emergencies have caused and will continue to cause imminent risks to the health or safety of attendees; and

**WHEREAS**, the City Council is conducting its meetings through the use of telephonic and internet-based services so that members of the public may observe and participate in meetings and offer public comment.

**NOW THEREFORE**, **BE IT RESOLVED**, that the recitals set forth above are true and correct and fully incorporated into this Resolution by reference.

**BE IT FURTHER RESOLVED**, that the City Council is conducting meetings during a state of emergency and OSHA recommends measures to promote social distancing; and/or

**BE IT FURTHER RESOLVED**, that the City Council has determined that given the state of emergency, holding in-person only meetings would present imminent risks to the health or safety of attendees.

**BE IT FURTHER RESOLVED**, that the actions taken by the City Council through this resolution shall be applied to all City committees governed by the Brown Act unless otherwise desired by that committee.

**BE IT FURTHER RESOLVED**, the City Council authorizes the City Manager or their designee(s) to take all actions necessary to conduct City Council meetings in accordance with Government Code section 54953(e) and all other applicable provisions of the Brown Act, using teleconferencing for a period of thirty (30) days from the adoption of this Resolution after which the City Council will again reconsider the circumstances of the state of emergency.

**SUBJECT:** Award the Contract for the Community Development Block Grant (CDBG) Project No. 19651 Sidewalk Connectivity Project to Witbro, Inc. DBA Seal Rite Paving and Grading

#### **<u>RECOMMENDATION</u>**:

Staff recommends the City Council adopt a Resolution awarding the contract for the CDBG Project No. 19651 Sidewalk Improvement Project between Floral Avenue, Rose Avenue. McCall Avenue and Orange Avenue using CDBG funding to Witbro, Inc. DBA Seal Rite Paving and Grading, in the amount of \$278,217.15, approve a contingency of 10% of the contract amount equal to \$27,800.00, and authorize the City Manager to sign the Agreement with Witbro, Inc. DBA Seal Rite Paving and Grading.

**DISCUSSION:** The County of Fresno receives an annual allocation of Community Development Block Grant (CDBG) grant funds from the federal government Department of Housing and Urban Development (HUD). The County makes a portion of these grant funds available to each of its participating cities based on the same HUD formula by which the County receives its funding. Each City participating in the County's CDBG program is invited to submit activity proposals for its portion of CDBG grant funds. The five participating cities include the cities of Fowler, Kerman, Kingsburg, Reedley and Selma.

On November 29, 2021, The City of Selma received approval of a time extension until July 22, 2022 for the Notice of Completion to be recorded and until September 20, 2022 for the final invoice and closeout documents to be submitted for the Selma Sidewalk Connectivity Project, CDBG Project No. 19651; Agreement No 19-595.

The Sidewalk Connectivity Project will construct new concrete sidewalk, concrete drive approaches, ADA compliant concrete curb ramps and replace existing storm drain inlets. The City received \$229,198.00 in CDBG funds and the City will use local funds for the remaining portion of construction for the project.

Bids were received from seven (7) contractors on Friday, January 7, 2022. The lowest responsive and responsible bidder was Witbro, Inc. DBA Seal Rite Paving and Grading, with a Bid in the amount of \$278,217.15. The Engineer's Estimate was \$275,000.00.

Bids were received from seven (7) contractors and the results were as follow:

**SUBJECT:** Fresno Council of Governments (COG) Call for Projects for Congestion Mitigation and Air Quality Improvement Program (CMAQ) and Surface Transportation Block Grant (STBG) Targeted Performance Program (TPP) Applications

#### **RECOMMENDATION:** Staff recommends the following:

- 1. City Council approve the project list proposed by staff.
- 2. City Council adopt Resolution supporting and implementing AB 1012 "timely use of funds" on federal-aid projects.

**EXECUTIVE SUMMARY**: Fresno COG has called for the Targeted Performance Program (TPP) applications for federally-funded transportation projects for the 2022-2026 fiscal years. The TPP is a non-competitive application that the City submits utilizing any unused funding the City has received annually for the Surface Transportation Block Grant Program (STBG) and Congestion Mitigation and Air Quality Improvement (CMAQ) program.

**BACKGROUND**: COG administers federal funding for local transportation projects. A portion of the funding is set aside for the "Targeted Performance Program (TPP)" and "Regional Bid" funding allocations for the two following funding programs:

- 1. Surface Transportation Block Grant Program (STBG) Typical roadway paving and rehabilitation projects.
- 2. Congestion Mitigation and Air Quality Improvement (CMAQ) program -Projects that reduce traffic congestion and air pollution.

The amount of unused funding available for TPP projects for the City of Selma is \$1,749,315.00 for STBG projects and \$1,082,167.00 for CMAQ projects.

Project applications for the Targeted Performance Program projects are to be submitted by February 25, 2022, for both CMAQ applications and STBG applications, and a Council resolution supporting and implementing AB 1012 "timely use of funds" (see attachment 1) was required with both applications. AB 1012 has been enacted into State Law in part to provide for the "timely use" of State and Federal funding and failure for not meeting project delivery dates for any phase of a project may jeopardize Federal or State funding to the Region. STBG projects are required to be on collector and arterial streets - local street projects are not eligible. CMAQ funds may be used for any transportation project within

the local agency's jurisdiction as long as there is a reduction in air pollution which results from the project.

Some of these projects were submitted for the competitive regional project list for both STBG and CMAQ, but Selma was not awarded any funding in the regional bid. With that, the City will resubmit the same projects or the same projects with slight variations that were submitted with the regional bid for both the STBG and CMAQ TPP applications.

Staff has developed a list of candidate projects to submit for funding consideration. The proposed projects are listed in order of proposed priority of each program, with current estimates of costs. Please note that these estimates are preliminary at this point and will be refined prior to submittal of the applications. Attachment 2 shows the locations and proposed limits of the various projects:

# STBG Targeted Performance Program Project List

#### 1. <u>Dinuba Avenue Street Improvements – Between McCall Avenue and Garfield Street (Dockery</u> <u>Avenue (if funds allow) – \$900,000</u>

Reconstruction of new pavement and street maintenance can be funded through the STBG program if the existing streets are maintenance projects.

#### 2. <u>Dinuba Avenue Street Improvements – Between McCall Avenue and Thompson Avenue –</u> <u>\$860,000</u>

Reconstruction of new pavement and street maintenance can be funded through the STBG program if the existing streets are maintenance projects.

# CMAQ Targeted Performance Program Project List

1. <u>Merced-Stillman-Tulare Alley Improvements – Alley segments between Merced and Tulare Streets</u> from McCall Avenue to Wright Street – \$300,000-\$500,000

Installation of new pavement and valley gutter can be funded through the CMAQ program if the existing alleys are unpaved because it is considered a particulate matter reduction project.

#### 2. <u>Chestnut-Gaither-Merced Alley Improvements – Alley segments between Floral and Merced Streets</u> from McCall Avenue to Wright Street - \$300,000-\$500,000

Installation of new pavement and valley gutter can be funded through the CMAQ program if the existing alleys are unpaved because it is considered a particulate matter reduction project.

#### 3. <u>Park and Ride Parking Lot – Lot to be located in the vacant dirt lot between Mill Street, 3<sup>rd</sup> Street,</u> <u>Grove Street and Orange Avenue - \$300,000-\$400,000</u>

Installation of a Park and Ride parking lot can be funded through the CMAQ program if there is a continuation of ridesharing and van-pooling promotion activities.

#### 4. <u>Nebraska Avenue Sidewalk Connectivity Project – Sidewalk segment at the southeast corner of</u> <u>Mitchell Avenue and Nebraska Avenue - \$160,000 (If funding is available)</u>

Installation of new sidewalk can be funded through the CMAQ program if the there are no existing sidewalks because it is considered a particulate matter reduction project.

# STBG and CMAQ TPP Funds

The applications for TPP projects are due February 25, 2022, for both STBG and CMAQ.

# **REASON FOR RECOMMENDATION:**

# <u>CMAQ</u>

The City of Selma has specified a goal of paving all unpaved alleys and CMAQ funds are a valuable funding source in meeting this goal. The City has been systematically paving alleys based on Staff recommendations regarding alleys with the most significant dust issues, problems with trash pickup, as well as Public Works maintenance time. The alleys selected for this application would complete the alley paving projects between Floral Avenue to the north, Rose Avenue to the south, Orange Avenue to the east and Wright Avenue to the west. Staff is looking at completing future alley paving projects with CMAQ funds in the area between Whitson Avenue to the north, Freeway 99 to the south, McCall Avenue to the east and Thompson Avenue to the west. Staff believes that this would address the large block areas with unpaved alleys. Staff is also recommending using these CMAQ funds to create a Park and Ride parking lot in the center of downtown to promote carpooling. If there are any available CMAQ funds, Staff is also recommending a sidewalk infill project along Nebraska Avenue to promote pedestrian traffic.

# <u>STBG</u>

The City of Selma has specified a goal of maintaining and resurfacing existing streets and STBG funds are a valuable funding source in meeting this goal. The City has been systematically maintaining streets based on the pavement management system and based on Staff recommendations regarding streets with the most significant maintenance issues. The street segment selected for this application would fall under the STBG requirements of maintaining arterial or collector streets. Staff believes that this would address a high-volume street for east-west traffic for the City of Selma and continue to maintain streets based on recommendations from Public Works and confirmed by the pavement management system for streets most in need of maintenance.

# FISCAL IMPACT:

All of the Federal Highway projects require a local match of 11.47% from local Gas Tax, Measure C and/or Transportation Funds. The proposed projects would be programmed for future fiscal years which allow time to plan for the expenditures beyond that which has already been planned.

# **ACTIONS FOLLOWING APPROVAL:**

- 1. Staff will prepare the CMAQ and STBG applications and submit them to Fresno COG by February 25, 2022, per the approved project list.
- 2. Staff will include the Resolution supporting and implementing AB 1012 "timely use of funds" with the applications.

#### **RECOMMENDATION:** Staff recommends the following:

- 1. City Council approve the project list proposed by staff.
- 2. City Council adopt Resolution supporting and implementing AB 1012 "timely use of funds" on federal-aid projects.

**SUBJECT:** Consideration of a Resolution Waiving Fees for Temporary Rental of Pioneer Village Main Building to Fresno County Department of Public Health for COVID-19 testing

**BACKGROUND:** At the December 2, 2020 City Council meeting, the City Council approved allowing the Fresno County Department of Public Health to occupy the Main Building at Pioneer Village for COVID-19 testing. Subsequently, at the April 19, 2021 City Council meeting, the Council extended this agreement along with a fee waiver for COVID-19 vaccinations at the Senior Center. The County now requests an extension from the City to continue COVID-19 testing through September 30, 2022 at Pioneer Village at no cost to the County. The County began operating mobile vaccine units during the summer of 2021 and no longer requires the Senior Center.

**DISCUSSION**: The current rental agreement with the City of Selma is a temporary use agreement with the County. The County anticipates continued use of Pioneer Village for testing through September 30, 2022 A Certificate of Insurance from the County of Fresno naming the City of Selma as Additional Insured is on file with the City, as well as an approved Facility Rental Form. The County has contracted janitorial services to provide daily cleaning for Pioneer Village, including the public restrooms.

The County uses the Pioneer Village Main Building from Tuesdays through Saturdays between 7:00 a.m. and 7:00 p.m. Days and times may vary based on testing demand.

The estimated total rentals and utility costs which would be waived for use of Pioneer Village would be approximately \$4,928.00.

**SUBJECT:** Consider Adoption of a Resolution Approving and Authorizing the City Manager to Execute a Memorandum of Understanding between the City of Selma and Boys & Girls Club of Fresno County-Selma Club Regarding City Funding

**BACKGROUND**: With the approval of the Fiscal Year 2021-2022 Budget, funding was authorized for several Community Based Organizations (CBO). Council also directed that appropriate Memoranda of Understanding (MOU) be executed with CBOs setting forth various terms and conditions relative to the allocation of City funds in support of these organizations.

**DISCUSSION**: The Boys & Girls Club of Fresno County-Selma, a CBO, is approved to receive financial assistance from the City during Fiscal Year 2021-2022. Consistent with Council's direction, staff is requesting approval of the MOU attached to the Resolution as Exhibit A and authorization for the City Manager to execute the agreement on behalf of the City. As directed, the MOU includes various provisions surrounding the receipt of City funding, including a requirement for quarterly and year-end reporting of activities associated with the use of City funding.

Although the City Council has approved funding for the Boys & Girls Club in an amount not to exceed \$38,188, it did so pending execution of a MOU. As a result, no funding has been distributed to this organization. Once the MOU has been approved and executed, the City Manager will release funds accordingly.

The funding request for the Boys & Girls Club is for operating expenses, including salaries and overhead. The salaries are for direct services and do not include any administration oversight or implementation of City funding.

**RECOMMENDATION:** Adopt the attached Resolution Approving and Authorizing the City Manager to Execute a Memorandum of Understanding between the City of Selma and Boys & Girls Club of Fresno County-Selma Club Regarding City Funding.

#### MEMORANDUM OF UNDERSTANDING

#### Selma Boys & Girls Club

This Memorandum of Understanding ("MOU") is made and entered into this \_\_\_\_\_ day of \_\_\_\_\_, 2022, ("Effective Date") by and between the City of Selma, a municipal corporation (the "City") and Boys & Girls Clubs of Fresno County-Selma Club are collectively referred to herein as the "Parties" and individually as "Party."

#### **RECITALS**

WHEREAS, the City Council has appropriated funds from the general fund to assist with financing programs deemed to be necessary to meet the social needs of the population of the city, including, but not limited to, the areas of health, social interaction and youth development; and

**WHEREAS,** the City allocated \$38,188.00 to Boys & Girls Clubs of Fresno County-Selma Club to maintain and improve essential services; and

WHEREAS, Boys & Girls Clubs of Fresno County-Selma Club has additional funding to maintain and improve essential services, including, but not limited to, a variety of programs and services for all residents, youth development services and programs; health and awareness; educational and development programs; and

WHEREAS, on July 6, 2021 the City Council approved this funding request submitted by Boys & Girls Clubs of Fresno County-Selma Club in the amount of \$38,188.00 through June 30, 2022; and

WHEREAS, City and Boys & Girls Clubs of Fresno County-Selma Club desire to enter into an agreement which set forth each party's rights responsibilities regarding the expenditure of General Fund dollars allocated to Selma Boys & Girls Club; and

#### **AGREEMENT**

NOW, THEREFORE, for and in consideration of the mutual covenants contained herein, the City and the Boys & Girls Clubs of Fresno County-Selma Club agree as follows:

1. <u>City Obligations:</u>

CITY will provide Boys & Girls Clubs of Fresno County-Selma Club with an amount not to exceed \$38,188.00 for the purpose of paying operating costs and expenses associated with the Boys & Girls Clubs of Fresno County-Selma Club services, programs and community resources for the community.

- 2. Boys & Girls Clubs of Fresno County-Selma Club Obligations:
  - A. <u>General Requirements</u>. Boys & Girls Clubs of Fresno County-Selma Club will provide programs and services in order to better serve the community and expand on youth development services.
  - B. <u>Quarterly and Final Reports</u>. Boys & Girls Clubs of Fresno County-Selma Club will provide quarterly and final reports to CITY as set forth in Exhibit A.
  - C. <u>General Obligation</u>. Boys & Girls Clubs of Fresno County-Selma Club agrees to continually seek additional funds, grants, donations, etc. to reduce of offset the need for CITY General Fund assistance.
- 3. <u>Term:</u>

This MOU shall begin on July 1, 2021 and shall remain in full force and effect until June 30, 2022, unless sooner terminated as provided herein:

- 4. <u>Termination</u>:
  - A. <u>Breach of Contract</u>. If, in the opinion of CITY, Boys & Girls Clubs of Fresno County-Selma Club fails to adequately fulfill its obligations hereunder, with the time limits specified herein, or otherwise fails to comply with the terms of the MOU, or violates any ordinances, regulation or other law applicable to it performance herein, CITY may terminate the MOU immediately, upon notice.
  - B. <u>Without Cause</u>. CITY may terminate the MOU without cause upon thirty (30) days advance written notice to Boys & Girls Clubs of Fresno County-Selma Club. Such notice shall state the effective date of the termination.
  - C. <u>Compensation Upon Termination</u>. In the event this MOU is terminated, Boys & Girls Clubs of Fresno County-Selma Club shall be entitled to compensation for uncompensated expenses incurred pursuant to the terms and conditions of this MOU through and including the effective day of such termination. However, this provision shall not limit or reduce any damages owed to CITY due to a breach of this MOU by Boys & Girls Clubs of Fresno County-Selma Club.

#### 6. Indemnification:

- A. Indemnification Under this MOU. Boys & Girls Clubs of Fresno County-Selma Club shall indemnify, hold harmless, and defend the City, its officers, officials, agents, employees and volunteers from and against any liability (including liability for claims, suits, actions, arbitration proceedings, administrative proceedings, regulatory proceedings, losses, expenses or costs of any kind, whether actual, alleged or threatened, including legal counsel fees and costs, court costs, interest, defense costs, and expert witness fees), where the same arise out of, are a consequence of, or are in any way attributable to, in whole or in part, this MOU. In the event the City, its officers, employees, agents and/or volunteers are made a party to any action, claim, lawsuit, or other adversarial proceeding arising from the this MOU, and upon demand by City, Boys & Girls Clubs of Fresno County-Selma Club shall have an immediate duty to defend the City at Boys & Girls Clubs of Fresno County-Selma Club cost or at City's option, to reimburse the City for its costs of defense, including reasonable attorney's fees and costs incurred in the defense of such matters.
- **B.** The Parties understand and agree that the laws of the State of California shall govern the rights, obligations, duties, and liabilities of the parties to this MOU and also govern the interpretation of this MOU. Any litigation concerning this MOU shall take place in the municipal, superior, or federal district court in Fresno County, California. If any action at law or suit in equity is brought to enforce or interpret the provisions of this MOU, or arising out of or relating to this MOU, the

prevailing party shall be entitled to reasonable attorneys' fees and all related costs, including costs of expert witnesses and consultants, as well as costs on appeal, in addition to any other relief to which it may be entitled.

- C. This MOU contains the entire understanding between the Parties relating to the obligations of the Parties described in this MOU. All prior or contemporaneous agreements, understandings, representations, and statements, oral or written and pertaining to the subject of this MOU or with respect to the terms and conditions of this MOU, are merged into this MOU and shall be of no further force or effect. Each Party is entering into this MOU based solely upon the representations set forth herein and upon each Party's own independent investigation of any and all facts, such Party deems material.
- **D.** If any term or provision of this MOU or the application thereof to any person or circumstance shall, to any extent, be invalid or unenforceable, then such term or provision shall be amended to, and solely to, the extent necessary to cure such invalidity or unenforceability, and in its amended form shall be enforceable. In such event, the remainder of this MOU, or the application of such term or provision to persons or circumstances other than those as to which it is held invalid or unenforceable, shall not be affected thereby, and each term and provision of this MOU shall be valid and be enforced to the fullest extent permitted by law.
- **E.** This MOU may be executed in multiple counterparts, each of which shall be deemed an original, but all of which taken together shall constitute one and the same instrument.
- **F.** The captions appearing at the commencement of the sections hereof, and in any paragraph thereof, are descriptive only and shall have no significance in the interpretation of this MOU.

The waiver by City or Boys & Girls Clubs of Fresno County-Selma Club of any breach of any term, covenant or condition herein contained shall not be deemed to be a waiver of such term, covenant or condition or of any subsequent breach of the same or any other term, covenant or condition herein contained. No term, covenant or condition of this MOU shall be deemed to have been waived by City or Boys & Girls Clubs of Fresno County-Selma Club unless in writing.

**G.** Each right, power and remedy provided for herein or now or hereafter existing at law, in equity, by statute, or otherwise shall be cumulative and shall be in addition to every other right, power, or remedy provided for herein or now or hereafter existing at law, in equity, by statute, or otherwise. The exercise, the commencement of the exercise, or the forbearance of the exercise by any Party of any one or more of such rights, powers or remedies shall not preclude the simultaneous or later exercise by such Party of any of all of such other rights, powers or remedies.

**H.** The person or persons executing this MOU on behalf of each Party represents and warrants that he/she has the authority to execute this MOU on behalf of that Party and has the authority to bind that Party to the performance of its obligations hereunder.

#### 7. Insurance Requirements:

This MOU shall not be executed by CITY, and Boys & Girls Clubs of Fresno County-Selma Club is not entitled to any rights hereunder, unless certificates of insurance and letter of endorsement that the following provisions have been complied with, are filed with CITY.

a. Boys & Girls Clubs of Fresno County-Selma Club shall obtain and maintain General Liability insurance, including Sexual Abuse and Molestation coverage, with limits no less than Two Million Dollars (\$2,000,000) per occurrence and Two Million Dollars (\$2,000,000) aggregate

b. . The certificate of insurance shall be accompanied by an Additional Insured Endorsement, including the City of Selma, its officers, officials, agents, employees and volunteers as additional insureds.

#### 8. Relationship of Parties:

It is understood that this MOU is by and between two (2) independent entities and is not limited to, and shall not be construed to, create the relationship of agent, servant, employee, partnership, joint venture, or any other similar association. Both parties further agree that Boys & Girls Clubs of Fresno County-Selma Club shall not be entitled to any benefits to which CITY employees are entitled, including, but not limited to, overtime, retirement benefits, leave benefits or worker's compensation. Boys & Girls Clubs of Fresno County-Selma Club shall be solely responsible for the acts or omissions of its agents, officers, employees, assignees and subcontractors.

9. Compliance with Applicable Laws and Licensure Requirements:

Boys & Girls Clubs of Fresno County-Selma Club agrees to comply with all local, state and federal laws and regulations applicable to Boys & Girls Clubs of Fresno County-Selma Club hereunder. Boys & Girls Clubs of Fresno County-Selma Club further agrees to comply with all applicable local, state and federal licensure and certification requirements, including, but not limited to employees and adults working directly with you and fingerprints on file, etc.

**IN WITNESS WHEREOF**, the City and Boys & Girls Clubs of Fresno County-Selma Club have caused this Memorandum of Understanding to be executed as of the Effective Date.

#### Please provide a description of proposal for which you are seeking funding.\_\_\_\_

The Boys & Girls Clubs of Fresno County has maintained a Club in Selma located in the Salazar Center at 1800 Sheridan Street. The Club is located in one of the most underserved areas of Selma. We serve youth, ages 6-18. We provide positive activities every day after school and during the summer months.

We focus on 3 core area's that provide 1. Academic assistance – homework help and mentoring; 2. Character and Leadership - teaching youth to become responsible citizens and develop leadership skills in youth-led projects, and 3. Healthy Lifestyles – teaching youth to avoid risky behaviors including gang activity, drug and alcohol abuse, etc. and engage in social recreation and physical activities.

We opened this Club in April of 2016 with the invaluable support and investment of funding from both the City of Selma and the Selma Health Care District. The Club is open 4 hours per day after school with 96 members and an average attendance of 18 kids per day

We are requesting \$ 38,188 in funding to support our Club operations and for the purpose of paying operating costs and expenses associated with the services, programs and community resources we provide to the City of Selma.

How are you developing a plan for sustainability, including diversification of funding sources, in order for your proposal to go on without reliance on future City funds

The cost to operate the Club is approximately \$72,000 per year. Each year we have been faced with the challenges of minimum wage being raised a \$1.00 for each of the past 6 years per staff member.

We constantly seek additional grant funds to support our operations. We had also put together a fund-raising committee but when COVID pandemic began all of those plans were set aside because of the CDC requirements for social distancing. However we were able to keep the Club open and operating for kids to come after school and during the summer months, even when the schools were closed during that time. We developed safety protocols and kept kids safe at the Club.

We have been able to secure some grant funds from Fresno County Law Enforcement asset forfeiture funds, some funding from the federal Payment Protection program, funding from the Selma Health Care District. We also plan to resurrect our fundraising events as soon as it is safe to gather again in groups. We do have individual donors and sponsors who have contributed to the efforts to sustain the Club also.

## If your organization is awarded funds, how will you use them to leverage additional grants, contributions or community support?

We have been trying to leverage funding each year....with donors, grantors and private foundations. We ask for matching support and request funds from individuals, local businesses, and the Selma Health Care District to keep the Club going. These are future employees that are coming to the Club.

By demonstrating good behaviors, graduation rates, and avoiding the juvenile system, youth are proving that individual mentorship and emotional support from Club staff are making a positive difference in the community of Selma; and is worthy of investment in their futures. We request

funds to help sustain the operations and the work that we have provided in developing youth's positive behaviors and motivation.

We have appreciated the support of the Selma City Council, the Selma Health Care District, and the City Police Department, Parks and Recreation, and other City officials in their belief and engagement with the Selma Boys & Girls Club. Thank you for your consideration of this proposal.



**SUBJECT:** Redistricting - Third Public Hearing to Receive Input from the Community Regarding Proposed Draft District Maps, Composition of District Boundaries, and Communities of Interest

#### **RECOMMENDATION:**

1. Receive a report regarding the final Census data and proposed draft district maps;

2. Open the public hearing to receive input from the community regarding the composition of district boundaries and the draft maps;

3. Identify a preferred map or map(s), and provide direction on any revisions to the draft maps;

4. Alternatively, discuss and take other action related to this item.

**SUMMARY:** The California Elections Code requires that every ten years cities with by-district election systems use new census data to review and, if needed, redraw district lines to reflect how local populations have changed. This process, called redistricting, ensures all districts have nearly equal population. The redistricting process for the City of Selma must be completed by April 17, 2022. This is the third of four required hearings for the current process.

#### **BACKGROUND AND DISCUSSION:**

The purpose of this public hearing is to:

1. Inform the City Council and the public about the final 2020 Census data;

2. Inform the City Council and public how this information affects the redistricting process;

3. Review proposed draft maps and Receive feedback from the City Council and the community relative to the draft maps.

4. Identify a preferred map or map(s) and provide direction on any revisions to the draft maps.

#### Publication and Noticing Requirements for Redistricting Hearings

Per Elections Code Section 21608(c) and 21608(g)(3), the City is required to publish the hearing date, time and location 5 days in advance on the internet and a website calendar satisfies the publishing requirement. On January 19, 2022, the public hearing information was published to the City's website calendar. Additionally, to increase public participation, the City has utilized a number of different engagement tools, including posting redistricting information on social media platforms, distributing information via email, and placing ads on our digital billboards. The notice of public hearing was posted in the Selma Enterprise on January 26, 2022, as well as the dedicated redistricting website page.

#### Mapping Tools and Public Participation Kits

California's new "FAIR MAPS Act" has significantly changed the criteria for mapping compared to the rules when Selma first went through the districting process. The City's demography consultant, National Demographics Corporation (NDC), provided the mapping tools needed to empower residents to review draft maps and to develop and submit their own map proposals. These tools were made available in both English and Spanish.

**Caliper Corporation's "Maptitude Online Redistricting" (MOR)** tool is a professional and powerful online mapping tool allowing residents to develop and submit detailed district map proposals.

**Paper-and-Excel-based Public Mapping Tools**, also known as "Public Participation Kits," were made available as an avenue for public participation. While online mapping tools are very popular, the City does not want to exclude those residents who do not have internet access or who simply prefer not to draw maps online. The first, and simplest, Kit is a one-page map showing streets, city borders, and population counts. Residents draw the map they wish to propose and add up the population counts by hand until they get the right population count in each district. The second form of offline mapping tool is for those residents who do not want to deal with an online mapping tool, but who are already comfortable with Microsoft Excel. NDC provides a similar simple one-page map of those same "Population Units," but this time the map shows the Unit ID number rather than the population count in that Unit. Residents then enter their preferred district assignment for each Population Unit into the pre-formatted Excel spreadsheet, and Excel calculates the total population and demographics of each District. When the resident has the map the way they like it, they simply email in the Excel file.

#### **Census Data and Analysis**

On September 20, 2021, the State of California posted the prisoner-adjusted 2020 Census data per Elections Code 21003. For all cities, these figures are deemed to be the final numbers to balance in the redistricting process (Elections Code Section 21603(a)). NDC processed these numbers and analyzed them with respect to the current districts used in the City of Selma.

#### Next Steps

1. Consider any revisions to the draft maps and maps presented from members of the public;

2. Identify a preferred map for adoption;

3. Direct staff to bring back an Ordinance for future City Council consideration to adopt a new Council District Map to conform with the California "FAIR MAPS Act."

Please note that direction should be given prior to opening the public hearing. The date of the next hearing (Public Hearing No. 4) is currently scheduled for March 21, 2022 at 6:30 p.m. The redistricting process for the City of Selma must be completed by April 17, 2022.

FISCAL IMPACT: There is no fiscal impact associated with holding this third hearing.

# **SUBJECT:** Consider adoption of a Resolution Approving Side Letter Agreements with the Police Mid-Management Employees and the International Association of Firefighters Local 3716; and Approving the Master Salary Schedule Reflecting Changes in Job Classifications and Pay Rates

**RECOMMENDATION:** Adopt the attached Resolution Approving Side Letter Agreements with the Police Mid-Management Unit and the International Association of Firefighters Local 3716; and Approving the Master Salary Schedule Reflecting Changes in Job Classifications and Pay Rates.

**BACKGROUND:** Section 3500, et al, of the California Government Code requires the City and recognized employee representation units to meet and confer over hours, wages, and terms and conditions of employment, including the addition, deletion, reclassification, and compensation of positions covered by recognized representation units.

Pursuant to Government Code Section 3500, et al, and your Council's direction on January 18, 2022, City representatives have met and conferred with four (4) representation units regarding the addition of new job classifications, the reclassification of existing job classifications, and corresponding pay rates. Presently, we have reached tentative agreements with two (2) representation units. The tentative agreements are attached to the resolution before you today as Exhibits A and B. The affected bargaining units are:

- Police Mid-Management Unit (Exhibit A)
- International Association of Firefighter Local 3716 (Exhibit B)

City representatives continue to meet and confer with the remaining two (2) representation units with the goal of reaching tentative agreements over the next several weeks. The remaining representation units include the Misc. Mid-Management Unit and the Secretarial, Technical, and Clerical Unit.

In addition, pursuant to Section 36506 of the California Government Code, the City Council shall by Resolution or Ordinance fix the compensation of all appointive officers and employees. Also, pursuant to 570.5 of Title 2 of the California Code of Regulations, pay rates for City employees must be approved and adopted by the City Council in accordance with requirements of public meeting laws and be publicly available in a salary schedule which identifies position titles, pay rates, and the time base of compensation including whether the time base is hourly, daily, bi-weekly, monthly, bi-monthly, or annually. Furthermore, the California Public Employees' Retirement System (CalPERS), requests all CalPERS contracted employers to list their compensation levels in one document, approved and

adopted by the governing body, in accordance with Title 2 of the California Code of Regulations. Consequently, the City Council has adopted a Master Salary Schedule listing all job classifications approved by the City Council including corresponding pay rates and the time base of compensation. The last update to the Master Salary Schedule was January 18, 2022, Resolution NO. 2022 – 5R.

The Resolution before you today would approve the Side Letter Agreements identified as Exhibits A and B and approve changes to the Master Salary Schedule, attached to the resolution as Exhibit C, reflecting the negotiated changes in job classifications, corresponding pay rates, and the time base of compensation.

**DISCUSSION:** Over the past several months, the City Manager has assessed operations and workload priorities within the City Manager's Office, the Finance/Treasurer Department, the Community Development Department, the Police Department, and the Fire Department. The remaining City department will also be evaluated leading up to the 2022-2023 budget deliberations. In addition, over the next several months, the City Manager will conduct a comprehensive salary survey of all job classifications to assess the City's ability to recruit and retain qualified employees.

The City Manager tentatively proposes the addition of ten (10) new job classifications and their corresponding hourly/monthly pay rates, the reclassification of two (2) existing positions, and pay rate adjustments for two (2) existing job classifications. These actions are recommended to better meet departmental workload and operational priorities and enhance the City's ability to recruit new employees. All proposed job classification and pay rate changes require meeting and conferring with the four (4) representation units listed above relative to hours, wages, and terms and conditions of employment.

The recommended actions before you today represent tentative agreements with two (2) representation units regarding one (1) new job classification and one (1) pay rate adjustment for an existing job classification. City representatives will continue to meet and confer with the affected bargaining units regarding the remainder of the proposed new job classifications and pay rate changes. We are not recommending specific position allocations at this time. We anticipate discussion of position allocations and fiscal impact in March 2022, as part of the second-quarter budget update/adjustment review once we have a more detailed report on revenues and expenditures.

It is also recommended that your Council approve the corresponding changes to the Master Salary Schedule, as reflected on Exhibit C, to reflect the new job classification and pay rate changes resulting from negotiations with the Police Mid-Management Unit and the International Association of Firefighters Local 3716.

The recommended new job classification, position reclassification, and pay rate changes are discussed below by affected department and representation unit:

# Police Department:

- Approve the side letter agreement with the Police Mid-Management Unit, Exhibit A, adding the following new job classification and its corresponding wage rate:
  - Supervising Safety Dispatcher (\$4,296.00 to \$5,223.00 Monthly Rate)
- <u>Reclassify one (1) vacant Safety Dispatcher II position (\$20.38 to \$24.78 Hourly Rate)</u> to Supervising Safety Dispatcher.

The Supervising Safety Dispatcher will supervise staff and operations of the Police Department Communications Dispatch Center. This action was approved on July 1, 2021, with adoption of the FY 2021-2022 budget. No new position allocation is required since an existing funded vacant position is being reclassified. The maximum salary cost for this position for the remainder of the fiscal year is \$4,283.00. Due to the number of vacant Safety Dispatcher positions, this cost will be absorbed within existing appropriations. No new appropriations are required. There is no impact to the General Fund.

• Modify the Master Salary Schedule to reflect the above actions.

# Fire Department:

• <u>Approve the side letter agreement with the International Association of Firefighters</u> <u>Local 3716, Exhibit B, increasing the starting hourly rate of pay for the Non-Safety</u> <u>EMT job classifications to \$15.00 per hour</u>

This action is necessary due to the increase in the state minimum hourly rate of pay to \$15.00, effective January 1, 2022. The cost associated with this action was approved in the FY 2021-2022 budget. In addition, there are sufficient funds in the Ambulance Fund budget to cover the cost of this action. No new appropriations are required. There is no impact to the General Fund.

• Modify the Master Salary Schedule to reflect the above action.

## Fiscal Impact:

As discussed above, the recommended actions will be funded through existing appropriations within the General Fund and the Ambulance Fund, and no new appropriations are required at this time. We will have a more thorough discussion of the fiscal impact associated with all recommended job classification and pay rate actions, including those presented today and those being negotiated with affected representation units, during the second-quarter budget update/adjustment review in March 2022.

**RECOMMENDATION:** Adopt the attached Resolution Approving Side Letter Agreements with the Police Mid-Management Unit and the International Association of Firefighters Local 3716; and Approving the Master Salary Schedule Reflecting Changes in Job Classifications and Pay Rates.

# ITEM NO: 4.

**SUBJECT:** Consider Extending the Stay of Enforcement regarding the Removal of an Illegal On-Premise Advertising Display at 1630 2<sup>nd</sup> Street

**<u>RECOMMENDATION</u>**: Direct City staff to move forward with the City's abatement of the illegal on-premise advertising display or to extend the stay of enforcement of abatement for an additional period of time.

#### **BACKGROUND:**

On September 20, 2021, the Selma City Council unanimously voted to declare an abandoned sign located at 1630  $2^{nd}$  Street a public nuisance. The owner was ordered to abate the nuisance by removing the illegal on-premise advertising display.

After a public hearing was held on November 1, 2021 to consider objections to the City Council's direction to City staff to remove the illegal advertising display, the Council voted to adopt Resolution No. 2021-63R ordering the City removal of the display. Additionally, the Council directed staff to stay enforcement of the abatement for a period of 90 days to give the property owner additional time to make progress on his planned development project at the site. The property owner had recently paid the planning application fees for his project, but had not submitted a completed application as needed by the Planning Division to adequately assess the proposed project.

Since the November 1<sup>st</sup> public hearing, the property owner has not submitted a completed project application, though Planning staff has been in contact with the property owner and his project engineer. No significant additional progress has been made on the project.

At this time, staff requests Council's direction to move forward with the City's abatement of the illegal on-premise advertising display or to extend the stay of enforcement of abatement for an additional period of time. If the Council directs staff to move forward with the abatement, the City shall remove the display utilizing City forces, or a contractor will be retained by the City to do so, and the cost of such removal shall be assessed against the Property as a lien which will remain on the Property until paid in full pursuant Selma Municipal Code Section 8-5-8 and California Business and Professions Code §5499.1 et. seq.

WHEREAS, the sign is an illegal advertising display within the meaning of Business and Professions Code §5499.1 because it is an on-premises advertising display that was legally erected, but has ceased to be used to identify or advertise any ongoing business, and has not been used for that purpose for a period of not less than 90 days prior to October 16, 2020; and

WHEREAS, on November 2, 2020 the City Council of the City of Selma did conduct and continue a public hearing to December 7, 2020 pursuant to Business and Professions Code §5499.2 to determine whether the sign was an illegal on-premises advertising display and a public nuisance; and

WHEREAS, on December 7, 2020 the City Council of the City of Selma did conduct the continued public hearing pursuant to Business and Professions Code §5499.2 to determine whether the sign was an illegal on-premises advertising display and a public nuisance and continued the public hearing to January 19, 2021; and

WHEREAS, on January 19, 2021 the City Council of the City of Selma did conduct the continued public hearing pursuant to Business and Professions Code §5499.2 to determine whether the sign was an illegal on-premises advertising display and a public nuisance and continued the public hearing to March 15, 2021; and

WHEREAS, on March 15, 2021 the City Council of the City of Selma did conduct the continued public hearing pursuant to Business and Professions Code §5499.2 to determine whether the sign was an illegal on-premises advertising display and a public nuisance and continued the public hearing to May 17, 2021; and

WHEREAS, on May 17, 2021 the City Council of the City of Selma did conduct the continued public hearing pursuant to Business and Professions Code §5499.2 to determine whether the sign was an illegal on-premises advertising display and a public nuisance and continued the public hearing to July 19, 2021; and

WHEREAS, on July 19, 2021 the City Council of the City of Selma did conduct the continued public hearing pursuant to Business and Professions Code §5499.2 to determine whether the sign was an illegal on-premises advertising display and a public nuisance; and

WHEREAS, on September 20, 2021 the City Council of the City of Selma did conduct the continued public hearing pursuant to Business and Professions Code §5499.2 to determine whether the sign was an illegal on-premises advertising display and a public nuisance and voted unanimously

to adopt Resolution 2021-56R declaring the illegal advertising display at 1630 2<sup>nd</sup> Street a public nuisance and ordering the sign abatement and removal; and

WHEREAS, on November 1, 2021 the City Council of the City of Selma did conduct a public hearing to consider objections to the City Council's direction to City staff to remove the illegal advertising display.

#### NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

1. The forgoing recitals are true and correct and incorporated herein as though fully set forth at this point.

2. The advertising display located on the Property identified in this Resolution is an illegal on-premises advertising display as defined by Business and Professions Code §5499.1 and a public nuisance, and the property owner has failed to abate the nuisance by removing the illegal onpremises advertising display located on the Property.

3. Pursuant to Selma Municipal Code Section 8-5-8 and California Business and Professions Code §5499.1 et. seq., the City shall remove the advertising display utilizing City resources, or a contractor retained by the City to do so, and the cost of such removal shall be assessed against the Property as a lien which will remain on the Property until paid in full.
