#### SWEARING IN CEREMONY- CITY MANAGER FERNANDO SANTILLAN

City Manager Fernando Santillan took the Oath of Office from City Clerk Rivera. City Manager Santillan introduced his family, and a prayer was said in his honor. Mayor Robertson called for a recess for the public to congratulate City Manager Santillan.

**RECESS**: At 6:17 p.m., Mayor Robertson called for a short break in the meeting. The meeting then reconvened at 6:24 p.m.

Prior to Consent Calendar, Mayor Robertson moved to Item 2, for a Public Hearing, which is to be heard at a specific date and time.

Item 2: Redistricting - Third Public Hearing to Receive Input from the Community Regarding Proposed Draft District Maps, Composition of District Boundaries, and Communities of Interest

Shalice Tilton, NDC Consultant gave the staff report and explained the maps of redistricting. She explained and showed four different maps and explained the changes to the districts. She will return on March 21, 2022, to adopt the redistricting map chosen.



**BACKGROUND:** Currently, the Fire Division Chiefs are assigned to a 40-hour per week work schedule. As such, their MOU stipulates that they accrue vacation hours according to that schedule, with 8 hours equaling one day of vacation.

**DISCUSSION:** As the Fire Department has grown over the past several years, it has become necessary to assign a Division Chief to each shift. This will provide for the safety and accountability of the twelve to fifteen fire and EMS personnel that are on duty each day. It will mean that the Division Chief's will switch from a 40-hour workweek to the same 48/96 schedule that all of our other firefighters work. With Council's recent approval of the third Division Chief position, the fire department will be able to implement this change in the coming months. This schedule change requires the approval of a side letter that addresses vacation hours accrued in the current MOU to be the same as other fire department employees working the 48/96 schedule; whereas, 24 hours equals one day of vacation.
