

NEW EMPLOYMENT OPPORTUNITIES EMPLOYMENT PROGRAM (NEO)

The County of Fresno Department of Social Services (DSS) and Fresno County Economic Development Corporation are committed to developing employment opportunities for residents, and meeting the workforce needs of businesses throughout the County. Through a number of strategies, including the County's NEO Program, DSS offers assistance to employers who hire DSS Welfare-to-Work clients.

The following services are available to employers for DSS clients hired:

- Employee recruitment
- Employee screening, including reimbursement for drug testing and background checks
- Specialized employee training
- Employee retention services, including support and engagement of clients, reimbursement for uniforms, equipment, transportation and child care
- Wage subsidies up to one year depending on the needs of the DSS client
