A roll call confirmed those Committee members who were present, which included Committeeman Ronald Heston, Committeewoman Elizabeth Rossell, Deputy Mayor William Raftery, and Mayor Michael Mikulski. Committeeman James F. Young, Sr. was present remotely.

Mayor Mikulski opened the meeting the public.

Kathy Agolio, 54 Gramercy Place – Thanked Kathy Hoffman and Public Works for the clearing the eyebrow on Gramercy Place. Inquired about the planting of trees and bushes on Main Street.

Mary Goudy, 794 Westminster Drive North– Asked the Committee to listen to the concerns of traffic in Leisuretowne.

Evie Doherty, 56 Stratford Road – Compliments to Committeeman Young for voting no to the landfill use. Requested that the Agenda and Ordinances be posted on the website.

John Goudy, 794 Westminster Drive North – Reminded the Committee, Barry Riggold passed away from a traffic accident in Leisuretowne. Requested more State Police presence, speed bumps, and bike lanes be placed throughout Leisuretowne. Encouraged the Board at Leisuretowne and Committee of Southampton to work together to prevent future traffic accidents and deaths.

Pat Topham, 450 New Road – Requested New Road be paved and speeding be strictly enforced. Remarked that she is glad to live in a small community and hopes it stays that way.

No one else from the public wishing to be heard. The public portion was closed.

Committeewoman Rossell – Shade Tree Advisory Board had a meeting this month. They will plant four trees in town and planning upcoming events for the community. The next meeting will be September 21st at 10:00am.

Committeeman Heston –Tomorrow night's summer concert maybe canceled due to inclement weather. Suggested to the Committee, ask George Morris, Esq. and Kathy Hoffman to revise the ordinance regarding fast food restaurants on highways. Remarked that the Committee should consider the purchase of a Claw Truck for Public Works to accelerate brush collection through town.

Deputy Mayor Raftery – Agreed with Committeeman Heston's remarks to purchase a claw truck to assist Public Works in brush and debris collection.

Mayor Mikulski – Thanked the Committee for not canceling fireworks on July 11th at the Red Lion Recreation Park. The park was the perfect location to host the fireworks.

CLERK/ADMINISTRATORS REPORT:

Kathy Hoffman remarked only one (1) bid was received for the Red Lion Recreation Park and substantially exceeds the Engineer's assessment. Recommended the Committee reject the bid and authorize rebidding.
