**AN ORDINANCE OF THE TOWNSHIP OF SOUTHAMPTON
TO AMEND FEES FOR SEWER SERVICE**

WHEREAS, Section 9-6 Sewer Fees were established with Ordinance 1996-2A in Section 1;

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Southampton, County of Burlington, State of New Jersey, as follows:

SECTION 1.

WHEREAS, Section 9-6.1 fees shall be amended as follows;

A. Base Rate. The basic quarterly service charge for sewer service shall be One Hundred Seventy Five Dollars (\$ 175.00).

SECTION 2.

Severability. It is the intention of the Township Committee that a separate provision of this Ordinance shall be deemed independent of all the provisions herein, and it is the further intention of the Township Committee that if any provision of this Ordinance shall be declared invalid, all other provisions shall remain valid and enforceable.

SECTION 3.

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Southampton, County of Burlington, State of New Jersey, as follows:

This Ordinance shall take effect retro-active January 1, 2021 upon notice and publication thereof in accordance with the law.


