

**TOWNSHIP OF SOUTHAMPTON, NEW JERSEY
ORDINANCE NO: 2022-11**

AN ORDINANCE OF THE TOWNSHIP OF SOUTHAMPTON, COUNTY OF BURLINGTON, APPROPRIATING \$250,000. FROM THE OPEN SPACE FUND FOR RED LION RECREATION COMPLEX IMPROVEMENTS

WHEREAS, the Open Space Funds purpose is to fund improvements such as the Red Lion Complex; and

WHEREAS, there are sufficient funds available in the Township Open Space for Red Lion Recreation Complex Improvements; and

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Southampton, County of Burlington, State of New Jersey, as follows:

SECTION 1.

There is hereby appropriated the sum of \$250,000. From the Township Open Space Fund in order that the Township may fund improvements to the Red Lion Recreation Complex; and

SECTION 2.

It is hereby determined and stated that the authorized purchases set forth in Section 1 of this Ordinance is an Open Space Expenditure and is not a current expense.

SECTION 3.

This Ordinance shall take effect upon notice and publication thereof in accordance with the law.
