**ORDINANCE 2022-02**

**AN ORDINANCE AMENDING SCHEDULE VIII IN ACCORDANCE WITH  
SUBSECTION 7-6.2 OF THE CODE OF THE TOWNSHIP OF SOUTHAMPTON TO  
INCLUDE NEWLY INSTALLED STOP SIGN INTERSECTIONS**

**WHEREAS**, the Township of Southampton (“Township”) has installed several more stop signs at intersections throughout the Township; and

**WHEREAS**, subsection 7-6.2 of the Code of the Township of Southampton governs the intersections designated as stop intersections requiring STOP signs; and

**WHEREAS**, subsection 7-6.2 of the Code of the Township of Southampton provides that all stop intersections in the Township must be listed in Schedule VIII, entitled “Stop Intersections;” and

**WHEREAS**, the Township has determined Schedule VIII must be amended to include the newly installed STOP signs at intersections throughout the Township.

**NOW, THEREFORE, BE IT ORDAINED AND ENACTED**, by the Township Committee of the Township of Southampton, County of Burlington, State of New Jersey that Schedule VIII of Chapter 7, Section 6.2 of the Code of the Township of Southampton is hereby amended to read as follows:

**Township of Southampton  
Schedule VIII  
Stop Intersections**

In accordance with the provisions of Subsection 7-6.2, the following intersections are hereby designated as stop intersections:

| <b>Intersection</b>                   | <b>Regulation</b>  |

| Huntington Drive and Buckingham Drive | Stop signs shall be installed on the near left side of Buckingham Drive (southwest corner) |
| New Freedom Road and Chairville Road  | Stop signs shall be installed on the near right side of all approaches                     |
| New Road and Ridge Road               | Stop signs shall be installed on the near right side of all                                |

| Retreat Road and Westminster Drive         | Stop sign shall be installed on the right side of Westminster Drive                        |
| Ridge Road and Retreat Road                | Stop signs shall be installed on the near right side of all approaches                     |

| Chelsea Place and Dorchester Drive         | Stop sign shall be installed on the right side of Chelsea Place                            |
| Tifani Lane and Dorchester Drive           | Stop sign shall be installed on the right side of Tifani Lane                              |
| Marlborough Drive and Dorchester Drive     | Stop signs shall be installed on both intersections on the right side of Marlborough Drive |
| Devonshire Way and Dorchester Drive        | Stop sign shall be installed on the right side of Devonshire Way                           |
| Yorkshire Lane and Dorchester Drive        | Stop sign shall be installed on the right side of Yorkshire Lane                           |
| Andover Court and Edinburgh Lane           | Stop sign shall be installed on the right side of Andover Court                            |
| Chesterfield Court and Edinburgh Lane      | Stop sign shall be installed on the right side of Chesterfield Court                       |
| Liverpool Lane and Newbury Drive           | Stop signs shall be installed on both intersections on the right side of Liverpool Lane    |
| Turnbridge Court and Newbury Drive         | Stop sign shall be installed on the right side of Turnbridge Court                         |
| Finchley Court and Westminster Drive South | Stop sign shall be installed on the right side of Finchley Court                           |
| Stratford Road and Newbury Drive           | Stop sign shall be installed on the right side of Stratford Road                           |

**SEVERABILITY AND EFFECTIVE DATE.**

- A. Severability. In the event that any clause, section, paragraph or sentence of this Ordinance is deemed to be invalid or unenforceable for any reason, then the Township Committee hereby declares its intent that the balance of the Ordinance not affected by said invalidity shall remain in full force and effect to the extent that it allows the Township to meet the goals of the Ordinance.
- B. Effective Date. This Ordinance shall take effect upon proper passage in accordance with the law.
