AN ORDINANCE OF THE TOWNSHIP OF SOUTHAMPTON, COUNTY OF BURLINGTON, APPROPRIATING \$168,094.00. FROM THE CAPITAL IMPROVEMENT FUND TO PURCHASE A PUBLIC WORKS BACKHOE LOADER IN THE AMOUNT OF \$168,094.00

WHEREAS, certain monies were set aside by the Township in the Capital Improvement Fund in the budget for 2023:

WHEREAS, there is sufficient cash balance in the Capital Improvement Fund to Purchase Public Works Backhoe Loader; and

NOW, THEREFORE, BE IT ORDAINED by the Township Committee of the Township of Southampton, County of Burlington, State of New Jersey, as follows:

**SECTION 1.**

There is hereby appropriated the sum of \$168,094.00, from the Capital Improvement Fund in order that the Township may fund purchase of a public works Backhoe Loader; and

**SECTION 2.**

It is hereby determined and stated that the authorized purchases set forth in Section 1 of this Ordinance is a General Capital Expenditure and is not a current expense.

**SECTION 3.**

This Ordinance shall take effect upon notice and publication thereof in accordance with the law.
