**ORDINANCE NO 2024-9**

---

**AN ORDINANCE AMENDING  
SEWER SERVICE AND CONNECTION FEES**

---

**WHEREAS**, the Township of Southampton has entered into agreements with the Pinelands Wastewater Company (Pinelands) to provide sewer service to certain portions of the Township; and

**WHEREAS**, it is necessary that the Township periodically adjust the connection fees charged for the connection to the system and the transportation and treatment of wastewater to reflect the costs paid to Pinelands and invested in the wastewater treatment system; and

**WHEREAS**, the Authority has received the recommendations of its Auditor with respect to the requirements of N.J.S.A:26A-10 and 11; and

**WHEREAS**, the Authority has determined that its sewer connection fees should be revised and updated to reflect the economic needs of the Township and comply with statutory and bond requirements;

**NOW, THEREFORE, BE IT ORDAINED**, by the Township Committee of the Township of Southampton, County of Burlington, and State of New Jersey that:

1. The sewer metered service charge is hereby amended to reflect a Sewer Metered Service fee of \$18.00 per thousand gallons of water used per user;
2. These rates shall be charged effective upon passage and publication according to law; and these rates shall be charged effective the 1<sup>st</sup> day of January, 2024; and
3. The sewer connection fee is amended to reflect a Sewer Connection Fee of \$8,296.97 per Equivalent Dwelling Unit (EDU);
4. These rates shall be charged effective retro-active January 1, 2024 and immediately upon passage and publication according to law; and
3. True copies of the Sewer Connection Fees shall be placed on file for public inspection or copying at the municipal offices.
