PERMIT DESCRIPTION:

Furnish and install approximately <LENGTH> feet of <DIA>" <MATERIAL> water main to provide water service to <ADDRESS/LOCATION>, connecting to the District's existing <DIA>" water main on <ROADNAME> at the <N/S/E/W> boundary of <ADDRESS>. All work shall be in accordance with the plans and specifications provided by the District <AND DESIGNER IF SEPARATE>. The extension shall be installed complete and ready for service and shall meet all of the conditions of this Permit, prior to final acceptance by the District.

GENERAL CONDITIONS:

1. Shop drawings must be submitted to and approved by the District, for all materials to be installed, prior to the start of construction.
2. A representative of the District must inspect all construction work on a continuous basis. Although the District's inspector may be present at the worksite, the inspector's responsibility is merely to determine whether Developer has completed the work to the District's satisfaction, and the inspector shall have no authority or responsibility to direct the procedures or methods used by the Developer, or its contractor, to perform the work except where specific procedures or methods are either expressly required by the District's specifications, or are a necessary component of performing the work in a workmanlike manner. Notwithstanding the foregoing, if the District determines that the Developer, or its contractor is failing to perform the work in accordance with Developer's obligations under this Permit, the District may refuse to accept, or approve, the work, or any portion thereof, and may direct its inspector to leave the worksite until the Developer, or its contractor, provides adequate assurances that the work will be performed in accordance with this Permit. District reserves the right to reject any work which was performed outside of the presence of the District's inspector, and which is not capable of being inspected upon the inspector's return to the worksite. In the event that District observes Developer, or its contractor, performing the work in an unsafe manner, District may report such condition to appropriate governmental agencies who have authority to enforce applicable laws regulations and rules. The Developer shall be responsible to reimburse the District for the cost of inspection at the rate of \$45 per hour (regular time). Two (2) working days advance notice shall be given to the District prior to the start of construction. It shall be the installing contractor's responsibility to call the Ohio Utility Protection Service to have all area utilities marked along the construction route.

3. No changes shall be made without the prior written approval of the District. All changes must be approved, in writing, by the Engineer prior to submission to the District for approval.
4. All necessary county or state highway permits and private property easements shall be the responsibility of the Developer and copies of same must be provided to the District prior to the start of construction (Agencies **may** require that District obtain highway permits in District's name).
5. Prior to the start of construction, the installing contractor shall submit to the District, proof of insurance coverage for liability & property damage in the amounts required by the specifications, and as approved by the District. The contractor shall also submit a valid State of Ohio Bureau of Workers' Compensation Certificate to the District, or an appropriate certification for a sole proprietor. If the extension involves providing water service to a planned Development, then a copy of the approved plat (approved by the county and / or agency having jurisdiction) shall be provided to the District prior to the start of construction.
6. Developer, and its contractor(s), shall comply with all applicable local, state and federal laws, regulations and rules, including but not limited to laws relating to employment discrimination, equal employment opportunity, worker and workplace safety, and handling, storage, use and disposal of hazardous substances or materials.
7. This Permit to Install will expire one (1) year from the Effective Date. If construction of the project has not begun before the Expiration Date, the Developer shall apply for a new Permit to Install before beginning construction.

CONDITIONS FOR FINAL ACCEPTANCE & PLACING IN SERVICE:

1. The new water main installation shall be certified by the District to be complete, and ready for service, in accordance with the plans and specifications approved by the District.
2. The Developer shall provide the District with an affidavit that all materials and labor for the project have been paid in full.
3. The Developer shall provide the District with a written warranty covering all materials and workmanship for a period of one year from the date of acceptance of the improvements by the District. The Developer and the District shall mutually agree on the procedures for making any necessary repairs during the warranty period.
4. Upon acceptance of the extension by the District, all lines, equipment, etc. (including income to be generated therefrom) shall become the property of the District; the District's reimbursement policy relative to future connections by adjoining property owners may apply for this extension. No connection to the District's system will be allowed, and no extensions will be accepted by the District, without advance approval.
