**SUBJECT: Notice Inviting Interested Contractors for the City's 2024 Informal Bid List**

The Public Works Department of the City of Stanton invites interested contractors to complete a Contractor's Qualification Application to be placed on the City of Stanton's qualified contractor's list for calendar year 2024 in accordance with the State of California Uniform Public Construction Cost Accounting Commission. This list is designed so contractors can receive "Notice Inviting Bids" for informal projects under \$200,000 in their work category per California Public Contract Code 22032. Only qualified contractors will be notified and eligible to bid on these Informal Bid Projects per Public Contract Code Section 22034.

All trade categories are subject to Informal Bidding Procedures and the Qualified Contractor List requirement. Contractors that are interested in being on the 2024 Qualified List are required to have a current license and subject to verification through the Contractor's State License Board.

**Contractors must be currently registered with the Department of Industrial Relations (DIR) and meet the requirements of Labor Code section 1725.5 to qualify for any City project.** Therefore, all contractors must provide a current and valid DIR registration number on their applications. Even if a contractor is placed on the Qualified Contractor List, the contractor cannot perform any work on any City project without a current and valid DIR registration. Contractor shall also furnish certified payroll records as required pursuant Labor Code section 1776 directly to the Labor Commissioner in accordance with Labor Code section 1771.4 and in a format prescribed by the Labor Commissioner throughout any City project.



By submitting an application to be included on the City's Qualified Contractor List, the contractor confirms it is in compliance with all applicable DIR regulations, Labor Codes, and has the capacity to maintain compliance through the calendar year and during any City project.
