#### Recruitment Update

The recruitment process for the City Manager position has been completed and a start date has been confirmed for Monday, July 18 pending final approval of the employment agreement by the City Council.

The second and final round of interviews for the part-time Administrative Clerk for the Finance Department was held on Wednesday, June 15. A candidate has been selected and is in the process of completing pre-employment requirements.

Recruitment for both a full-time Assistant Planner and Associate Planner opened on Thursday, April 14. Both positions will remain open until filled. The first round of interviews for the Assistant Planner position was held on Thursday, June 16.

The second round of interviews for the part-time Public Works/Engineering Intern position for the Public Works Department was held on Wednesday, June 15. A candidate has been selected and is in the process of completing pre-employment requirements.

# **ADOPTED BUDGET**

#### Fiscal Year 2022/23

The City Council adopted the Fiscal Year 2022/23 Operating and Capital Budget on June 14, 2022. Total revenues City-wide are estimated at \$49.1 million to provide funding for total City-wide operating and capital expenditures of \$46.7 million. The General Fund's budget is balanced with estimated revenues exceeding estimated expenditures by \$244,895 (after funding \$442,340 in one-time expenditures). The Finance Department is working with all City Departments to compile the budget document, which will be posted on the City's website in July. In addition, the Finance Department is working with the Marketing Assistant on a Budget in Brief document that will summarize the adopted budget for the public.

# **SPECIAL TAX ASSESSMENTS**

#### Fiscal Year 2022/23

The City has two voter-approved tax assessments that are collected by the County of Orange on each property owner's property tax bill.

In 1981, the City formed Stanton Lighting and Landscaping District No. 1 to provide funding for maintenance and improvements for the City's street lights, traffic signals and medians. The District's total costs are charged to each property parcel based on an assessment determined by an Engineer's Report prepared by the City's consultant, Harris & Associates. The property tax assessment ranges from \$16.59 to \$252.00 per parcel. These assessments have reached the maximum rate that can be charged per State law (unless a new voter approved action is taken). As a result, these assessments have not increased in several years.

In 1985, a protective services tax for fire protection and prevention services was approved. This flat tax ranges from \$24 to \$75 per parcel and is not adjusted for inflation. (This means that the tax assessed in Fiscal Year 2022/23 is the same as the tax that was approved in 1985.) The City collects approximately \$385,000 of funding from this special tax, which is used to fund a portion of the City's \$5.3 million contract cost with the Orange County Fire Authority.

In addition to the special tax assessments previously mentioned, the City collects the annual sewer service charge on the property tax bill as well for efficiency. For example, in lieu of placing the annual sewer service charge on the property tax bill, the City would need to invest in additional staff to compute, mail, and collect monthly sewer service charges from the City's residents. The sewer service charge funds the operating and capital needs of the City's sewer system. The Fiscal Year 2022/23 annual sewer service charge is the same as the Fiscal Year 2021/22 charge. A new sewer rate study will be completed after the Public Works Department completes the Sewer Master Plan Update project.

# **CAPITAL IMPROVEMENT PROJECTS**

#### **Updates**

- FY 2021-2022 Citywide Street Resurfacing Project Pre-con meeting held with All American Asphalt. Due to the need for Caltrans permits for traffic control, asphalt construction won't start until mid-July. Concrete work on Garden Grove Boulevard and Village Center Drive to start later this month.
- · Sheriff's Substation Flooring Installation Work almost complete. Punch list revealed minor items needing completion.
- · Banquet Hall New Lighting Project Work in progress.
- Orangewood Parkette Design Plans Conceptual layout plans will be brought to the Parks & Recreation Commission on July 18th
- Dog Park Design Plans 1st Community Input Meeting held on April 18th concurrent with the Community Services Commission meeting. Three conceptual drawings provided for input.
- Family Resource Center Renovations Design Plans 60% plans submitted for review by City staff.
- Stanton Park Improvements (Adult Fitness Equipment) Purchase order issued to Tait & Associates for developing a site plan for approval by Southern California Edison, which is a requirement for any "intensification of use" of the property.
- Premier Park Renovation Design Plans Design contract awarded to RJM Design Group, Inc. at the June 14th City Council meeting.
- Central Park & Dotson Park Basketball Court & Tennis Court Resurfacing Project No bids received. Will make a second attempt at bidding out this project in July.
- · Central Park Shade Structure Bid documents ready.
- · Sewer Master Plan Consultant gathering information, including working with the City's sewer cleaning vendor, Empire Pipe Cleaning.
- · Norm Ross Sports Park Design Plans Staff will recommend a consultant to be awarded the design contract at the July 12th City Council meeting. The use agreement with GGUSD is being refined.
- · 8861 Pacific Avenue Demolition (due to fire) Staff will recommend award of a demolition contract at the June 28th City Council meeting.

# ORANGEWOOD & SANTA ROSALIA

#### Safety Improvements

Orangewood/Santa Rosalia Safety Improvements – New project being initiated by the City Traffic Engineer (Joe Ames) to address continuing issues with motorists hitting the barrier at the intersection. Work involves a road diet at the intersection and additional signage on the new barrier scheduled to be installed soon. The installation, striping and signing work would be handled using a combination of City crews and County crews, and the design plans can be prepared by Hartzog & Crabill under their existing purchase order for traffic operations support services. *Conceptual plans for striping and additional signage below.*



# **OUTREACH EFFORTS**

#### Navigation Center Placement for Transition Aged Youth (TAY)

Stanton Outreach Coordinators established and maintained contact with a transition aged youth (18-26 years old). The individual was an Orange County resident who had recently become homeless and was in dire need of housing assistance. The Outreach Coordinators collaborated with the Placentia Navigation Center to place the participant in the shelter and connect the individual with additional resources.

#### Elderly Clients Connected to Supportive Services

While responding to a call for assistance from a concerned resident, the Outreach Coordinators engaged an elderly couple who have been experiencing chronic homelessness. Based on the referral, the Outreach Coordinators began the process of connecting the participants to County housing resources. Once the participants were evaluated, the couple was deemed appropriate for placement at the Buena Park Navigation Center. The Outreach Coordinators also completed a housing assessment and referred the couple into the County community queue for County-funded housing. As a result, the couple could obtain supportive services that include housing, case management and medical care.

#### Beach & Garden Grove Blvd.

Over the past month, the Outreach Coordinators have responded to calls for assistance from concerned residents residing near Garden Grove Blvd. and Beach Blvd. The increase in the calls comes from the encampment clean-ups that have been occurring in Garden Grove, Westminster, and under the 22 Freeway. The Outreach Team has been focusing heavily on this area to ensure individuals do not set up encampments and assist individuals with homeless service navigation and connectivity to shelter in their original place of origin.



## **PUBLIC SAFETY**

#### Beach & Chapman Shopping Center

Public Safety has been focusing enforcement efforts on the shopping center on the southwest corner of Beach Blvd. and Chapman Ave. The number of individuals that frequent the parking lot has increased dramatically as have the complaints from residents and business owners. Staff has partnered with outside agencies as well as conducted multiple daily patrols to address this issue. There is more work to be done, however, numerous business owners have expressed their appreciation of the efforts by staff.



#### Monroe Avenue Enforcement

Public Safety staff has been focusing on parts of the City that are routinely impacted by a number of issues including illegal dumping, illegal parking, homelessness etc. One of the more highly impacted streets is Monroe Avenue between Beach Blvd. and Dale. Seen above is a picture of the status of Monroe as the result of regular enforcement efforts by City staff.
