## Planning & Zoning Reminder

As the new building season begins the Planning and Zoning Board would like to remind our residents and builders of the following changes to the Building Ordinances that were adopted in by the Town in 2019. Please refer to the Town of Star Valley website (<https://www.starvalleyranchwy.org/town-documents/town-code/>) to access the most current Building and Zoning Ordinances – Specifically Title 6 Building and Title 9 Zoning

The Town adopted elements of the 2018 International Building Code (IBC), the 2018 International Residential Code (IRC), the 2018 International Mechanical Code (IMC), the 2018 International Plumbing Code (IPC), the 2018 International Fuel Gas Code (IFGC), the 2018 International Fire Code (IFC) published by the International Code Council (ICC) and the National Electric Code (NEC) as adopted by the Wyoming Department of Fire Prevention and Electrical Safety, Wyoming State Fire Marshall. For the same reason, the Town requires the inspection by the Town’s certified building inspector to assure adherence to the adopted codes.

Anyone building a new home in the Town of Star Valley Ranch is required to include a 576 sq. ft. garage on their building plans. This includes both attached and detached garages. This requirement can be found in Title 9, Chapter 7 of the Town Ordinances. New garages attached or detached to an existing home are not affected by the Ordinance.

The Planning and Zoning Board meetings are held on the 2nd and 4th Wednesday’s of each month. Meetings begin at 5:00 PM. We invite all residents to attend our meetings as the decisions and recommendations made by the Board are for the health and safety of all residents.
