WINTER TRAILHEAD PARKING UPDATE

PLEASE READ AND HEED - THANK YOU!

In our last newsletter (published November/December 2022) information was provided on winter recreational parking options at the three trailheads accessible from our Town (Cedar Creek, Green Canyon, and Prater Canyon). Recent developments now warrant an update to the previously published parking information.

For Cedar Creek Trailhead: Park in the small plowed out area just to the right of the junction of the Trailhead Road and Cedar Creek Drive. Signs will be added to this area defining the approved area for winter recreation parking from 1 November to 1 May. The plowed area will accommodate four vehicles. If the approved area is full, overflow parking for Cedar Creek Trailhead is located at the Cedar Creek Swimming Pool parking lot.

For Green Canyon Trailhead: As you approach the Green Canyon Trailhead on Green Canyon Drive, turn left on Green Canyon Circle and proceed to the plowed cul-de-sac for parking. Please heed the new signage and do not park in front of Green Canyon Trailhead or obstruct access to private property! Winter parking rules apply from 1 November to 1 May.

For Prater Canyon Trailhead: Parallel parking is <u>not allowed</u> on either side of Cedar Drive at the National Forest Boundary; the previously installed parking sign has been removed and will be replaced with "No Parking - Tow Away Zone" signs. Obstruction of access to private property along with Town Road crews' inability to plow the road effectively due to the overabundance of parked vehicles has led to the need for this change. Instead, for snow-machine access, please park at the newly signed parking area located north of the First Response Center across from the SVR Town Hall. Snow machines can then make their way up Vista West Drive to Cedar Drive to access the Prater Canyon Trailhead. Winter parking rules north of the First Response Center apply from 1 November to 1 May. The Town understands this parking change for Prater Canyon may not be ideal, however, a longer-term winter parking solution is currently in the works. Stay tuned!

A FEW WORDS FROM COUNCILMAN TAYLOR ELLIS

Town Master Plan Update

After acceptance of the Vision and Mission statements generated by community focus groups, town survey, and the work group committee, formal Requests for Proposals (RFP) were sent out to 20 master plan consultants on October 10th 2022. All the recipients of the RFP were located in Idaho, Wyoming, Montana, Colorado, and Utah, or had experience doing town master plans in Wyoming.

Five of the RFP recipients requested conferences with Mayor Buyers, Kristin Gray, and Taylor Ellis. Of the 20 firms contacted, only 2 submitted proposals. I will be reviewing the submitted proposals and will forward all proposals, along with my suggestions of the high-quality proposals, to the Town Council on January 6th 2023. The Town Council will then rank the proposals by January 20th 2023 and obtain a signed contract prior to February 6th 2023.

The completion date of the draft Master Plan will be negotiated prior to signing the contract. Once a draft of the Master Plan has been reviewed by the Town Council, a copy will be presented to the Citizens of The Town of Star Valley Ranch.

Additionally, a study is currently being conducted by Forsgren Associates, Inc. and will result in recommendations regarding final road surfaces within the town. This study will be completed in time to be included in the information supplied to the Master Plan consultants. Once the study has been completed it will also be made available to the residents of Star Valley Ranch.

IT'S TIME TO RENEW YOUR CAT OR DOG Valley Ranch".

All dogs or cats over six-months old shall be licensed within thirty (30) days of taking residence in the Town of Star Valley Ranch.

Each dog or cat license expires on December 31st of the calendar year for which it is issued and each dog or cat shall be licensed annually thereafter.

Registration fees are \$10 for an altered dog or cat and \$25 for an unaltered dog or cat.

Registration fees will be waived for Certified Service Dog or Cat with proof of Certification as

prescribed by a Physician or a Certified Trainer.

A photo of Fido or Fifi along with a copy of a current rabies vaccination receipt from a certified veterinarian is required for registration or renewals.

PLEASE KEEP DOGS UNDER CONTROL

DOGS MUST BE LEASHED AND UNDER CONTROL WITHIN TSVR

Per ordinance remember that when not on the owner's property, a dog must be under control by either leash, cord or chain or in an enclosed vehicle (exceptions being the Town's designated off-leash dog park).

Additionally, PLEASE do not let your dog chase or harass wildlife. The latter is also prohibited by Town ordinance.



DO YOU OPERATE A SHORT-TERM RENTAL?

PERMIT RENEWALS FOR 2023 ARE PAST DUE!

If you operated a permitted Short-term Rental (STR) during 2022 and intend to continue operation in 2023, you should have already renewed your permit. (STR operators/owners are responsible for renewing rental permits by the last day of December each year.)

As an STR operator/owner you are also responsible for notifying the Town of any changes in the status of your rental home (e.g., change in property managing agent, no longer operating as a short-term rental, change in ownership, etc.).

The SMO works to provide reasonable accompodation to the latter when residents are working to clear driveways of snow. Thank you for your cooperation!

TOWN'S WINTER ROADS

SAFETY FIRST!

We are into our winter months and would like to remind everyone that road conditions are changing and will become more difficult to maneuver and drive on. Without proper vehicle equipment you will have a difficult time driving on



some of the roads in Town during the winter. At times, you will have a berm in your driveway, you may get stuck, and you may hear a snowplow go by at 2am. All of this is part of living in a mountain Town in winter.

Please do not inhibit snow removal in any way or at any time. Our operators have 31 miles of road to plow, and this takes time. Please give them a break and abide by the following:

- Stay out of the way of the snow removal equipment
- Do not park in the road right-of-way
- Make certain that your garbage containers are on your property
- Do not push, shovel, or blow snow into the road

Snowplowing priorities will be adjusted according to snowfall amounts. The Town will begin plowing in the early morning hours when the snow depth is about 4 inches.
