### WATER RATES UPDATE

TOWN COUNCIL OPTS FOR RATES REVIEW

At last month's Town Council work session (held September 12<sup>th</sup>), a review of water project loans and water rates was conducted. After considerable debate and discussion, the Council decided to align future water rate changes with the Town budget cycle. Each Town budget year begins July 1<sup>st</sup> and runs through June 30<sup>th</sup>. The latter is dictated by Wyoming Statute (see W.S. 16-4-125).

The Town usually begins work on the next year's budget in February in order to have enough time to approve the new budget by July 1<sup>st</sup>. In addition to aligning any future water rate changes with the budget cycle, the Council also voted to convene a citizen group to review rates and make recommendations to the Council for consideration during the 2024-2025 budget development process. *Note that this will be a change from the existing water rate setting process that up to now has implemented increases in January of each year.* See the "Mayor's Memo" article on page 2 for more on this story.

### **MAYOR'S MEMO**

A FEW WORDS FROM KATHY BUYERS

Dear friends and neighbors,

Another beautiful Star Valley Ranch summer has come to an end. Some of our residents will be chasing the sun and heading south for the winter. Most of our residents stay here because we love the beauty, quiet, and recreation the winters provide for us. For everyone, please have a fun and safe winter.

The Council has recommended a group of citizens to work on a water rates study and make recommendations to the Council. The first meeting of the citizen water rate group will be on October 3<sup>rd</sup>. The Council voted to review all rates during the budget cycle beginning in March and make any rate changes based on the fiscal calendar which begins on July 1<sup>st</sup>. We all agreed that it is difficult to have an accurate budget if you are not reviewing rates at the same time.

The Council approved four capital projects for the 2023-2024 fiscal budget. Middle Branch Bridge is currently waiting for permitting from the U.S. Army Corp of Engineers, Water Improvement Project 2023 (Vista) has been awarded to Avail Valley Construction, LLC which will start in the spring, Brambleberry pavement and Alpine Way/Ridgecrest maintenance layer has been awarded to HK Contractors, Inc. and the Green Canyon tank liner will need to be re-bid in 2024.

You may have noticed 30 new package lockers in the hallway at the Mail Center. They were purchased and received by the Town in July at a cost of \$10,000.00 and cannot be installed until the Town receives locks that must be ordered by the Thayne postmaster. I agree that it is frustrating, and we are doing what we can to complete the project. Once we receive the locks our staff will have the boxes installed in a few hours. Thank you for your patience.

A couple of reminders for residents. Please remember that meter pits are to be clear of any structures and debris, i.e., wishing wells or any type of boxes, etc., that will hinder the water crew from accessing the meter pit. If such structures or debris exist, they must be moved off the meter pit. Also, it is the responsibility of property owners to keep meters clear of snow and other obstacles. Please refer to Ordinance §53.12



### ROADS 101

### SAFETY AROUND TOWN EQUIPMENT

KEEPING YOU AND OUR ROAD WORKERS SAFE

Undoubtedly, residents are familiar with the various heavy equipment vehicles operated by the Town's Public Works Department to maintain and repair Town roads as well as to clear snow during the winter.

We all have places to go and be, however, operating your privately owned vehicle safely around Town heavy equipment is a responsibility not to be taken lightly. Your safety as well as the safety of Town employees depends on it!

Here are some tips to help keep you safe when heavy equipment is operating on the roadway:

- Slow Down! Speeding is one of the major causes of roadwork area crashes and injuries.
- Keep a Safe Distance Between Your Vehicle, Public Works Personnel and Their Equipment
- **Don't Be a Gap Shooter**. As mentioned earlier, we all have things to do and places to be, however, *please don't try and "shoot the gap"* in front of, behind, or around heavy equipment with your vehicle. Instead...
- Make Sure the Equipment Operator Can See You. Make eye contact with and alert the
  operator—and ensure the operator sees you—before approaching a heavy equipment vehicle.
  Remember, blind spots can be a significant issue for a heavy equipment operator.
- Pay Attention to Warning Signs that May be Posted. Warning signs are posted to help you and other drivers move safely through a work zone. Please don't ignore them.
- **Be Patient and Stay Calm**. Road work being conducted in Town isn't intended to personally inconvenience you. Rather, the Public Works crews are working to improve the roads and make driving around town a better experience for everyone.



### MUNICIPAL FINANCE

WHERE TOWN GENERAL FUND MONEY COMES FROM (UPDATED)

(This article from last month's newsletter drew a few comments and generated good discussion, so we are updating the numbers with the Town's financial results from the latest fiscal year ended on June 30, 2023, and have provided some enhanced definitions below for some of these revenue sources.)

Understanding municipal finance is complex and oftentimes is unique to the specific community. Wyoming municipalities are statutorily bound to the revenues they receive and may generate. Moreover, municipalities are statutorily required to maintain balanced budgets. This is challenging when revenue streams are unpredictable and expenses everincreasing. This only refers to General Fund revenue streams since Enterprise Funds (self-sustaining userfee-funded programs like our water department) vary dramatically.



The smaller the population and the fewer commercial operations in the Town limits, the fewer locally generated revenue options there are, and thus more dependence on State revenue distributions. In fact, most Wyoming municipalities are heavily dependent on revenues from the State, both shared and appropriated, and Star Valley Ranch is no exception with 46% of our General Fund Revenue coming from State funding sources.

The following is a summary of the sources that made up the General Fund revenues for our Town based on the Town's actual revenue received in the fiscal year that ended on June 30, 2023:

**LOCAL REVENUES** – were 29% of our General Fund revenue, which includes the 5th penny sales tax which is collected by the county and then distributed by population based on the Census, and motor vehicle taxes which are also collected by the county and distributed to the Town.

PROPERTY TAXES – were 17% of the Town's General Fund revenue. The Town collects 8 mils of property tax (out of the total of 67 mils that property owner's pay - the other 59 mils go to the schools, county government, hospital, and other organizations). And, please keep in mind the Town is then contractually obligated to send 3 of its 8 mils (or 37.5%) to the Mid-Valley Fire District for fire protection services.

**LICENSES, PERMITS, AND OTHER FEES** – were 4% of the Town's General Fund revenue and represent locally generated revenue from Town-granted licenses, building permits and franchise fees.

**STATE REVENUES** – were 46% of the Town's General Fund revenue and include state sales and use tax (which is distributed by population based on the Census), direct State Aid payments, mineral extraction royalties and severance taxes, and revenue from taxes on cigarettes and fuel sales.

MISCELLANEOUS REVENUES – were 4% of the General Fund Revenue, and includes interest earned on the Town's cash investments, Lottery taxes, Natural Resources Board (NRB) donations, and other revenues that do not fit into another category.

**FEDERAL REVENUES** – In the fiscal year ended June 30, 2023 the Town did not receive any federal funding through loans and grants to our Town General Fund.

### **NEW TRAIL SIGN INSTALLED**

UPDATES FROM OUR CROP CIRCLES COMMUNITY GARDEN

There has been lots of activity in the garden circles area, within and without. There continued to be reports by gardeners of missing produce. Investigation of the tanks did reveal evidence of possible raccoon visitation (scat and footprints in the tanks) as well as complaints about chiselers inside and in tanks. Live traps were set but no raccoons. The potato harvest will occur soon and be harvested all at once for the Thayne Food Bank. The potato crop had a hard season. Too cold in the beginning, then very hot for a short while, then mildew that required management. A tough growing season - but growing we shall do!

### ASPEN TREE DISEASES ON THE RANCH

WHAT YOU NEED TO KNOW SUBMITTED BY RUSTY ADSHADE OF RUSTY'S TREE SERVICE

After 42 years of performing arborist services from Florida to California, I have come to believe that the Aspen tree is one of the most beautiful and dangerous trees in North America.

For the last 9 years, I have resided in Star Valley Ranch. My company, Rusty's Tree Service, has responded to hundreds of calls concerning Aspen trees that have fallen in yards, across driveways, and on top of homes and structures. I am writing this article as a warning to anyone who has large Aspen trees as part of their landscape. *Aspen Trees Can and Will Fall Down*.

Of the hundreds of fallen Aspen trees that we have removed from Star Valley Ranch homes, approximately 75% had a white mushroom growing out of the base. The roots of these trees were soft and spongy. Some of these trees had large dead branches at the very top. Many of them, however, looked completely healthy. Experts agree that this mushroom infestation, known as *Ganoderma* or

Here are a few stories from my customers who have experienced falling Aspen trees.

All these events occurred on the Ranch.

"Rusty told me that my beautiful threetrunked Aspen was in danger of falling. He showed me a large white half-moon shaped mushroom that was growing out of the tree at the base. He told me that the mushroom was a sign that the root system was rotten and that the tree would probably fall over within 2 or 3 years. I ignored his advice to remove the tree. Two years later I was sitting next to my tree when the wind blew my umbrella away. I got up to retrieve it when suddenly my tree fell right on the spot where I was sitting."

"My daughter had some friends over for the weekend. One of them was lying in our hammock when suddenly a large Aspen tree fell and missed her head by 6 inches."

"I was in my back yard with my wife. I casually leaned against one of the large Aspen trees and it tipped over." butt rot (Ganoderma applanatum), is incurable and that the tree should be removed immediately. The presence of the white butt rot mushroom usually means that the tree is too dangerous to climb and that alternative

methods of tree removal must be used. Therefore, it is extremely important to consult with a professional tree removal expert.

The remaining 25% of fallen Aspen trees in our community had a brown satin textured mushroom known as *Aspen trunk rot* (*Phellinus tremulae*). These mushrooms are usually located on the middle to upper trunk of the trees.

Trees infected with this mushroom are usually hollow or rotten in the center. Just like the butt rot mushroom, there is no cure. Infected trees will eventually fall and must be removed.

We encourage you to go online and read about these two mushrooms. Learn how to identify them. If you discover that your Aspen trees have *butt rot* or *Aspen trunk rot*, call us for a free inspection. We can help you determine which trees need to be removed.

Our landscapes can safely contain Aspen trees as long as we become familiar with the warning signs.
