MAYOR'S MEMO

A FEW WORDS FROM KATHY BUYERS

Hello everyone,

I certainly hope you are enjoying this beautiful early fall weather. There is a lot happening in Star Valley Ranch so let's get started. On October 10th the Town Council will introduce the first reading of changes to the Water Rates Ordinance. Please look for more communication from the Town Council regarding water rates.

The Town Council has begun the process of clarifying the language in the Nuisance Ordinance, Short-Term Rental Ordinance, Land and Buildings Ordinances.

At the Town Council meeting on September 12, 2023, the Council will begin the process of approving a Travel and Tourism Board. This is a unique board that will be set up to receive lodging tax dollars. To date the County has already collected \$36,000 on our behalf. The Wyoming State Statutes have given the municipalities very clear direction as to the board procedures. We will be looking for four volunteers to serve on the board that have in the past or currently worked in the travel or tourism industry. The board may be finalized at the November Town Council meeting.

The Town staff has recently completed training in the field of communication skills and conflict resolution. The Town continues to prioritize training for all staff members and look forward to additional supervisory training, roads, water, project management and government accounting just to name a few continued education classes for our staff.

We will again have a very busy summer with the water project on Vista. Please be courteous to our construction workers and staff. They work hard to make our community a better place to live.

REMINDER!

RECREATIONAL VEHICLES, BOATS & TRAILERS PLACEMENT ON YOUR PROPERTY

Recreational vehicles, boats and trailers placement, and use of recreational vehicles, motor homes, boats and trailers on your Town of Star Valley Ranch property is particularly important. <u>Ordinance</u>



<u>§154.075, Temporary Dwellings</u> explains the Town's requirements:

(A) No person shall use or permit the use of any temporary dwelling, motor home or trailer as defined in this chapter as a principal or seasonal dwelling on any site, lot, field or tract of land.(B) Storage of temporary dwellings, recreational vehicles, motor homes, trailers, boats and the like shall:

(1) Only be on a lot where a principal dwelling currently exists; and be inside a building or stored in the rear or side yard of the owner's dwelling; and

(2) Be set back the required distance for the respective zoning district.

(C) Un-occupied parking or storage of temporary dwellings (including trailers and motor homes) on a street or front yard is prohibited. (Prior Code, § 9.05.150)

COUNCIL CORNER

A FEW WORDS FROM COUNCILMAN DENNEY

This summer, I have attended Town Council joint meetings with each of the TSVR boards, one "Coffee with the Mayor" session, all meetings held by the Water Utility Board (to which I am the assigned as Council liaison), and all Council workshops and monthly meetings. To follow are some observations regarding effective interaction between the Town Council and residents.

The Town Council revised its monthly agenda to include time for residents to voice concerns or raise topics at the beginning of each meeting. A number of residents have taken advantage of this opportunity. The Council established a <u>Citizen Participation Policy</u> for this discussion time and residents should become familiar with it to manage expectations for all.

The best way for issues to be brought to the Town Council is either through the informal "Coffee with the Mayor" sessions or by asking the Mayor to place the topic on an upcoming Town Council workshop agenda. In addition, the topic may be more appropriately brought to one of the TSVR boards by contacting the respective board chairman and requesting the topic be added to the next board meeting agenda. Wyoming State Law requires agendas for Council and board workshops be developed and published *before* each meeting.

I have also observed that regulatory ordinances passed by the Town are usually reactive to actions being taken, (or not taken) by residents. Of major significance to the Town is the large number of short-term rental (STR) properties being offered by TSVR homeowners. The Town first enacted an ordinance in March 2022 requiring STR owners obtain an annual permit along with requirements to notify neighbors of their intent and to provide a local contact who could take action if the renters are being unduly obnoxious or violating other Town ordinances. [This ordinance *did not* authorize the presence of the STR properties as the latter is considered the right of the property owner.]

Unfortunately, the Town has continued to receive complaints about the actions of some STR patrons, some of which the Town has no ability to regulate (i.e., flying drones). The impact of STR properties continues to be a topic in nearly all workshops wherein the Council tries to identify further actions that can be taken.

WHERE DOES THE REVENUE COME FROM?


MUNICIPAL FINANCE

WHERE TOWN GENERAL FUND MONEY COMES FROM

Understanding municipal finance is complex and oftentimes unique to the community. Wyoming municipalities are statutorily bound to the revenues they receive and may generate. Moreover, municipalities are statutorily required to maintain balanced budgets. This is challenging when

revenue streams are unpredictable and expenses ever-increasing. This only refers to General Fund revenue streams since Enterprise Funds (self-sustaining user fee programs like our water department) vary dramatically.

The smaller the population the fewer locally generated revenue options and thus more dependence on State-shared distributions. Wyoming municipalities are heavily dependent on revenues from the State, both shared and appropriated. To follow is a look at the sources that make up the General Fund revenues for our Town.



STATE REVENUES - Approximately 45.3% comes from state revenues which includes state sales and use tax (which is distributed by population based on the Census), State-aid from severance tax, State grants and loans, also included in State revenue is shared tax on cigarettes, gasoline, and diesel fuels. Cigarette tax is distributed by point of sale.

FEDERAL REVENUES - Approximately 4% represents federal funding through loans and grants.

LOCAL REVENUES - Local Government revenues are approximately 28% which includes the 5th penny sales tax which is distributed by population based on the Census.

MISCELLANEOUS REVENUES - This represents approximately 13% of revenues from Lottery, pari-mutuel betting and other revenues that do not fit into another category.

PROPERTY TAXES - At approximately 5%, this represents the revenues from property tax generated from not more than 8 mills.

LICENSES, PERMITS, AND OTHER FEES - this represents locally generated revenue from licenses, permits and franchise fees which is approximately 4.7%.

RULES OF THE ROAD

FOR WALKERS AND BICYCLE RIDERS

The Wyoming Department of Transportation makes these recommendations for pedestrians and bicyclists as part of their "<u>Rules of the Road</u>" Driver License Manual.

<u>Pedestrians</u>

By Statute, drivers in Wyoming are required to give the right of way or yield to a pedestrian. If you must walk where there are no sidewalks, *walk on the left side of the road facing traffic*. At night, wear light-colored clothing to help others see you.

<u>Bicyclists</u>

Bicyclists have the right to use all public roadways, and share rights and duties applicable to all drivers of any vehicle. But, unlike motor vehicles, bicyclists must share their lane of traffic. *Bicyclists must ride as close to the right side of pavement as is practical and safe*. Any bicycle used after dark must have a front light and rear reflectors, to help alert vehicle drivers to their presence.

NOTES FROM JIM ROGERS, SMO

A few items for residents to keep in mind.

- Visibility of address signage continues to be a problem. Remember, if the Sheriff or an EMT can't see it, it may take them longer to get to you if you've called for assistance. [Refer to Ordinance §71.06 OTHER STREET ISSUES.]
- Construction permits must be posted and visible from the roadway. [Refer to Ordinance <u>§150.019(B)</u> ACTION REQUIRING A PERMIT.]
- Dogs and cats must be licensed by the town and dogs must be leashed. [Refer to Ordinance §90.04 DOG OR CAT LICENSING; REGISTRATION & §90.05(E) PROHIBITIED ACTIVITIES.]

This Ordinance is an update to board organization to have consistency of form and language and to dissolve the Economic Development Board and reserve the subsection for future use.

ORDINANCE 2023-08 [SECOND READING]

TITLE III ADMINISTRATION CHAPTER 33 TOWN ORGANIZATIONS

This Ordinance is for the creation of a Roads Advisory Board and outlines the procedures in accordance with existing boards.
